Would this exempt her from needing 2000 more hours of supervision even if she started her Ph.D. program before she actually got the psychology license? The Board responded that she needed to apply for licensure, that an application gives specifics on her background which is needed to respond to her question.
- b. Jesse Metzger, Ph.D. submitted a letter regarding supervised practice. From the description he provided the Board, it does not sound like this is clinical practice. He should review the Board's rules.
- c. Drs. Hebert and Forman of Drexel University sent the Board a letter regarding a resident of Vermont enrolling in a research study. The Board has determined that if the client is in Vermont at the time of participation in the video, the psychologist would be required to hold a Vermont license. The Board refers them to Section 3018 Telepractice of the law.
