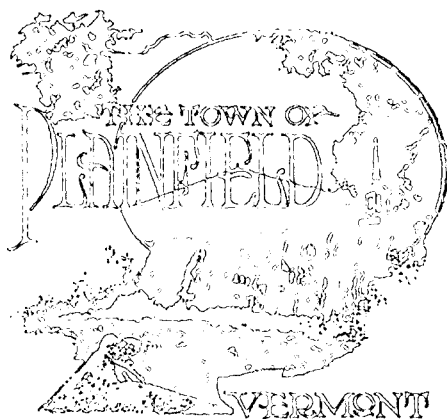

Property Tax Policy                      Taxes are due and payable on the due date on your bill. They must be in the office on the due date or postmarked on the correct date. After this date they become delinquent and will be turned over to the delinquent tax collector. You will be charged an 8% penalty fee and 1% interest per month thereafter. The only exception to the above policy is School Payment #1. This payment will be charged only the interest of 1% per month until the due date of the second School billing. The due dates of taxes are set at each annual Town Meeting.

Town meeting called to order at 10:10 am, March 4, 2003 at the Plainfield Town Hall as warned.

**Article 1** To elect all necessary officers for the ensuing year by Australian ballot. The following officers were elected:

**Article 3** To hear reports of Town Officers and act on same.

**Auditors Certificate** Motion to accept by Janice Walrafen. Seconded by Maggie Sample. Ayes have accepted the certificate.

**Town Clerk's Report** Motion to accept by Allen Clark. Seconded by Janice Walrafen. Ayes have accepted the report.

**Treasurer's Report** Motion to accept by Sue Barasch. Seconded by Allen Clark. Ayes have accepted the report.

**Delinquent Tax Collector's Report** Motion to accept by Sandy Ross. Seconded by Allen Clark. Ayes have accepted the report.

**Lister's Report** Motion to accept by Sandy Ross. Seconded by Mary Trerice. Ayes have accepted the report.

**Planning Commission Report** Motion to accept by Janice Walrafen. Seconded by David Strong. Ayes have accepted the report.

**Town Offices Committee Report** Motion to accept by Sandy Ross. Seconded by Mary Trerice. Ayes have accepted the report.

**Zoning Administrator's Report** Motion to accept by Allen Clark. Seconded by George Springston. Ayes have accepted the report.

**Selectboard Report** Motion to accept by Mary Niebling. Seconded by Allen Clark. Karl Bissex, Chair of the Selectboard, spoke. He thanked people who sit on committees. Karl introduced Liz Perreault and Lori Barg. He thanked Janet and Keith for their services. Janet presented Karl with a picture. Ayes have accepted the report.

**Water System Report** Motion to accept by Allen Clark. Seconded by Peter Youngbaer. Rose Paul presented a plaque to Jay Jewett for his 20 years of service to the Town. Jay was not here to accept his plaque. Ayes have accepted the report.

**Wastewater Report** Motion to accept by Allen Clark. Seconded by Peter Youngbaer. Ayes have accepted the report.

**Cemetery Commission Report** Motion to accept by Allen Clark. Seconded by Peter Youngbaer. Mary Niebling asked how much money did the cemetery commission lose in the stock market? Dale Bartlett answered that they lost about \$80,000.00, but he felt it would be made back in the long run. Ayes have accepted the report.

**E-911 Report** Motion to accept by Allen Clark. Seconded by Peter Youngbaer. Alex Thayer wants her road to be East Hill Road, not E Hill Road. Sandy Ross says she has tried to get 911 to fix this. Pat Martin says that East Hill Road comes up on the 911 computer. Ayes have accepted the report.

**Recreation Committee Report** Motion to accept by Allen Clark. Seconded by Peter Youngbaer. Ayes have accepted the report.

**Fire Department Report** Motion to accept by Allen Clark. Seconded by Peter Youngbaer. Ayes have accepted the report.

Tom Pelham our State representative is here to speak. He passed out flyers. He spoke about what is going on at the State House. Sandy Ross said that any Act 60 reform or Current Use changes should be income based. Tony Spector would like to exempt farm people from school tax.

**Article 4** Shall the Town voters authorize an appropriation of \$2500.00 to the Conservation Fund? Motion to accept by Mary Niebling. Seconded by Dave Spence. George Springston spoke about the fund. Ayes have approved the article.

**Article 5** Shall the Town voters authorize the expenditure of \$6500.00 to help fund the Plainfield First Response for insurance, dispatch, training, and equipment? Motion to accept by G. Cormier. Pat Martin motions to table this question until after Article 6 is decided. Seconded by Jan Waterman. On to Article 6.

**Article 6** Shall the Town voters approve the expansion of the Fire Department to include the First Response rescue unit? Motion to accept by Jim Milne. Seconded by G. Cormier. Pat Martin spoke: The Rescue Squad has been running independently from the town. Benefits of this are that it would reduce volunteer hours needed, and insurance costs would be reduced. We would see a considerable amount of savings over the long run. We see this as a positive change that would benefit the town. Mary Trerice wants to know what our arrangement with Marshfield is. Bill Smith answered that they give Plainfield funding. Pat Martin added that the Fast Squad will be able to get more grants if they become part of the Fire Department. After the merge, they will be known as the Plainfield Fire and Rescue. Ayes have approved the article.

Motion by Pat Martin to go back to vote on Article 5. Seconded by Laura Paris. Back to Article 5. Article 5 continued. Pat Martin motions to amend this to read "Shall the Town voters authorize the expenditure of \$6500.00 to Plainfield First Response and its successors and assigns." Seconded by Gary Graves. Ayes have approved the article.

**Article 7** Shall the Town voters authorize an expenditure of \$525.00 to Battered Women's Services and Shelter? Motion to accept by Allen Clark. Seconded by Peter Youngbaer. Ayes approved the article.

**Article 8** To see if the Town voters will authorize an expenditure of \$400.00 to support programs of the Central Vermont Community Action Council? Motion to accept by Allen Clark. Seconded by Will Roberts. Mary Niebling spoke in favor of this article. Ayes have approved the article.

**Article 9** To see if the Town voters will authorize an expenditure of \$750.00 to Central Vermont Community Land Trust? Motion to accept by Sarah Albert. Seconded by Jodi Vilardi. Ayes have accepted the article.

**Article 10** To see if the Town voters will authorize an expenditure of \$1200.00 to the Central Vermont Council on Aging? Motion to accept by Allen Clark. Seconded by Laura Paris. Sue Barasch told us about the services offered. They provide meals to the elderly at sites, and they deliver meals to peoples homes. Ayes have accepted the article.

**Article 11** To see if the Town voters will authorize an expenditure of \$500.00 to the Central Vermont Crime Stoppers? Motion to Accept by Allen Clark. Seconded by G. Cormier. After discussion, a motion was made by Brenda Lindemann to amend this to \$200.00. Seconded by Heather Milne. More discussion ensued and then a motion by Brian Hurlbert to call the question. Seconded by Jan Waterman. The ayes have voted to call the question. Vote on amending to \$200.00. We need a show of hands. Ayes 52 Nays 16. We will now vote on the amended amount of \$200.00. Ayes 48 Nays 33. The Ayes have approved the article for \$200.00.

**Article 12** To see if the Town voters will authorize an expenditure of \$3000.00 for the Central Vermont Home Health & Hospice. Motion to accept by Janna Osman. Seconded by Jodi Vilardi. G. Cormier wants to amend to \$1000.00. Susan Donnon spoke in favor CVHHH. Sue Barasch spoke of the numerous hours that volunteers put in. Several people spoke in very high support of CVHHH. The ayes have approved the article.

**Article 13** To see if the Town voters will authorize an appropriation of \$18,000.00 to the Cutler Memorial Library to pay for the librarian and the purchase of books and materials? Motion to accept by Laura Paris. Seconded by Wm. Newhall. Joanne Szwed says that she does not want to fund something that would give the federal government access to records. Tony Spector motions to keep the government out of our library. (The Patriot Act) Amend article 13 to add: contingent upon the librarian not divulging patron records to any agency of the federal government. Joanne Szwed seconds. Nays have voted against the amendment. Many spoke in favor of the library. The ayes have approved the article.

**Article 14** To see if the Town voters will authorize an expenditure of \$500.00 to the Family Center of Washington County? Motion to accept by Sandy Ross. Seconded by Linda Workman. Ayes have approved the article.

**Article 15** To see if the Town voters will authorize an expenditure of \$300.00 to the Onion River Arts Council? Motion to accept by Sandy Ross. Seconded by Allen Clark. Ayes have approved the article.

**Article 16** To see if the Town voters will authorize an appropriation of \$350.00 to support the Onion River Food Shelf? Motion to accept by Allen Clark. Seconded by Sandy Ross. The Ayes have approved the article.

**Article 17** To see if the Town voters will authorize an expenditure of \$500.00 to the People's Health and Wellness Clinic? Motion to accept by Sandy Ross. Seconded by Andy Robinson. Sue Barasch spoke about the good that the clinic does and what it does. Plainfield had a lot of people that use the clinic this past year. The ayes have approved the article.

**Article 18** To see if the Town voters will authorize an expenditure of \$400.00 to the Retired and Senior Volunteer Program? Motion to accept by Sandy Ross. Seconded by Allen Clark. The ayes have approved the article.

**Article 19** To see if the Town voters will authorize an expenditure of \$200.00 for Sexual Assault Crisis Team of Washington County? Motion to accept by Cecile Sherburn. Seconded by Sandy Ross.

**Article 20** To see if the Town voters will authorize an expenditure of \$400.00 to the Twin Valley Senior Center? Motion to accept by Sandy Ross. Seconded by Sarah Albert. Alex Thayer wants to know how people travel to Marshfield to the center. Sarah answered that transportation is available. The ayes have approved the article.

**Article 21** To see if the Town voters will authorize an expenditure of \$150.00 to Washington County Diversion Program? Motion to accept by Sandy Ross. Seconded by Janna Osman. Paul Angel spoke in favor of this article. Ayes have approved the article.

**Article 22** To see if the Town voters will authorize an expenditure of \$500.00 to the Washington County Youth Service Bureau/Boys and Girls Club? Motion to accept by Sandy Ross. Seconded by Cecile Sherburn. Mary Lane spoke in favor of this article. The ayes have approved the article.

**Article 23** To see if the Town voters will authorize an expenditure of \$350.00 to Wheels Transportation Services? Motion to accept by Sandy Ross. Seconded by Allen Clark. Sue Barasch spoke about how many Plainfield people use this service. The ayes have approved the article.

**Article 24** To see if the Town voters will authorize an expenditure of \$400.00 to Woman Centered? Motion to accept by Sandy Ross. Seconded by Cecile Sherburn. Ayes have approved the article.

**Article 25** To see what amount of money the Town will vote to pay for highways, bridges, fire department and administrative operations of the Town of Plainfield for the period of July 1, 2003 to June 30, 2004. Motion by Karl Bissex to spend \$556,859.00 which includes an amendment of \$300.00. Seconded by Bob Barasch. Karl went on to comment on several budget items. Pat Martin offers that perhaps more people could volunteer to the town to show appreciation. Motion to call the question by Steve Farnham. Seconded by Jan Waterman. The ayes have called the question. Ayes have approved the amendment to change the line item (Selectboard Salaries) from \$2300.00 to \$3200.00. Steve Farnham motions to call the question. Seconded by David Strong. All in favor of changing the budget to \$557,759.00? The ayes have accepted the budget of \$557,759.00.

**Article 26** To see if the Town voters will authorize the Selectboard to borrow an amount not to exceed \$200,000.00, for a term of five years, to purchase and renovate an existing building or build a new facility to accommodate the town municipal offices. Motion by Karl Bissex to pass over this article until we have more information for a vote. Seconded by Lori Barg. Ayes have voted to pass over.

**Article 27** Shall the Town vote to accept the provisions of public statutes relating to the collection of taxes by the Town Treasurer, (VSA 32 Section 4791)? Motion to accept by Ethel Bower. Seconded by Sandy Ross. The ayes have approved the article.

**Article 28** Will the town vote to collect property taxes on August 13, 2003 and collect school taxes on November 19, 2003 and February 11, 2004, collecting half of the total school taxes on each of those dates? Motion to accept by Bob Barasch. Seconded by Sue Barasch. The ayes have approved the article.

**Article 29** Shall the Town authorize the Selectboard to borrow money, as may be needed, to pay town expenses for the town budget period of July 1, 2003 to June 30, 2004? Motion to accept by Sue Barasch. Seconded by Sandy Ross. Karl Bissex says that we would not borrow more than was intended in the budget. If we vote no on this we would have to have a special meeting if we needed to borrow money. The ayes have approved the article.



**Article 30** The Town discussed various issues; putting all Social Concerns in one article, the issue of the US Patriot Act and Homeland Security. The final motion passed as follows: The Plainfield Vermont voters express to the Vermont legislators and US congress their concern for potential loss of civil liberties from Patriot Act I and II and the Homeland Security Act. Charles Cogbill spoke about the Plainfield Fuel Assistance program. Susan Donnon motions that all organizations who request money submit a financial statement and budget with their request. Nays have defeated this 12 to 7. Discussed exploring alternatives to the current electoral process that take into account of third parties. He amends to put instant run-off voting to a referendum of Vermont voters. Opposed by Nays. Amend to: Plainfield voters express to legislators to adopt instant run-off voting. Ayes have approved. Sue Barasch mentions that last year she spoke about how she would like all of Plainfield to become handicapped accessible. She would like to reaffirm this again at this time. Brenda Lindemann motions to ask that organizations who ask for money from Plainfield submit information about programs and data of how they served Plainfield residents. Ayes have approved this motion.

Motion to adjourn by Steve Farnham. Seconded by Bob Barasch. Meeting adjourned at 2:10 P.M.

## TOWN CLERK'S REPORT

The town clerk's office continues to be a busy place as always. We are still receiving many recordings and have filled 2 1/2 land record books this year. We have begun a preservation plan. This year we had preservation work completed on Volume One of the land records that dates back from 1798-1813, our oldest general index, and vital record books from 1884-1896 preserved. This process is critical to the history of our town. In the restoration process the books are dismantled, then the records are mended with Japanese tissue paper or Crompton heat set tissue where necessary, and then the paper is deacidified. The books are then re sewn and bound in acid-free materials. The vital records were encapsulated in archival envelopes to protect them. We also had ten years of town annual reports bound. We will continue with our preservation plan to ensure the historical records are here for many years to come.

I am pleased to say that we will be moving from this office in the near future. Thanks to all of you for supporting the new municipal building project. We look forward to a much healthier environment for the records and those of us that serve the town.

We processed 12 birth records, 19 marriages, 1 civil union, and 7 death records last year.

This will be a busy election year as we have the primary and general elections this year. It is a privilege to vote, so don't forget to register. Just stop by the town clerks office, DMV, or any voter registration agency for a voter application form. If you are planning to be out of town during the election time, you can still vote by absentee ballot.

We still process DMV motor vehicle renewals for your convenience. The renewal fee has increased to \$3.00. This year we processed 157 renewals. Registration renewals can now be done 24 hours a day. You can go online to <http://www.vermont.gov/expressrenewal> or by phone at 866-259-5368. Your renewal stickers will be mailed to you in less than a week's time. DMV also has a second Mobile Van unit that travels around the state for your convenience. The schedule can be checked online at <http://www.aot.state.vt.us/dmv>. We have a schedule of when the mobile DMV van is in different areas of the state. They will be available at town meeting.

There were 241 dogs registered in 2003. Registering your dog is a VERMONT STATE LAW. To register your dog, your dog must be six months old and have proof of a current rabies vaccination. If your dog is spayed or neutered, you must bring proof of that also. For everyone's protection, including your dog, stop in and register your dog before APRIL 1, 2004. If you forget, you can still register your dog after this date for an additional 50% fee. Bring your dog, we have biscuits!!

Would you like to pay your taxes electronically?? Let us know! We

are considering this service; surveys will be available at town meeting.

We all need to thank the many people that volunteer their time to the town. Thanks for contributing your time to our town! ## LISTERS REPORT 2004

Last year saw substantial legislative changes relating to Act 60, now called Act 68. The State portion of school property taxes will be lower for homesteads than for all other property. This is for state residents only. This is to give a break to homeowners on the school taxes that are paid on the part of their property that is actually their year-round home. This will be accomplished by lowering the rate towns pay for the statewide portion of school taxes.

In order for this to happen, each resident homeowner must fill out and return the "Declaration of Homestead" form that was mailed to you. This must be done before April 15, but the sooner you send it back in, the better. The form is very simple to fill out-it does not require any financial information. All you need to do is verify your identification, address, location and amount of acreage and declare whether or not a portion of your residence is used for business purposes. If so, you need to declare what percentage is used for the business. This part will not be included in your homestead. You must include the SPAN number that is found on your tax bill. This is just an identifying number. If you don't have a copy of your last tax bill, please call the town clerk for your SPAN number. You can also file this form on line at: [www.vermont.gov](http://www.vermont.gov).

As anyone knows who has tried to buy or sell a property lately, real estate prices continue to rise dramatically. This is due to a number of factors. One, certainly, is the limited availability of housing in our area. Another is the continued low mortgage interest rates. With record low mortgage interest rates, home buyers are able to borrow considerably more money and still have the same monthly payments. Because of this, buyers have more money available.

Our equalization ratio, which helps determine State Aid to Education, has fallen because of these steep increases in prices. Since we are, by law, required to keep our listed values close to 100% of the equalized values set by the State, we must again make some adjustments to keep up. We are planning on another townwide adjustment for this spring similar to the one we used in 2002. It looks like we will have to continue to make these updates fairly regularly, as long as real estate prices stay high. We have been advised by the Tax Department that this is the best way to keep our ratios where they need to be between complete reappraisals.

Remember that for years many individual taxpayers have received rebates from the State for property taxes. We fill out the claims for these with our Vermont Income Tax Returns, but the rebates are for property taxes. In 2002, 541 Plainfield residents received \$130,926 in property tax rebates under Act 60. There are many more residents who are eligible for this rebate who have not applied. We encourage you to find out if you qualify and then file the rebate forms.

We are continuing to make some of our inspections in the fall. Change of Appraisal notices will still go out the end of May, so if we visited you in the fall, you won't be notified of the change in your valuation until then. We will follow up in the spring with any that we didn't get to.

We have a new Lister this year. Maggie Sample has filled the slot left when Mel McKnight retired. Maggie has had considerable real estate experience and we welcome her! We also thank Mel for his years of service. We will miss him.

If you have any questions or would like to go over your property record, please call the Town Clerk's office to schedule an appointment. **And don't forget to fill out your HOMESTEAD DECLARATION form!!!! It is essential for our town that these are all included.**

## PLANNING COMMISSION

This year the Plainfield Planning Commission spent a good deal of time working on a set of proposed subdivision regulations. The process of drafting started with reviewing what the surrounding towns had in place. Nearly all the neighboring towns have subdivision regulations in place, some for many years. We then looked at different towns in other parts of the state and found the town of Weybridge had a set of regulations that seemed to be a reasonable place to start since there were similarities between Weybridge and Plainfield. Weybridge also had the same advisors for their regulations that Plainfield had when the Town Plan was adopted, Burnt Rock Associates of Waitsfield.

Once we had a basic document to work from we made some changes we thought would be better for Plainfield. The Planning Commission then held public hearings on the draft document. The Planning Commission got useful public input during the hearings and made more changes based on that input.

The goal of the subdivision regulations is to allow future development to take place in ways that take into account the specific conditions of the site rather than just use the zoning guidelines, which do not allow flexibility in design.

The Planning Commission is also working on upgrading the computerized mapping data the town has. In the future we will have the ability to utilize this information with the towns computers. This will be financed through a series of grants as they become available.

The Planning Commission meets on the first and third Mondays of each month. We welcome public participation at all our meetings.

## ZONING ADMINISTRATOR REPORT

In 2003, 41 permits were issued, broken down as follows:

The interim subdivision regulations adopted by the selectboard in January 2003 did not affect any of the subdivision applicants this year because they were all 2-lot subdivisions. However, all subdivisions are now subject to the state's septic regulations and must obtain a permit from the Wastewater Management Division. Information can be obtained from their office in Barre (476-0190) or at their website: <http://www.anr.state.vt.us/dec/ww/wwwmd.cfm>.

Any building to which the public will have access may also need a permit from the VT Department of Labor and Industry. Their number in Montpelier is 828-2288.

Information on other state permitting requirements can be obtained from Susan Haitsma, the Agency of Natural Resources permitting specialist in our area. She can be reached at 476-0185.

Several useful pamphlets covering a variety of building or renovation projects are available at the town office, including:

*Vermont's New On-Site Septic Regulations.* VT Agency of Natural Resources, Wastewater Management Division.

*A Guide to Building, Construction, and Occupancy Permits in Vermont.* VT Dept. of Labor and Industry.

*Do You Need a State Permit?* VT Agency of Natural Resources.

It is important to obtain a zoning permit for any construction that does not take place inside of an existing building. This allows the listers to be up-to-date, and helps to avoid problems during title searches for refinancing or property transfer. ## SELECTBOARD REPORT

The members of the selectboard representing the citizens of the Town of Plainfield are pleased to report that we have been able to accomplish some important goals during this fiscal year. The following outline lists the key issues that have been worked on during the past year.

### Long term improvements:

- 1) Sidewalk in village-The town is slowly working through the planning, design and public input phase on this project. New sidewalks will line both sides of Main Street to the Fire Station, one side of Mill Street, and one side of Route 2 from the hardware to Maple Valley. Construction is expected to start in 2005.
- 2) Town Office-The new town office building has been purchased and the newly formed committee is working on the renovation design and action. Please call the town clerks office to join the committee.
- 3) Great Brook-State and federal money for the Great Brook flood mitigation and fish access projects have been granted with work expected in the summer of 2004. This will reduce potential damage done to property caused by future flood events
- 4) Street Lights-Lori has been working extensively to convert the 50+ street lights in town from rental to owned energy efficient lights. The expected savings once paid for will be about \$3000 annually. Related to this is the effort of our historical society to install lights on our bridge in the village.
- 5) Revolving Loan Fund-This fund has authorized \$55,000 of expenditures so far this year. This money is to be used to assist business and homeowners with improvement of property. Liz is heading up this committee.
- 6) Emergency Preparedness-Grants have been secured by the fire department and the town for equipment and training to better enable us to respond to emergencies. The Fire Department will be distributing 911 number plates in the Village. Please mount these on your homes. A new Emergency Plan will be available soon. The new radio at Town Hall and a generator will help our town in the future. The Town of Plainfield has submitted our Pre-Disaster Mitigation Plan to the Regional Planning Commission. This is required for the Town to receive federal aid in the future in case of disaster.
- 7) Speeding- The selectboard is proposing an increased budget for training and equipment to assist the county sheriff and our constable in slowing traffic in our town. This will allow us to issue speeding tickets with resulting revenues returned to the town. New radar equipment is being researched for this purpose.
- 8) Road Crew-We are glad to report Mike is back after healing his broken leg. Thanks to Brian and Lyndal for stepping in to help keep

things going during that time. The disruption caused the crew to get behind on culvert, ditching and brush clearing work, but plans are under way to get at it this spring. The water truck seems to be working well and allows the crew to wet the chloride as it is applied.

- 9) Town Truck-The road crew currently uses two plow trucks each with over 250,000 miles on them. Mike feels it time to replace one and we intend to purchase one this year using money from our equipment fund. We are grateful for the excellent maintenance performed by the road crew over the years that enabled us to put off this purchase for so long.
- 10) Zoning-The planning commission has been working on refining the zoning regulations to bring them more in line with statutes and the town plan. Public testimony continues to be taken and the process is still under way as of this writing.
- 11) Property Valuation-Due to higher than expected property sales, our current level of appraisal (CLA) has dropped forcing us to adjust valuation again. See Listers report for more detail.
- 12) Town Land Issues-We have had an offer of a land swap, town forest in Calais for the purchase of town forest in Plainfield, this year which is being considered. We have also received as a donation one parcel with another expected to be donated within the year.
- 13) Business Activity-We continue to support and work with our local businesses to help them continue to operate and serve our town. Support through revolving loan funds, tax abatements and high-speed Internet initiatives are a few of the ways we can do this.
- 14) Delinquent Taxes-This board is taking a more active role in collecting taxes owed to the town. As part of this initiative, delinquent taxpayers will be listed in the annual report.
- 15) HOMESTEAD DECLARATION It is very important for you to fill out your Homestead Declaration. Everyone received copies of this in the mail this year. The amount of re-imbursement the Town receives from the State is dependent on this. Please submit this PRIOR TO APRIL 15TH 2004. Failure to do this could increase our property taxes substantially. Additional copies are available at the town clerks office.

We have chosen to do our best to level fund the budget this year in recognition of the tax burden on our citizens. This in spite of increases in salaries, insurance, fuel, and many other items. This is in part due to the possibility that the calculation of school funding share may be changed by the legislature this year with possible higher taxes resulting.

We are reviewing as of this writing the developing of "set aside" funds to be used to fund future expected projects. These include bridge repair, flood damage, future sand shed building, and reappraisal of properties. These "reserve funds" will help to stabilize the municipal budget from year to year.

We would like to thank the many community members who devote many hours by serving our community. These include volunteers as well as paid individuals. These efforts by these individuals allow us to locally control how our community grows and prospers. There continue to be openings on Town Boards. Please submit a letter of interest if you would like to serve the town.

## **CUTLER MEMORIAL LIBRARY ANNUAL REPORT 2003**

Cutler Memorial Library is happy to report on another busy year! Our collection continues to be updated with the latest in board books for babies, picture books for children, fiction and non-fiction for youth and adults, an extensive Vermont collection, large print, audios, videos, magazines, and reference materials. We have added a new DVD collection this year that features new movies as well as educational DVDs and some great classic movies you won't find anywhere else! We also provide Internet access for those in the community who wish to check email or search for information.

The Freeman Foundation Grant of \$11,000 awarded in May helped us improve our Internet connection from a dial-up service to cable. This provides a constant connection to the Internet and makes surfing and searching faster and easier. The grant also allowed us to purchase two new computers. One computer is designated for use by the librarian and will give us the ability to catalog our collection. One computer was added to our present station to allow the public two stations of Internet use.

Local authors Leda Shubert and Laura Williams-McCaffery paid us a visit in the spring to talk about their work. ## **WATER SYSTEM REPORT 2003**

We are all sure to remember January of 2003 when a major leak drained the reservoir and the village was out of water for almost 24 hours. The culprit was an unused 2" hydrant on the ball field. We removed the hydrant during the summer and found that there had been no thrust block installed to keep the hydrant in position. The water pressure pushed the hydrant off the end of the line. There was also a cracked fitting at the pumping station that was replaced. We would again like to thank the system users for their patience and assistance during this trial and also for the recognition given to all involved.

Again this year we had some leaks in the system. Some were on service lines. We had leaks again on deteriorating lines in Lower Martin Meadow. We also had a number of service lines freeze up.

All water quality testing was performed per State and Federal regulations and all passed. Water quality reports will be going out again later in the year. We urge you to read them and if you have questions about any results, please call the plant.

Looking ahead, we have hired an engineering firm to do a study of our water system. Forcier Aldrich will produce a map of our system, analyze the adequacy of the system, and recommend a prioritized list of improvements to keep the system running well. This will help with long range planning and allow the town to manage the costs of future repairs and improvements in a responsible way.

## WASTEWATER REPORT 2003

During the year 2003, the wastewater facility ran very well. An inspection of the facility in November by State personnel gave us a rating of "Excellent". Both the plant and the ultraviolet light disinfection system are performing well.

During the summer, we constructed a storage shed in back of the facility to store the equipment that does not require a heated environment. To say the least, we opened up a lot of space in the plant and eliminated some safety concerns.

The FY 02-03 budget included money to flush the lines in the system. This is done to clean out blockages before they become a serious problem. We did some selected areas last fall and we've selected some more areas to do this spring.

## DOG LICENSE

All dogs six months of age or over shall annually on or before April 1, be licensed. Also any dog acquired after April 1 or becoming six months old during the year shall within 30 days be licensed.

### License Fee:

All Dog License VT State Fee .....	\$1.00
Neutered male or female .....	\$4.00
Unneutered dogs .....	\$8.00

A 50% penalty is charged for dogs owned and not licensed after April 1st.

To be licensed, all dogs must be vaccinated against rabies by six months of age. A dog vaccinated under one year of age must be revaccinated within 12 months and then every 24 months thereafter.

A certificate or certified copy stating the dog has, within twenty-four months, been vaccinated against rabies by a duly licensed veterinarian shall be presented to the clerk.



## PLAINFIELD CONSERVATION COMMISSION

**Conservation Fund:** The purpose of this fund is to help with voluntary land conservation projects in town. For example, it can provide seed money for larger grants from groups such as the Vermont Housing and Conservation Board, the Vermont Land Trust, and other organizations. Voters continued to support conservation in Plainfield at the 2003 Town Meeting, approving \$2,500 for the Conservation Fund, which now contains over \$7,800, including private donations. Project nomination forms and policies are available from the Town Clerk's office. Additional funding is being requested at Town Meeting 2004, and contributions are always welcomed.

**Conservation Goals:** Commissioners reviewed and prioritized the conservation-related goals from the Town Plan to develop a list of items on which we will work. Key projects included control of invasive plants, support for the Cross Vermont Trail, Great Brook improvements, and mapping of wetlands.

**Great Brook:** The Conservation Commission worked with Lori Barg on surveying the proposed stream restoration sites on the brook. Corps of Engineers permits have been applied for and work will take place this coming summer. See the Selectboard report for more information.

**Greenup Day:** Sponsored in Plainfield by the Conservation Commission during the first weekend each May, this year's activities were coordinated by George Springston. Thanks to the 30 volunteers who showed up to help maintain and beautify town property. They cleaned up trash from the Recreation Field and Route 2 Rest Area, and they raked out weeds and planted many trees and shrubs, such as red oaks, willows, highbush cranberry and serviceberry, at the Recreation Field. Many other volunteers walked areas around town collecting trash from the roadsides and streambeds. Altogether, 40 bags of trash, 13 illegally dumped tires, and 50 pounds of metal were collected. Contact George at 454-1220 to take part in this year's activities.

**Invasive Plants:** With the help of Rose Paul of the Nature Conservancy, the Commission undertook the removal of several species of invasive plants on town property at the Route 2 rest area and around the town recreation field, following up on last years' inventory. Some inventory of native plants was also carried out. Further work on town properties is scheduled for the growing season of 2004. Townspeople are invited to contact Allen Clark, 476-5321 to assist or for help with identifying invasive species on their property. Invasives are considered a serious threat to environmental quality and biodiversity.

**Rest Area on Route 2:** In addition to working on removal of invasives, we continue to maintain the rest area on Route 2 in cooperation with the Central Vermont Solid Waste District Adopt-A-Site program. Thanks

again to Larry and Sandra Holt for continuing their excellent job of mowing the rest area.

**Street Trees:** Necessary maintenance of some large street trees was accomplished this year when three red oaks and a sugar maple in the village had pruning and cabling done. A grant from the Urban and Community Forestry Program of the Vermont Department of Forests, Parks and Recreation, matched by the town, paid for the work. Sadly, some of the town's oldest, grandest street trees have been cut down in recent years. Please remember that you must have permission from the town tree warden (Nelson Blackburn) to cut down any tree within the road right-of-way. Utility companies are not exempt from this law. The conservation commission or the town tree warden will be happy to discuss the maintenance options for any street tree a homeowner has concerns about, or can arrange for a tree expert to look at it. Some funds are available for ongoing maintenance.

**Town Park:** Several volunteers joined the Commission for a park spruce-up day in June: six blueberry bushes were planted, young trees were pruned, some erosion problems on the steps leading to the river path were tackled, and flower beds received a thorough weeding. Last summer's heat and rain soon showed us that regular weedings throughout the growing season will be necessary to keep new growth in check. The commission welcomes anyone who would like to help with ongoing care of the park; please call Sarah (476-0526) if you're interested.

**Vermont Land Trust:** After conducting informal research and surveys of the Vermont Land Trust parcels near downtown Plainfield, off Sugar Wood Road and Route 214, we provided VLT with a letter of suggestions and recommendations related to the use of this property.

**Meetings of the Conservation Commission** are held on the third Wednesday of each month at Town Hall, 7 pm. Everyone is invited to attend, and anyone interested in serving on the Commission is encouraged to apply.

And many of the early difficulties at the dispatch end have been worked out. If you have had a problem using the 911 system or have a complaint about response when you had to call 911, please let me know.

## PLAINFIELD FIRE AND RESCUE

2003 has passed at Plainfield Volunteer Fire & Rescue, each year we say it has been a busy and productive one, yet this year we far exceeded our run volume and time spent on calls. The Fire & Rescue squad responded to 210 incidents and directly saved two houses from significant fire and smoke damage, as well as helping 196 people from our community and beyond. The Fire dept. installed another hydrant (fire pond) this summer thanks to the help of the Vermont Rural Fire Task Force and landowner Joe Wheeler. The fire department also received grant money from the Dept. of Justice and Homeland Security totaling \$30,000+. This money allowed for large purchases such as breathing apparatus, automatic defibrillators and another thermal imaging camera as well as helping to upgrade some of our communications. In the coming year the Fire dept. is planning to put together a committee to determine the needs and specifications of a new tanker. The current tanker is a 1977 model with an aging steel tank as well as numerous mechanical issues. The dept. is also planning to try and implement a fund to continue our rural fire protection plan. This plan was put together with the help of the Vermont Rural Fire Task Force. This fund would help to install more dry hydrants which help us maintain better water supply in rural areas. The past years accomplishments as well as the coming years goals would not be possible without the volunteers of the fire and rescue and for this we would like to thank all of the members and also the community for their continued support.

Here are a few friendly reminders from The Plainfield Volunteer Fire & Rescue Dept.

- If you haven't posted your new E-9-1-1 address (a few still have not) please find out what your number is and get it on your mailbox or your house if it can be seen from the road, it will only help you in the end.
- If you don't have smoke detectors please install some, outside bedrooms, top of stairwells and basements are key areas and remember to change those batteries. Families should test their smoke detectors monthly and plan an escape route with the children. It is recommended to replace your smoke detectors if they have been in use for more than 7 years, more often if your home is heated by wood. New construction and renovations requires both single and multi family dwellings to be equipped with line voltage smoke detection with battery back up.
- If your home has gas or oil appliances a carbon monoxide detector is a good idea. Annual Gas/oil appliance cleaning, tune-ups, and installations should be preformed by technicians specializing in these fields.

- Having your chimney cleaned and inspected annually is recommended. Be sure your wood has ample time to dry before burning, this will avoid the build up of creosote, reducing the possibility of chimney fires.
- Dryer vent pipes and hoses should be cleaned annually to prevent the build up of lint, use metal flexible pipe in place of plastic hose and if possible use rigid metal dryer pipe.
- All homes should have an ABC type fire extinguisher and occupants should know how to use it.
- Keeping driveways plowed and sanded not only makes things easier on you, it makes your home accessible for the fire department.
- If there is a car or truck with a red light on in your rear view mirror he or she maybe going to your home, Please pull over as soon as you safely can.
- No one is allowed to have an open-air fire without a permit, which can be obtained by contacting one of the towns fire wardens. One exception with the ground covered with snow one can burn brush, leaves, grass and trees. Special environmental permits are required for the burning of any material classified as building debris from the State of Vermont Air Quality Division. The burning of household rubbish is no longer allowed, put yourself in your neighbor's position would you want to smell your trash burning?
- Anyone wishing to obtain a fire permit should call a day in advance, please keep in mind this is a volunteer service and if none of the four listed below can be reached you should not burn.
- Anyone interested in joining the fire dept. can contact any of the four chiefs listed below.

## PLAINFIELD HISTORICAL SOCIETY YEARLY REPORT

The Plainfield Historical Society held regular monthly meetings throughout 2003, and its members carried out many activities. Community activities included participation in planning Plainfield Old Home Days and staffing a booth at the August 23rd event, offering to work with the Selectboard to replace the lamps on the bridge over the Winooski and on the bridge over the Great Brook, and co-hosting a meeting to discuss the future and preservation of the historic building that currently houses the Blinking Light Gallery.

As a way of improving its ability to receive grants and donations, the Society applied for and received a certificate of incorporation as a Vermont Non-Profit Corporation. To strengthen itself organizationally, it elected the following officers to one-year terms: Jane Hosford, President; Ben Koenig, Vice-President; Karen Vogel, Treasurer; and David Strong, Secretary. A checking account was set up. \$225 was expended in 2003 on fees and supplies, leaving a balance of \$453 at the end of the year.

The Historical Society also accepted donations of several items of historical interest, including two scrapbooks and a 16mm film of "Plainfield and Calais Old Home Day, 1937". Two videotapes of the film were made and one was donated to the Cutler Memorial Library for use by library patrons. Work began on inventorying the contents of several boxes of materials collected by the Historical Society in years past. Gloves to handle documents and acid-free sleeves for photographs were purchased for this purpose.

At our last meeting in 2003, members of the Society agreed on an ambitious plan to increase public awareness of the historic landmarks and buildings in Plainfield. This involves posting roadside signs at the boundaries of the village historic district, installing historic markers at the Mill site and at the former Miles Washburn blacksmith site, and promoting the placement of small brass plaques on the 68 buildings listed on the National Register of Historic Places in the village.

## MARSHFIELD-PLAINFIELD COMMUNITY INTERNET PROJECT

The Marshfield-Plainfield Community Internet Project is pressing ahead with plans to bring fast Internet service to our two communities. As many of you know, the “digital superhighway” doesn’t quite reach many rural areas of Marshfield and Plainfield. Instead, many of us rely on dial-up Internet service, which is exceedingly slow compared to high-speed connections available elsewhere in Vermont.

Our community group, with three members from each town, is working to change that. In November we mailed a survey to residents of both towns, asking about their interest in faster Internet service – widely known as “broadband” service. The response was far better than we had expected. More than 160 households replied (surveys are still trickling in).

Now that we’ve demonstrated the interest, our committee has approached various vendors, most of them Vermont-based companies, about providing the service to our towns. Based on their responses to our “Request for Information,” we will select and work with the best vendor. Our primary criteria are that the service be fast, reliable, and available to as many homes and businesses as possible at an affordable price.

Or visit our web site – [www.MarshfieldPlainfield.org](http://www.MarshfieldPlainfield.org) – to complete the survey on-line. Please talk to your neighbors about this; ask them to complete a survey as well, particularly if you live in a sparsely populated area of Marshfield or Plainfield.

Our committee is hopeful that faster Internet access, perhaps “wireless” service, may be available by this summer. We thank the Vermont Council on Rural Development and its broadband project coordinators, Al and Laura Duey, for their tremendous support on this project. And we thank the selectboards in Marshfield and Plainfield for their endorsements of our effort, which, by the way, did not involve the appropriation of any of your tax dollars. 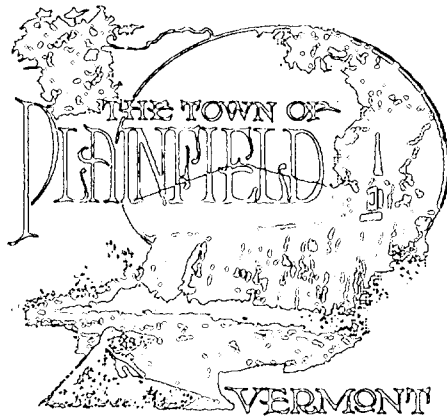

### PLAINFIELD LOGO

The Plainfield Logo is representative of the past, present and future of this active Vermont community.

The Winooski River was a well traveled waterway of the early Indians, traders and trappers, as well as for their raids on more southern towns. Early settlers coming to the town harnessed the water power for use at the "Mill Privilege" where all the early industry was located.

The church spire is indicative of the various religious societies that have been in town. Five churches were located within the village area in the late 1800s.

Spruce Mountain in the background is a reminder of "potash," the cash crop of the early settlers; later the producer of millions of board feet of lumber for the Batchelder Mill and other wood industries; today recreationists enjoy hikes to the top of the mountain.

For the future it is up to us to decide what is essentially good to all in keeping the Pride of Plainfield alive.
