Analysis of Bill

1. **Summary of bill and issue it addresses:** This bill requires mandated reports to contact DCF and the law enforcement agency of jurisdiction within 24 hours of becoming aware of an allegation of sexual abuse of a child. The mandated reporter list is increased as well as the addition of "camp" employees. Due to the requirement to notify both DCF and the local police it will help prevent cases from not being investigated with due diligence.
2. **Is there a need for this bill?** Yes, the addition of the reporters going to both DCF and law enforcement will increase the attention given to each case,
3. **What are likely to be the fiscal and programmatic implications of this bill for this Department?** Law enforcement may find additional cases are created that otherwise would be handled by DCF alone. This will create addition work and recording requirements for the police agencies.
4. **What might be the fiscal and programmatic implications of this bill for other departments in state government, and what is likely to be their perspective on it?** It will not affect DCF as they already receive these complaints. There may be slightly more as the mandated reporter list is expanded.
5. **What might be the fiscal and programmatic implications of this bill for others, and what is likely to be their perspective on it?** Businesses or care agencies for children will need to make sure their employees comply with this law with due diligence.
