



Tabor and attend Long Trail School in Grades 7-8?



SUPERINTENDENT OF SCHOOLS ANNUAL REPORT

This is my fifteenth report to you as your Superintendent of Schools. The Bennington-Rutland Supervisory Union (BRSU) central office continues to offer support and assistance to our nine school districts as each addresses its own concerns, needs and local issues. The average daily membership of students in the BRSU over the past fifteen years (1989 to 2004) has increased by over 200 students (1,627 to 1,835); over the last 5 years, however, we have seen an average decrease of 1% per year.

The Act 60 educational funding law had brought us significant financial concerns. This past year's enactment of Act 68 has changed the rules once again. While budgets are being prepared and tax rates are being projected using the new rules, additional reporting requirements have also been imposed on school districts. This year for the first time we are required to present to voters, on a Commissioner approved form, a more detailed four year budget comparison.

Each school continues to be actively involved in assessing its students' performance and planning strategies for improving instruction. Each school continues to prepare an annual Action Plan to address areas that need attention based on current assessment results. All schools report on their results to their local boards and to the public. In addition, the 2002 federal *No Child Left Behind (NCLB)* law requires other reporting and notification. One important component of this law requires the schools that receive Title I compensatory funding (Currier, Manchester, Mettawee, and Sunderland) to hire both highly qualified teachers and teacher assistants. Teachers must be licensed; and teacher assistants must have either completed at least two (2) years of college or pass an equivalent test to assure competency in reading and math. I have asked Assistant Superintendent John Bacon to present an accompanying report, along with 2003 test scores, for your local school.

For the past four years, Dr. Bacon has served as our Assistant Superintendent. His duties include overseeing the Title I, II, IV, and V federal programs; the Section 504 federal law; and Safe and Drug-Free Schools programs; coordinating professional development activities; and assisting with the overall administration of our nine school districts.

The BRSU Board-approved model for special education administration includes a part-time central office coordinator along with special education directors employed either directly or indirectly by the town school districts. Judith Adams is serving in her fifth year as our Coordinator as well as our Early Education Program Director. Debbie Gould serves as Director for Manchester, Susan Kristoff for Pawlet and Rupert. Debbie Brophy-Antonez for The Dorset School, and Mary K. Murphy for Sunderland, Danby, Mt. Tabor, along with Dorset's secondary students. We continue to operate a highly successful Early Education Program serving approximately seventy

handicapped and at-risk children at centers located at the Mt. Tabor Town Hall, the Manchester Elementary Middle School, the Happy Days Play School in Arlington and the Mettawee Community School in Pawlet.

Dr. Charlene Rapinz continues for the thirteenth year in her role as our full-time school psychologist and is joined for the fourth year by our part-time school psychologist Dr. Mary Hissong. Greg Rosenthal continues as our federally funded School-to-Work facilitator who assists our special needs high school students in transitioning to the work force.

Over the past seven years, our supervisory union has been a strong proponent of Asian studies. When our elementary students enter high school and college, they will be studying side by side with students from many backgrounds and cultures. With the emerging global economy focusing on Asia, it is important that we provide multi-cultural Asian experiences for our students. At least ten BRSU educators have participated and received funding from the Freeman Foundation for study programs in Asia. Our schools have served as hosts for teachers from China, Japan, and Thailand. The BRSU joined with other local supervisory unions to write and implement a Freeman Foundation grant that is allowing our local high school students to participate in Asian exchange programs. Last year, sixteen students from China visited local high schools and even toured *Hildene*; and another group of students will be arriving at the end of January. A group of local high school students, including participants from Burr & Burton Academy, Mill River UHS, and Poultney HS, will be traveling to China in April and another group will follow in June.

Our office continues to provide a multitude of services, including the monitoring of high school tuition payments for over seven hundred students; assisting Boards in determining residency; preparing budgets and most meeting agendas; dealing with truancy and legal issues; arranging for appropriate insurance coverage; preparing and overseeing a multitude of contracts; and providing assistance to our boards, principals, teachers, parents, and to community members in general. We look forward to serving our communities in the coming year.

**BENNINGTON-RUTLAND SUPERVISORY UNION
AUDIT OF SUPERVISORY UNION ACCOUNTS**

The BRSU has engaged Jeffrey R. Bradley, CPA, Mendon, VT, to conduct an audit of its FY'03 accounts. Copies of the audit report are available for inspection at the Office of the Superintendent of Schools (362-2452).

REPORT ON TEACHER QUALITY AND STUDENT PERFORMANCE

The primary focus of our schools is not just teaching but constantly improving our teaching so that eventually all of our students are successful at meeting high standards for learning. Toward this goal, teachers participate in professional development activities continuously and take courses to improve their teaching. We hire the best teachers possible and half of our teachers have masters degrees. In compliance with the federal **No Child Left Behind (NCLB)** law, all of our teachers are highly qualified and either fully licensed in Vermont or licensed in another state and provisionally licensed in Vermont. Parents may contact their school's principal to review the credentials of their child's teachers. We also test students routinely in order to measure student progress and the school's performance as required by **NCLB**.

Each year our students' performance is measured using the Vermont Department of Education's testing program to determine if our schools are making "adequate yearly progress" (AYP) toward the goal of all students mastering the state standards in English Language Arts, Math and Science. Although the percentages of our students meeting or exceeding the standards varies from school to school and test to test, our students' performance is generally comparable to the state averages. We have found over the years that these results fluctuate depending on different versions of the tests and on the strengths and weaknesses of the different groups of students being tested especially in our smaller schools.

Within each school, Action Planning Teams of parents, teachers, administrators and board members review and compare test results annually in order to plan program changes, curriculum revisions and professional development to improve student performance in the areas identified as weak. (Please contact your building principal if you would like to review the test results in more detail or be part of your school's Action Planning Team.) All of our schools continue to improve and make "adequate yearly progress" according to the state's analysis of our test scores. Student performance for all students combined and for those students receiving free and reduced hot lunch met the state's goals in all areas. For the first time, however, students with disabilities did not make adequate yearly progress in English Language Arts under the accountability system for **NCLB**. For more detailed information, please contact your building principal or our office or access the Vermont Department of Education website at [http://www.state.vt.us/educ/new/html/pgm assessment/data.html](http://www.state.vt.us/educ/new/html/pgm%20assessment/data.html).

While the performance of our students may seem low, Vermont's standards are high and the tests are much more difficult than the usual multiple choice tests. Instead of just basic knowledge and skills, the tests also measure higher order thinking skills and require students to write explanations to justify or explain their answers. In fact, when Vermont students are compared nationally on the Scholastic Aptitude Tests and National Assess-

ment of Educational Progress tests, Vermont students' average scores rank among the averages for students from the other top ten states in the country. So while we would like more of our students to do better, our students do as well as the best students in the nation, thanks to Vermont's high standards, our solid educational programs, and the hard work of our talented teachers.

ANNUAL REPORT

In the past year, the Danby-Mt. Tabor Fire Co. responded to 42 calls, consisting of structure fires, chimney fires, motor vehicle accidents and fires, rescue squad assists, brush and grass fires, carbon monoxide detector usage, and alarms.

Danby-Mt. Tabor and East Dorset Fire Departments have combined efforts to create a Rescue Team. This went into service on January 1, 2004. We are now able to do extrication work at motor vehicle accidents and other rescue calls. The equipment was acquired jointly through a grant from Homeland Security. Six months of training have given us good insight on the use of this equipment. The Rescue Team will respond to accidents in both department areas. Mutual Aid efforts have given us a chance to have more people responding to problems we may encounter.

A Truck Replacement Fund has been initiated to help us purchase a truck, since our first-line truck is a 1976 model, and is in need of being replaced. Our goal is to raise approximately \$150,000. At this point, we have \$9,080 in the Fund. Any suggestions to raise money or donations to help us would be very much appreciated!

The Department has received four grants this year:

1. State Grant — One Air Pack	\$ 2,990
2. Homeland Security — Extrication Equipment & Radios	\$ 20,000
3. Homeland Security — Matching Funds for Air Packs	\$ 5,000
4. Homeland Security — Air Packs & Spare Bottles, Communication & Imaging Camera	\$ 30,000

This equipment has to be purchased before we are given the grant money. No grant money can be used for anything but these items, as stipulated.

We do thank you all for your support during the year, and we plan to be able to serve you well in the future.

SOUTHWESTERN VERMONT COUNCIL ON AGING

Report to the Citizens of Mt. Tabor

This report briefly describes the services and support provided to elders in Mt. Tabor by the Southwestern Vermont Council on Aging during the past year; these included:

Senior Meals:

The Council provided funding for meals served to elder residents of Mt. Tabor. This funding helped make available 633 meals that were prepared and delivered to the homes of older persons in your community who were in need of this special meal support. This service, provided through contract, is often referred to as "Meals on Wheels". We also supplied "Blizzard Bags" to Meals on Wheels participants and other isolated elders, containing "shelf-stable" meals for use in a weather related or other emergency situation. In addition, Mt. Tabor elders were able to participate at the luncheon sites available in our region, enjoying warm, nutritious meals and good company.

Case Management Assistance:

Several elder residents of your community were served by SVCOA Case Management staff who provided help with applications and problem solving around programs such as Fuel Assistance, SSI, Medicaid, Food Stamps, etc. Case Managers also helped frail elders who were facing long term care placement, assisting those who wanted to and were able to remain independent connect with available supports including Medicaid Waiver assistance.

Other Services:

The Council on Aging also made available services to help support older persons in your community: 1) Telephone support through our "Senior HelpLine" (786-5119 or 1-800-642-5119). This service provided phone access to elders and others in need of information about available programs and supports for older persons; 2) Health benefit counseling information and form filing assistance through our SHIP Program; 3) Legal service support through a contract with the Vermont Senior Citizens Law Project; 4) Provision of information related to elder issues through the "Elder Connection" column written by Barbara Hanson appearing weekly in the Bennington Banner; 5) Nutrition education and counseling provided by a Registered Dietician to elders who needed to improve their dietary intake; 6) Senior Companion support on a one on one basis for frail, homebound elders; 7) Elder Care Clinician outreach services to elders struggling with mental health issues provided through a contract with United Counseling Services; 8) Community Development assistance and 9) Caregiver information and support for family members and others who are providing help to elders in need of care.

In the face of rising health care costs, nursing shortages, shrinking reimbursement and regulatory changes to the health care system, RAVNAH has continued to identify community needs and provide essential cost-effective health care services to some of Rutland County's most vulnerable individuals. We are proud to report that we continue to be a community leader in guiding and shaping the future of home health care, preventative and long-term care services, including home care, hospice, maternal-child health and community programs. Our services not only promote a healthy community, but also support individual dignity and independence in the home.

We are proud to report on a number of successes we have achieved:

- Provided over 1,200 hours of volunteer service in our Hospice Program.
- Initiated Hospice Palliative Care Program
- Instituted Options Counseling for nursing home admissions
- Collaborated with Wilcox Pharmacy in the Synagis® Program for patients with respiratory syncytial virus
- Provided over 3700 flu vaccinations
- Prepared for compliance with the Health Insurance Portability and accountability act.

We could not have been successful without our dedicated staff. RAVNAH's staff and volunteers made over 84,000 visits to 2,494 different patients. In the town of Mount Tabor we provided 104 visits to 3 individuals.

To the individuals and organizations of the town of Mount Tabor that have supported us during 2003 we are truly thankful. With your support, RAVNAH will continue to meet our mission "to enhance the quality of life of all we serve through comprehensive home and community health services."

Vermont Department of Health

Annual Report - Mount Tabor

The Vermont Department of Health works to protect and improve the health of all citizens. The following are some of the essential services available to residents of Mount Tabor.

Bioterrorism – Emergency Preparedness:

The Vermont Department of Health is actively working with local, state and federal agencies to assure a rapid and effective response to bioterrorism and other public health threats or emergencies. Local health department response may include: finding and identifying disease early; investigating the source of the disease; providing accurate and timely information to the public and health professionals; and collaborating with other agencies during biological, environmental or weather events. The Rutland District Office has become a contributing member of the LEPC (Local Emergency Planning Committee) for the Rutland Region. In the past year we have established ties with many of the emergency response agencies. We have also provided training to town health officers, worked closely with the Rutland Regional Medical Center to increase active surveillance, and participated with local and statewide partners in a table top exercise on October 3, 2003. This exercise tested our ability to interact correctly in the event of a regional emergency incident.

WIC (Special Supplemental Nutrition Program for Women, Infants and Children):

One of the most effective ways to improve the health of the overall population is to improve nutrition and physical activity. WIC improves the health of pregnant and postpartum women, infants and young children by assuring access to health care, teaching families about good nutritional practices, and providing an individually designed package of nutritious food to eligible individuals. During 2002, 3 women, infants and children living in Mount Tabor received foods as well as health screening and individualized nutrition education through this program. The average value of foods provided is \$35.00 per person per month.

West Nile Virus Surveillance:

West Nile Virus first appeared in the U.S. in New York City in 1999 and has become well established in nearly all states. Birds, some mammals and people can get WNV from the bite of an infected mosquito. The Vermont Department of Health and Agriculture conduct surveillance for WNV each year from June until cold weather limits mosquito activity in the fall. As of October 21, 2003: 76 birds and three horses have tested positive for WNV. Three human cases of WNV have been confirmed in the state. In Rutland County from June 12 – October 17, 2003, 88 dead birds were reported, 61 were tested, and 7 birds were found to be infected with WNV. There were no human or equine cases reported during this same time period for Rutland County.

GREEN MOUNTAIN NATIONAL FOREST

The phrase "CARING FOR THE LAND AND SERVING PEOPLE", captures the Forest Service mission. As set forth in law, the mission is to achieve quality public land management under the sustainable multiple-use management concept to meet the diverse needs of people. Some of the highlights of this past year's program include:

We are feverishly trying to finish the Green Mountain National Forest Land and Resource Management Plan (Forest Plan). The Forest Plan is an extremely important document, and directs how we will manage the Green Mountain National Forest (Forest), including what types and amounts of goods and services will be provided. Here is a listing of the meetings we held:

- Public meetings in Arlington and Londonderry on Notice of Intent comments and Desired Future conditions, January and February, 2003;
- Public meetings in Arlington and Londonderry on draft goals, March 2003;
- Public meetings in Arlington and Londonderry on recreation and lands acquisition, April 2003;
- Species Viability Evaluation Panels for plants and animals, April – August 2003;
- Public meetings in Arlington and Londonderry on newly acquired lands (9.2 lands), May 2003;
- Public meetings in Arlington and Londonderry on Class I and II roads, June 2003;
- Public meetings in Arlington and Londonderry on trails, July 2003;
- Public meetings in Arlington and Londonderry on biodiversity and ecosystem management, August 2003;
- Public meetings in Arlington and Londonderry on Wilderness, September 2003;
- Public meetings in Arlington and Londonderry on vegetation and timber management, October 2003; and

We are now holding public planning group meetings on the final details of the plan, (setting up the zoning and management areas, setting goals and objectives, etc.). I cannot encourage you enough to become involved in this effort! Watch the newspaper for upcoming meetings or contact the Forest to get on the mailing list. Your opinion is important, and we want to hear from you!

In the field, our wildlife program continues to focus on federally listed threatened and endangered species. Working with State (Vermont and New York) and Federal agencies, we continue to monitor the Indiana bat populations in Vermont. We also continued Canada lynx surveys using hair snares

for a fourth year. As in the past, no lynx were detected. Surveys for both species are likely to take place in 2004. The Forest continued its apple tree release program on the Manchester District using both Forest staff and volunteers to complete approximately 15 acres of release work.

In fisheries management, we continued to work with the Vermont Fish and Wildlife Department and southern watershed groups on a variety of inventory and habitat surveys of the Batten Kill, as well as riverbank restoration projects.

In vegetation management, we have four timber sale projects on the entire Forest. Timber stand improvement happened on 112 acres and site preparation for natural regeneration of 94 acres. Environmental Analysis continued for the Greendale Project in Weston; and the Nordic Project in Winhall, Peru and Landgrove.

In recreation management, construction was completed on the Hapgood Pond dam. The Vermont Youth Conservation Corps rebuilt trails and bridges in several areas. Numerous volunteer groups, including VAST and the Green Mountain Club, as well as campground hosts and other individuals donated their time and energy to improving recreation opportunities on the Forest.

The Forest grew by 2,844 acres through the acquisition of 4 parcels of land, and is now approximately 387,000 acres. The largest parcel was 2,720 acres in the Town of Wardsboro. Smaller parcels were acquired in Woodford, Warren, and Rochester.

U.S. Forest Service personnel were on site of the Challenger spacecraft disintegration in February. They helped NASA find pieces in a small area of Texas and were instrumental in finding several pieces that become part of the overall puzzle of that incident. We also sent out 15 interagency crews (20 people crews) to help in fighting wildfire in the west.

We wish to thank our many partners and cooperators who have helped us make 2004 a very successful year! We look forward to serving you in the new year, and in working closely with you on the stewardship of YOUR Green Mountain National Forest.
