

1 TO THE HOUSE OF REPRESENTATIVES:

2 The Committee on Natural Resources, Fish, and Wildlife to which was
3 referred House Bill No. 833 entitled “An act relating to the interbasin transfer
4 of surface waters” respectfully reports that it has considered the same and
5 recommends that the bill be amended by striking out all after the enacting
6 clause and inserting in lieu thereof the following:

7 Sec. 1. SURFACE WATER DIVERSIONS AND TRANSFERS STUDY
8 GROUP; REPORT

9 (a) Creation. The Secretary of Natural Resources (Secretary) shall convene
10 a Surface Water Diversions and Transfers Study Group to investigate and
11 make recommendations to the General Assembly regarding the environmental,
12 economic, and recreational impacts of surface water diversions, including the
13 transfer of surface water between watersheds.

14 (b) Membership. The Surface Water Diversions and Transfers Study
15 Group shall be composed of the following members:

16 (1) the Secretary of Natural Resources or designee;

17 (2) the Secretary of Agriculture, Food and Markets or designee;

18 (3) one member of the Senate Committee on Natural Resources and
19 Energy, appointed by the Committee on Committees;

20 (4) one member of the House Committee on Natural Resources, Fish,
21 and Wildlife, appointed by the Speaker of the House;

1 (5) two persons representing businesses or industries reliant on large
2 quantities of surface water, appointed by the Committee on Committees;

3 (6) two persons representing nonprofit environmental advocacy groups,
4 appointed by the Speaker of the House;

5 (7) one hydrologist, appointed by the Secretary; and

6 (8) one person representing an agriculture or forest products business
7 conducted on working lands, appointed by the Secretary of Agriculture, Food
8 and Markets.

9 (c) Duties. The Surface Water Diversions and Transfers Study Group
10 shall:

11 (1) develop a baseline inventory of the current and projected quantity,
12 location, and usage of diversions and transfers of surface water in Vermont;

13 (2) recommend whether or not surface water transfers between
14 watersheds should occur;

15 (3) identify whether the State of Vermont should develop and
16 implement a statewide permitting or other regulatory regime for diversions or
17 other transfers of surface water, including the scale or size of a watershed
18 subject to regulation;

19 (4) analyze potentially viable regimes to address the use of surface water
20 in Vermont;

1 (5) if necessary, propose legislative changes to implement the
2 recommendations of the Study Group; and

3 (6) if necessary, identify any water quality rules, policies, or procedures
4 that may require updating to implement the recommendations of the Study
5 Group.

6 (d) Assistance. The Surface Water Diversions and Transfers Study Group
7 shall have the administrative, technical, and legal assistance of the Agency of
8 Natural Resources and shall have the legal and drafting assistance of the Office
9 of Legislative Council.

10 (e) Report. On or before January 15, 2021, the Surface Water Diversions
11 and Transfers Study Group shall submit a written report to the House
12 Committee on Natural Resources, Fish, and Wildlife and the Senate
13 Committee on Natural Resources and Energy providing its findings and
14 recommendations under subsection (c) of this section.

15 (f) Meetings.

16 (1) The Secretary of Natural Resources shall call the first meeting of the
17 Surface Water Diversions and Transfers Study Group.

18 (2) The Secretary of Natural Resources or designee shall be the chair of
19 the Surface Water Diversions and Transfers Study Group.

20 (3) A majority of the membership of the Surface Water Diversions and
21 Transfers Study Group shall constitute a quorum.

1 (4) The Surface Water Diversions and Transfers Study Group shall
2 cease to exist on February 1, 2021.

3 (g) Compensation and reimbursement.

4 (1) For attendance at meetings during adjournment of the General
5 Assembly, a legislative member of the Surface Water Diversions and Transfers
6 Study Group serving in his or her capacity as a legislator shall be entitled to
7 per diem compensation and reimbursement of expenses pursuant to 2 V.S.A.
8 § 406 for not more than six meetings. These payments shall be made from
9 monies appropriated to the General Assembly.

10 (2) Other members of the Surface Water Diversions and Transfers Study
11 Group shall be entitled to per diem compensation and reimbursement of
12 expenses as permitted under 32 V.S.A. § 1010 for not more than six meetings.
13 These payments shall be made from monies appropriated to the Agency of
14 Natural Resources.

15 Sec. 2. EFFECTIVE DATE

16 This act shall take effect on passage.

17 and that after passage the bill be amended to read: “An act relating to surface
18 water diversions”
