BOARD OF BARBERS AND COSMETOLOGISTS

June 15, 2009**

1. The meeting was called to order at 9:06 a.m.

2. The Chair called for approval of the Minutes of the May 18th meeting. Ms. Commo made a motion, seconded by Ms. Comeau, to approve the Minutes of the May 18, 2009 meeting as presented. Motion passed unanimously.

Mr. Cannistraci will be notified.
