1. The meeting was called to order at 9:31 a.m.
2. Dr. Grimes moved, seconded by Dr. Basiliere, to approve the minutes of the May 13, 2022, as written. Approved.

 - a. Uniform 3-year endorsement discussion- The Board voted unanimously not to seek more restrictive requirements than those established under 3 V.S.A. Section 136a(a) for uniform endorsement licensure in Vermont of qualified psychologists licensed in other states.
 - b. Dr. Basiliere moved, seconded by Dr. Root, to extend the date for the COVID 19 Internship from July 1, 2022 to July 1, 2023 and to extend the other Remote Supervised Practice Policies from July 1, 2022 to December 31, 2024. Approved.
 - c. The Board discussed a policy change which would allow for up to 6 hours of professional ethics continuing education to be accepted for members of the profession and Board members for attending meetings of the Board. Attorney Layman drafted a policy which the Board will review, provide comment on, and discuss at its next meeting.
 - d. Members of the Board inquired about obtaining a report of active disciplinary complaints at each meeting. Attorney Layman advised the Board that the Office has decided not to do this any longer as the Office does not have the resources. The Board has asked that a section be added to the agenda for members of the Board to report the number of complaints that have been assigned to them.
 - e. ASPPB submitted notification of an EPPP Part 2 Skills Town Hall meeting. Dr. Basiliere attended and updated the Board.
 - f. ASPPB requested feedback on ASPPB Guidelines on Practicum Experience for

Licensure. This will be discussed at the Board's July meeting.

- g. The Board held elections.

Dr. Huitt nominated Dr. Root for Vice-Chair, seconded by Dr. Grimes. Approved.
