Thank you for taking the time to share your thoughts on wind energy in Vermont. I believe there is no greater challenge and opportunity to Vermont and our world than the challenge to change the way we use and produce energy.

As you know, any form of power generation will have some environmental impacts. We need to find sources that will mitigate those impacts as much as possible. Vermont must come together to find local, clean, low-emission, renewable energy to reduce our carbon footprint and spur the local economy. Wind power would be one way to accomplish that here in Vermont along with the combined effort solar power, hydropower, and biomass energy. This mixed portfolio allows each form to demonstrate its own unique benefit to the state as an efficient renewable energy resource. Investing in this array of renewable resources is imperative for the sustainability of Vermont's energy production moving forward, and I believe that halting development would be irresponsible. The decisions we make now to fortify a clean energy portfolio, freed from fossil fuel dependence, comprise the foundation of a long-term commitment to Vermonters in the face of a climate change reality.



Thank you for contacting me and sharing your concerns about property taxes and affordability in general. We all know that rising property taxes to fund education have put an unsustainable burden on Vermonters. There are also a number of other issues that have compounded to contribute to the ongoing affordability crisis in our state. The good news is that our economy continues to recover, but many of our middle class families have yet to feel the effects of the recovery in their wallets. I ran my latest campaign on the idea that we must provide all Vermonters with the opportunity for jobs, financial stability and the right to affordable, quality healthcare. My task this legislative session is to work with lawmakers to double down on reforms that will support working Vermonters.

I agree that now is not the right time to implement a publicly-financed health care system, based on the tax burden it would have placed on Vermonters. However addressing healthcare affordability is still be one of my biggest priorities. I believe we have an opportunity to put in place further health care reforms to achieve a better, fairer, and less-costly health care system. In order for us to get there, we must accelerate the hard work we've begun on cost containment and a more rational payment and delivery system. In the coming months, I plan on pursuing initiatives that I believe will help us build upon the progress that we've made so far including enhancing the Green Mountain Care Board's role as a central regulator, pursuing an all-payer waiver with the federal government to move towards quality-based reimbursement, and strengthening our commitment to the Blueprint for Health to support community health teams and medical homes.

Thank you for including me on your letter to House Speaker Smith. I apologize for the delay. I appreciate hearing your thoughts on the very real challenges facing Vermonters.

I believe it is important to look at the issue of rising property taxes as part of the much broader issue of education spending. I have proposed ideas to that effect and I am encouraged the legislature agrees and is considering measures to bring education spending under control. However, we must still focus reform efforts on creating a 21st century school system in Vermont, one that delivers high quality education for our children more efficiently.

In general I agree we should encourage high quality businesses to develop in our state. I also believe Vermont's distinctive sense of place, quality of life and brand is tied to its historic development pattern of compact centers surrounded by working lands. Act 250 in general and Criterion 9(L) in particular encourage sound development that bolsters Vermont's economy because it encourages new development in existing settlement; saves tax payers money by getting more use out of existing infrastructure; and safeguards millions invested in our centers. 9(L) requires a project to make efficient use of land and does not prohibit development. Since July 2014 when the new criteria became law, no development in the state has been denied an Act 250 permit because of this new criteria. Over 190 projects have gone through Act 250 since July.

The particular Rutland case that you refer to has been approved to move forward. As background, Saxon Partners proposes to build a BJ's wholesale club in Rutland on land that is subject to an Act 250 permit for a mini-mall that was never built. Because the design has changed from what was originally permitted, an Act 250 permit amendment is required. This amendment was recently granted.

I also appreciate your comments on solar development. I believe that climate change is the most urgent environmental issue of our time and I am committed to solutions including weatherization, energy efficiency, clean renewable energy, and cooperation with our neighboring states and Canadian provinces. In Vermont, solar power is one tool for achieving our goals, including reaching goals set in law to reduce emissions 75 percent by 2050. Solar has helped us

reduce our peak energy demand, and in combination with energy efficiency saved Vermonters \$16 million by deferring the need for new transmission projects. Solar has also helped create more than 1,500 jobs in Vermont.


