### Analysis of Bill

**1. Summary of bill and issue it addresses.** Describe what the bill is intended to accomplish and why.

This bill would exempt solid waste collected as part of a municipal or non-profit litter collection event from separating mandated recyclables, leaf & yard residuals, and food residuals from the litter. During Green Up Day and other litter collection events, items are collected that may be dirty, contain liquids, or otherwise contaminated which can disqualify such items from being managed with our existing recycling system without exerting considerable effort to clean such items. In order to continue to encourage litter collection events, this exemption is proposed. (Please note: The Solid Waste Program had already informed Green Up Day that their volunteers would not be expected to separate mandated recyclables from the litter, but they need to continue to separate other landfill banned items, such as tires, electronics, car batteries, etc.)

**2. Is there a need for this bill?** Please explain why or why not. This bill would clarify that Universal Recycling does not apply to litter collected during events.

**3. What are likely to be the fiscal and programmatic implications of this bill for this Department?** None. Please note that litter collected during Green Up Day is exempt from the solid waste franchise fee.

**4. What might be the fiscal and programmatic implications of this bill for other departments in state government, and what is likely to be their perspective on it?** None.

**7. Rationale for recommendation:** Justify recommendation stated above. While some of the items collected during litter events may be recyclable, the items are often dirty or contaminated; our recycling system requires clean material in order for the recyclables to be marketable. If volunteers who collected litter were required to clean litter items in order to recycle items, it could discourage volunteers from participating and from picking up such items.


