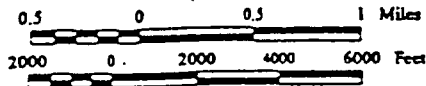
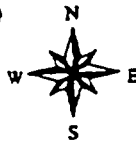

Zoning Districts

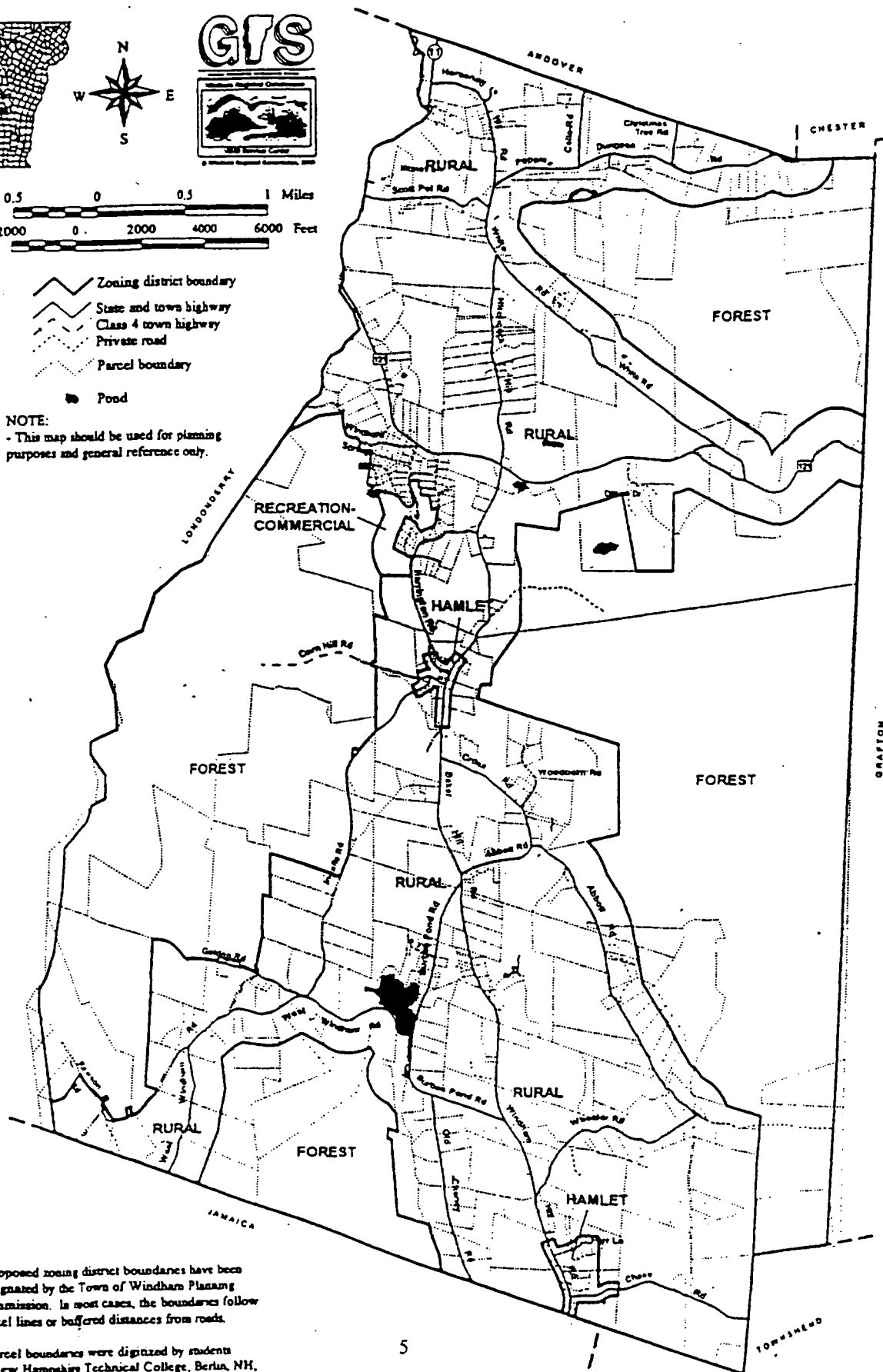
EFFECTIVE: MAY 1, 2001

NOTICE TO VOTERS for Presidential Primary Election

BEFORE ELECTION DAY:

CHECKLIST POSTED at Clerk's Office By February 1, 2004. If your name is not on the checklist, then you must register to vote.

REGISTER TO VOTE no later than 12:00 noon, Monday, February 23 at Town Clerk's Office. All Clerk's offices will be open from 10:00 a.m. until 12:00 noon on Monday, February 23, 2004.

PARTY CHOICE: In the presidential primary, you must declare which major party ballot (Democratic or Republican) you want to vote, and your choice will be recorded on the checklist and be part of a public record. 17 V.S.A. §2704

REQUEST EARLY or ABSENTEE BALLOTS: You or a family member can request early or absentee ballots at any time during the year of the election in person, in writing, by telephone or email. The latest you can request ballots for the Presidential Primary Election is the close of the Town Clerk's office on March 1, 2004. (Any other person authorized by you who is not a family member must apply in writing or in person for a ballot for you.)

WAYS TO VOTE YOUR EARLY BALLOT:

- You may vote in the town clerk's office before the deadline.
- Voter may take his or her ballots out of the clerk's office and return in same manner as if the ballots were received by mail.
- Have ballot mailed to you, and mail or deliver it back to the clerk's office before Election Day or to the polling place before 7:00 p.m. on Election Day.
- If you are sick or disabled before Election Day, ask the town clerk to have two justices of the peace bring a ballot to you at your home. (Ballots can be delivered on any of the eight days preceding the day of the election or on the day of election.)

SAMPLE BALLOTS will be posted by February 11, 2004.

ON ELECTION DAY:

If your name was dropped from the checklist in error, or has not been added even though you submitted a timely application for addition to the checklist, explain the situation to your town clerk and ask that your name be added to the checklist today.

- The town clerk or presiding officer will investigate the situation and then either have you swear to an affidavit that you had submitted a timely application and add your name to the checklist or explain why it cannot be added.
- If the Town Clerk or BCA does not add your name, you may request a Provisional Ballot. In order to vote a provisional ballot you must be able to swear that you properly submitted a timely application for addition to the checklist and that you are qualified to vote at the polling place. A provisional ballot will only be counted after the election if the Town Clerk is able to verify that you had previously submitted a timely application and that you are a resident of the polling place district and otherwise qualified to vote (citizen of the United States, over 18, and a Vermont resident who has taken the voter's oath.) If you vote a Provisional Ballot, you can call (800) 439-8683 after March 9 to find out if your ballot was counted, and if not, why not.
- If the clerk or BCA does not add your name and you want to vote a regular ballot instead of a provisional ballot, you can appeal the decision to a superior court judge, who will settle the matter on Election Day. Call the Secretary of State's Office at 1-800-439-VOTE (439-8683) for more information.

If you are a first time voter who submitted your application to the checklist individually by mail, you must provide a valid Vermont photo identification, or a copy of a government issued document with your current address, before you vote for the first time.

If you, or any voters you know, have physical disabilities, are visually impaired or can't read, let them know they may have assistance from any person of the voter's choice to help them vote.

If you know voters who cannot get from the car into the polling place, let them know that a ballot may be brought to their car by two election officials.

If you have any questions or need assistance while voting, ask your town clerk or any election official for help.

NO PERSON SHALL:

- Vote more than once per election, either in the same town or in different towns.
- Mislead the board of civil authority about your own or another person's true residency or other eligibility to vote.
- Hinder or impede a voter going into or from the polling place.
- Socialize in a manner that could disturb other voters in the polling place.
- Offer bribe, threaten or exercise undue influence to dictate or control the vote of another person.

FOR HELP OR INFORMATION: Call the Secretary of State's Office at 1-800-439-VOTE (439-8683) from 7 a.m. until 9 p.m. on Election Day. (Accessible by TDD)

If you believe that any of your voting rights have been violated, you may file an Administrative Complaint with the Secretary of State's Office, 26 Terrace Street, Montpelier, VT 05609-1101.

If you believe you have witnessed efforts to commit any kind of fraud or corruption in the voting process, you may report this to your local United States Attorney's Office.

If you have witnessed actual or attempted acts of discrimination or intimidation in the voting process, you may report this to the Civil Rights Division of the United States Department of Justice at (800) 253-3931.

INSTRUCTIONS FOR VOTERS using Paper Ballots in the Presidential Primary Election

CHECK-IN AND RECEIVE BALLOTS:

- Go to the entrance checklist table.
- Give name and street address to the election official in a loud voice.
- Wait until your name is repeated and checked off by the official.
- Ask for a Democratic or Republican ballot. (For the Presidential Primary ONLY, the official will record the major party ballot that you request on the entrance checklist.)
- An election official will give you a Democratic or Republican ballot.
- Enter within the guardrail and go to a vacant voting booth.

MARK YOUR BALLOT: In the Presidential Primary Election, you may vote for one candidate of **ONLY ONE PARTY** on only **ONE BALLOT**, or your vote will not count.

- To vote for a candidate, fill in the oval to the right of the name of the candidate you want to vote for.
- **WRITE-IN** candidate(s). To vote for someone whose name is not printed on the ballot, use the blank "write-in" lines on the ballot and either write-in the name or paste on sticker.

CHECK OUT:

- Go to the exit checklist table and state your name in an audible voice.
- Wait until your name is repeated and checked off by the official.

CAST YOUR VOTE by depositing your voted ballot in "Voted Ballots" box. **LEAVE** the voting area immediately by passing outside the guardrail.

ARTICLE 1: To choose a Moderator. DONNA KOUTRAKOS IS ELECTED MODERATOR ONE YEAR TERM.

ARTICLE 4: To see what salaries and/or allowances the School District pay its Officers and Directors as included in the School Budget for 2003-2004 school year. VOTED TO ALLOW \$1,500.00 FOR THE SCHOOL DIRECTORS FOR THE 2003-2004 SCHOOL YEAR AS INCLUDED IN THE SCHOOL BUDGET FOR THE 2003-2004 SCHOOL YEAR.

ARTICLE 5: To see if the voters of the Windham School District will authorize the School Board directors to expend \$402,799.00 to defray the expenses of the Windham School District for FY 2003-2004. VOTED TO AUTHORIZE THE SCHOOL BOARD DIRECTORS TO EXPEND \$402,799.00 TO DEFRAY THE EXPENSES OF THE WINDHAM SCHOOL DISTRICT FOR FY 2003-2004.

ARTICLE 6: To see if the voters of the Windham School District will authorize the transfer of \$28,573.00 from the General Fund balance to the Bus Fund for the purchase of a bus in FY 2003. VOTED TO AUTHORIZE THE TRANSFER OF \$28,573.00 FROM THE GENERAL FUND BALANCE TO THE BUS FUND FOR THE PURCHASE OF A BUS IN FY 2003.

ARTICLE 7: To see what sum the School District will appropriate for school maintenance and Improvements. VOTED TO APPROPRIATE \$1,000.00 FOR SCHOOL MAINTENANCE AND IMPROVEMENTS.

Therefore, be it resolved that the voters request the Legislature of the State of Vermont to take action immediately to bar relicensing of the Vermont Yankee Nuclear Power Station whose current license expires in 2012; to bar the licensing of any other nuclear generating station in the State of Vermont; and to proceed forthwith implementing a state energy plan that relies upon renewable energy sources to supply Vermont's energy needs.

ARTICLE 34: To see if the Voters of the Town of Windham, will adopt the following Resolution: VOTED TO ADOPT (BY VOICE VOTE).

Whereas the environmental, economic, and public health effects of global climate change, caused primarily by the burning of fossil fuels, pose serious threats to Vermont and to all of the earth's natural systems, and whereas nuclear power produces dangerous and long-lasting nuclear waste;

Whereas the efficient use of energy saves money and reduces all types of pollution; and renewable energy sources, including solar, wind, biomass, hydro, and geothermal power, have the potential to provide affordable energy with minimal environmental harm;

Whereas Vermont's economy would be strengthened by the creation of new industry and new jobs in the manufacturing and installation of renewal energy systems; by the creation of a fuel-efficient transportation system; and by energy efficiency improvements in all residential commercial, and governmental buildings;

Whereas Vermont and America would become more secure by becoming more independent in our ownership, production, and management of energy resources, especially by importing less oil from foreign countries;

THEREFORE,

"Be it resolved that the citizens of the Town of Windham urgently call upon our municipal leaders, state legislators, governor, and Congressional delegation to put Vermont in the forefront of a sustainable energy future. Specifically, we request immediate and ongoing action on legislative initiatives designed to promote energy efficiency in Vermont's homes, businesses, public buildings and transportation systems, and to encourage expansion of the renewable energy industry in the State of Vermont."

ARTICLE 35: To see if the Voters of the Town of Windham, will adopt the following Resolution: VOTED TO ADOPT (BY PAPER BALLOT) (TOTAL VOTES – CAST 52 – NEED 27) (VOTES – YES 38 – NO 14).

Whereas, the Bill of Rights of the United States Constitution and the Constitution of Vermont guarantee those living in the United States the following rights:

Freedom of speech, assembly and privacy;

The rights to counsel and due process in judicial proceedings; and

Protection from unreasonable searches and seizures; and

Whereas, we believe these civil liberties are precious and are now threatened by

A. The USA PARTIOT Act, which

**All but eliminates judicial supervision of telephone and Internet surveillance;
Greatly expands the government's ability to conduct secret searches;
Gives the Attorney General and the Secretary of State the power to designate domestic groups as "terrorist organizations"; and
Grants the FBI broad access to sensitive medical, mental health, library, financial, and educational records about individuals without having to show evidence of a crime and without a court order; and**

- B. The HOMELAND SECURITY ACT, which**
Increases the government's ability to secretly collect information without court orders or other checks; and
- C. FEDERAL EXECUTIVE ORDERS, which**
Establish secret military tribunals for terrorism suspects;
Permit wiretapping of conversations between federal prisoners and their lawyers;
Lift Justice Department regulations against illegal COINTELPRO-type operations by the FBI (covert activities that in the past targeted domestic groups and individuals); and
Limit the disclosure of public documents and records under the Freedom of Information Act; and
THEREFORE,
Resolution calling on local government to defend state and federal Constitutions from threats imposed by the USA PATRIOT Act, the Homeland security Act, and orders and rules of the executive branch:
We call on our local government to act in the spirit of our state and federal Constitutions by asking local and state police, the local U.S. Attorney's Office, and the FBI to:
1. Report to citizens regularly and publicly the extent to and manner in which they have acted under the USA Patriot Act, The Homeland security Act, and orders and rules of the executive branch, or COINTELPRO-type regulations including disclosing the names of any detainees;
 2. Not participate, to the extent legally permissible, in law enforcement activities that threaten civil rights and civil liberties such as surveillance, wiretaps, and securing of private information, which the Acts and Orders authorize;
 3. End racial profiling in law enforcement and detentions without charges; and
We call on our local government to:
 4. Openly work for the repeal of the parts of the Acts and Orders that violate civil rights and civil liberties.
 5. Ask the Town Clerk to notify the above authorities of our action in this regard.

ARTICLE 36: To see if the Voters of the Town of Windham, will adopt the following Resolution: **VOTED TO ADOPT (BY VOICE).**
Whereas genetically engineered (GE) foods and crops are likely to cause long-term damage to the environment, threaten the integrity of rural, family farm economics and can have serious impacts on human health; whereas GE crops have been found to contaminate other crops through cross-pollination, and are stringently regulated in more than 30 countries; and whereas citizens throughout the United States are taking steps to address concerns about GE foods at the state and local levels; and whereas Congress and federal regulatory agencies have failed to adequately address this issue, therefore, be it resolved that the residents of Windham:

1. Call upon our elected officials, including Vermont legislators, Congressional Representative and U.S. Senators, to support the mandatory labeling by manufacturers and processors of all genetically engineered food and seeds, as well as a moratorium on the further growing of GE crops until there is credible and independent scientific evidence that these products are not harmful to our health, the environment, and survival of family farms and
2. Declare our support for legislation at the state and federal levels that will shift all liability from farmers to the commercial developers of GE technology for any damages resulting from the growing of GE crops, and
3. Declare a moratorium on the planting of genetically engineered seeds in the Town, as a step toward making Vermont a GE-free planting zone by the 2004 growing season.

ARTICLE 37: To transact any other business which may legally come before this meeting.
VOTED TO ADJOURN THE MEETING AT 4:30 P.M.

2003 Selectman's Report To the Voters and Landowners of the Town of Windham, VT

"It is with despair that we have to report that the Town of Windham was hit with a devastating flood in August. Unfortunately, the cost of these repairs will have to be subsidized by the Town, which has necessitated your selectmen to obtain financial aid from a local bank. Although work will be reimbursed by the Federal Government, they do not reimburse for administration or interest charges." Does this paragraph sound familiar? It should. It was the opening lines of the 1976 Selectmen's Report and could easily be the opening lines for the 2003 Report. On August 3, 2003 a major rainstorm hit the Town of Windham and all but destroyed Route 121. Other roads damaged by flooding streams were Mercy Lane, White Road, Hitchcock Hill, the Cross Road, Popple Dungeon, Scott Pet, Christmas Tree Farm, Old Farm, Corn Hill and Harrington Roads. The damage sustained caused many of these roads to be closed to traffic until the cost of the damage could be assessed and repairs completed. Governor, Jim Douglas paid the Town a visit and spent time viewing the flood-ravaged areas and a video of the actual floodwaters and answering questions from Town officials and homeowners.

The Town meeting held on March 4, 2003 was well attended and Walter Woodruff was elected to another 3-year term as selectman. Though most of the attention during the summer was focused on the flood work, other projects did manage to be completed. A new culvert was installed at Bridge 33 on Town Highway #1. Paving and painting of lines occurred on White Road and Horsenail Hill. The first moose hunt in Windham in many years took place in November without any problems.

WINDHAM ELEMENTARY SCHOOL PRINCIPAL'S REPORT

In keeping with the accepted standards of practice I am pleased to provide this annual report.

WES welcomed thirty-two students, K-6, on opening day 2003. Current enrollment is thirty students. At the time of this writing the 04-05 projected enrollment is twenty-nine students.

Educational needs, student grade numbers and financial sense dictated organizational restructuring. Mrs. Kehoe and Ms. Sally Newton, K and grade one teachers, team-teach four mornings each week. The shared curriculum areas are Language Arts and Mathematics. This has provided for more student interaction and availability of skill levels in learning. Mrs. Jennifer Schreiter joined the WES staff as a Grade 4-6 teacher assistant. This position supports and helps to ensure that all student needs are being met. I am pleased to report that these changes have had a positive impact for both student and staff.

An on going interest and primary concern is to provide quality educational services and learning opportunities for our students. The development of the school budget is an annual challenge. Sensitivity to both of these guided the following 03-04 budget decisions.

Mrs. Kehoe replaced Mrs. McAllister as the pre school teacher two afternoons each week. This serves the three-five year old population. The grade 4-6 instrumental music program was eliminated . Although unfortunate, it was appropriate due to lack of student participation.

The WES staff continues to work to implement research based programs in Language Arts, Mathematics and social curriculum. The WCSU curriculum committees continue to work on developing standard based Science and Social Studies models for instruction. Additional WES recognizes and supports the need of accountability in the area of assessment. Due to low enrollment figures and the need to protect personally identifiable information of students, it is not published annually. The positive fact is ,based on Vt. state "rolling two-year average", WES students show continued achievement, meet the standards, and exceed the standards in the assessments. These assessment results help to refine and improve our program instruction.

The No Child Left Behind Act (NCLB) legislation provides a blueprint for further development and training in curriculum instruction and assessment. We are diligently moving forward to provide the best education for all our students.

The WES continues to implement the goals of the school action plan as

required by Act 60. The action plan drives local decisions in the areas of school reform, school climate, staff development, and budgeting.

The WES teachers serve on multiple curriculum committees, continue their professional development and provide meaningful learning opportunities daily to students. I would like to extend my highest professional appreciation for the remarkable dedication and commitment demonstrated by the teachers.

The parents are to be applauded for their attendance at school activities. WES can proudly boast that it was the only school in the WCSU that had 100% parent attendance at the Annual Open House. Your efforts and support have had a positive impact on the school climate. Parents unselfishly continue to volunteer in many areas. This is greatly appreciated and valued by the school community.

Our school would not be the thriving place that it is without the continued support of the community. We invite you to visit us, to share our day, volunteer, and be part of what is our most important job--helping our children to grow and learn.

This year has been an exciting one for the schools in the Windham Central Supervisory Union.

As a result of the continuing curriculum and professional development work, and the efforts of the teachers and others working in curriculum and instruction, all of the schools in the Windham Central Supervisory Union met their Annual Yearly Progress targets as defined by the Vermont assessment system. There is much more to education than test scores, but these benchmarks indicate that our students are mastering essential skills. We remain committed to the statewide portfolio system in both writing and math and offer practice sessions as well as scorer calibration sessions within our district as part of our professional development work. One of our professional development days in May is dedicated to all teachers coming together to score portfolio pieces done over the year by students and to collaborate about student work.

This year the Windham Central SU professional development committee has chosen to organize the days into topical study strands. Teachers choose their topic and participate in a study group for the year. Nearly all of these groups are led by administrators and teachers within our district and provide another forum for us to collaborate. We also continue our involvement in the Integrated Inquiry Project, which integrates the study areas of science and math, and our commitment to teachers involved in the Vermont Math Initiative and the Vermont Reading Initiative. Other study areas being addressed include: cultural studies, differentiated instruction, reading/writing in the content areas, team teaching, technology integration, and other content based seminars.

Leland & Gray Board and Administration continue to actively search for solutions to space issues. The school has also begun the New England Association of Schools and Colleges (NEASC) accreditation process. This is a comprehensive, multi-year study process involving a self-study, as well as a site visit and evaluation by a visiting team of professionals. For the initial phase, the faculty reviewed and revised the school's "Mission Statement" and "Student Learning Expectations" which were reviewed and approved by the Board. Eight study subcommittees have been formed, one to address each of the eight standards for accreditation. Committee members include staff, Leland & Gray Board members, students, parents and community members.

We continue our major Supervisory Union wide initiative of technology use and integration including revised systems for connectivity to ensure continued access to the Internet from each individual building. As our use of our student data management system increases, we look toward implementing systems to help us meet the increasing requirements for data analysis related in large part to the increasing testing requirements.

School Directors' Report 2004

The Windham Elementary School is running very smoothly and is providing an education that is challenging and stimulating in a stable environment. Madeline Rice continues her fourth year as our Principal promoting academic excellence and addressing the myriad of administrative tasks involved with the day-to-day operation of the school. The teachers and support staff are working hard to address the students' individual needs and meet the goals appropriate for their specific grades as well.

A big change from last year is that the state's funding law, Act 60, has been replaced by Act 68. Under Act 68, the sharing pool has been eliminated and an excess spending provision has been put in place. Schools must keep their expenses per student below an established statewide figure or else be subject to penalties. The School Board has been successful in keeping education spending per student below this year's required figure of \$10,800 and has, as much as possible, worked to level fund the 2004-05 budget in order to see what effect Act 68 will have on property taxes. Many of Act 68's details are still being worked out at the state level so it is difficult to predict its effect on Windham's taxpayers. However, it is looking hopeful that we may see some reduction in our tax bills.

Act 68 uses the term "equalized student" in figuring per pupil costs. The number of equalized students is determined by calculating the total number of pupils from Essential Early Education through grade twelve and including state-established factors for populations of students that are more expensive to educate including high school students, children from poverty and students who speak english as a second language.

Enrollment for the 2004-05 school year is projected to be 27, down from this year's level of 30. At present, only one kindergartner is expected to enter school in September and so the proposed staffing allows for this student to be part of the grades 1-3 classroom, eliminating the need for a separate kindergarten teacher. The structure of staffing at the school is flexible so the fluctuations in student population can be accommodated. Windham Elementary School plans to continue to teach preschool with its own staff.

A weekly hot lunch program was started this fall and is very popular with the children. During last year's legislative session, a new law, Act 22, was passed requiring public schools to offer federal daily school breakfast and lunch programs unless the voters in the community vote to opt out of this requirement. We feel that our present system of offering a weekly lunch is about as much as is appropriate for our very small school and that a daily meals program would require more staffing, equipment and storage space than we presently have. As you may have noticed in the warning, there is an article to be voted on regarding opting out of the school breakfast and lunch program. The School Board recommends that voters do opt out of the daily meals requirement for the 2004-05 school year.

We thank the community for its continuing support of the school and the children. With the remote location and large hills separating us from other towns, Windham is a small community and our school is very small by necessity and not choice. The role that community members can have in the school is significant. We so appreciate the generous donations of time, energy and money given to the school this year by residents of town. It is truly the spirit of the community that enables us to continue to work to provide the best school and education for our children.

TRANSFER STATION/RECYCLING CENTER

Members of the Londonderry Group Solid Waste District will notice that their budget figure for 2004 has taken quite a jump from 2003. The cost of hauling and dumping has gone up but a large part of the increase is for new equipment and for re-arranging the facility. Our trash compactor, bought second hand in the mid 80's, has been welded 3 or 4 times in the last 6 years and where it was placed it isn't working. Water from rain and snow run off gathers and freezes under the 40 yard container we compact into; mixed into this ice is any leakage from the garbage in the 40 yarder. The State of Vermont has given us a conditional certification for our facility; it is conditioned on us putting in a 1000 gallon underground holding tank to catch any leakage (leachate) from the garbage in the 40 yarder. Leachate will have to be pumped out and taken to a sewage treatment plant.

In order to make an acceptable and workable set up, the plan is to buy a new compactor, put the compactor and 40 yarder that it feeds on higher ground, install a 1000 gallon holding tank, put a roof over the compactor and 40 yarder to keep rain and snow out of the holding tank, buy Matt a new and safe shed and erect a shelter for Larry to sort bottles in. The estimated cost we are working with \$105,000, has been arrived at with the help of an engineer supplied by Casella Inc. and has been budgeted to the 5 towns as follows: Landgrove, \$10,500—Londonderry, \$43,050—Peru, \$16,800—Weston, \$22,050—Windham, \$12,600. The percentages used to allot the cost of the changes are the same percentages used to allot the cost of day to day running of the facility. The State has given us until 7/1/04 to complete the changes and so we will be going to bid shortly.

The Hazardous Waste Day pick-ups for 2004 are Saturday May 22nd and Saturday Oct. 30th from 9 a.m. to 1 p.m. at Flood Brook Elementary School in Londonderry. We are getting between 70 and 80 cars per HHW day; thank you for participating. Questions or suggestions? Call the Recycling Co-ordinator at 824-3356.

Lister's Report 2003

The Lister's roster has undergone a change with the resignation of Brenda Bingham (nominated and approved at the last Town Meeting). Jerry Dyke was appointed by the Selectmen until the next town meeting.

Last years report stated "Nothing has changed with regard to Act 60 -----". This year we report that a major change has taken place with a revised plan called Act 68. The "Sharing Pool" has been changed. Note: This Act applies only to the school portion of your taxes.

It has put vacation homeowners on a fixed school tax rate and residents on a flexible school tax rate. In essence, vacation homeowners will pay \$1.59 per \$100 grand list valuation. The Municipal tax rate is the same for both categories.

Resident homeowners will pay \$1.10 per \$100 grand list valuation, ADJUSTED by the percentage by which the school budget exceeds \$6,800 per student. (A value selected by the State). Example: if the cost per student is \$10,000, the difference of \$3,200 will realize an increase in the \$1.10 school tax rate of \$.47 (3,200 divided by 6,800), or \$1.57 school tax rate. In addition, if the per student amount rises in excess of \$10,800, another surcharge is added to the Town's rate.

This then, will require the Town's Grand List to be broken into resident and non-resident categories. That is why every resident homeowner MUST file a Declaration of Vermont Homestead form (HS-131) to be enrolled as a resident homeowner. Failure to comply will have its own set of penalties. The State will send a list to the Listers, who must validate that the list is complete and correct, and return it within one week.

There are other changes in the law relative to "homestead" and "domicile". To summarize, the procedure has not been simplified but rather has been further complicated with additional work for the listers.

As always, the property owners are subjected to adjusted valuations on their properties, which do not appear readily. Example: A property valued by the listers for \$100,000. Sales of properties in the town are selling on average for 21% more than listed values. For that year, the State assumes that ALL properties in the town would sell at that rate of increase and adjusts the town's total grand list. This becomes the Equalized Grand List, which is the basis of the monies the town must send to the State. In effect, the taxes being collected on every homeowner, resident and non-resident, are based on a higher value than the listers valuations on that property.

For 2003, we have been advised, that the average listed value remains accurate within 91.6% based on actual sales, our deviation from the average (called COD,

coefficient of divergence) has increased to 14.7%. This implies that some taxpayers may be paying more or less than the average. Reappraisal of the Town's parcels must be undertaken when CLA drops below 80% and/or COD is greater than 20%.

In 2002, there were 35 towns, which exceeded the 20% rule and reached 39%. There were only 27 towns registered below a 10% criteria.

We have advised the State Department of Property Valuation and Review, that the many factors which contribute to the variation of sale prices are too many and varied to maintain a COD of under 20%. We have constantly suggested other alternatives but to no avail.

The major emphasis of the Planning Commission has been to continue to upgrade the 5 year Town Plan. The plan has been submitted to the Windham Regional Commission for review. The plan will be presented to the Board of Selectmen after which a properly warned meeting will be held by the Town.

The major changes to the plan are an update of statistics and a revised organization of the information.

A great deal of interest has been expressed with regard to the availability of flood insurance following the rain storm and subsequent damage to property. The Commission is in contact with the Windham Regional Office to submit the necessary application to the Federal Office, and preparing to develop an ordinance for the Town's adoption.

As always, the meetings are open to the public and we welcome your participation in providing your thoughts on the town's future direction. Meetings are held every 2nd Thursday of the month at 7:00 PM at the town office.

2003

As the Health Officer for the Town of Windham, I attended the two required Health Officer training sessions in May and October, that were sponsored by the State Health Department. The Oct. session covered residential fire safety requirements. Copies of the handouts were passed on to the members of the Windham Fire Co.


For the third summer, I participated in the West Nile Surveillance Study conducted by the State Health Department and the Department of Agriculture. This required weekly overnight collection of mosquitoes and delivery to the Health Department. Statewide, Vermont had no positive mosquito pools. The Town of Windham did not have any dead birds that tested positive for West Nile Virus.

In June, I was asked by the Select Board to inspect a complaint of trash thrown into a brook that ran through private property. I made a referral to the Agency of Natural Resources after I did find trash in the brook. But in August, the flood through Rte. 121 took care of the problem.

In the fall, Edith Serke, a member of the Board of Directors of the Council on Aging for Southeastern Vermont, and I collaborated to establish a volunteer transportation service. Our objective is to assist any residents of Windham who are unable to get to medical appointments, diagnostic tests or medical treatments which require an accompanying driver. We have some volunteers willing to drive, but in the first few months of this new program, we have not received any calls for transportation. We will continue to work on getting the message out to the community of this service that is available to people of all ages.

If the residents of Windham have any concerns regarding health issues of their home or environment, please contact me. I have handouts on a variety of subjects and can direct a question to the appropriate source if needed.

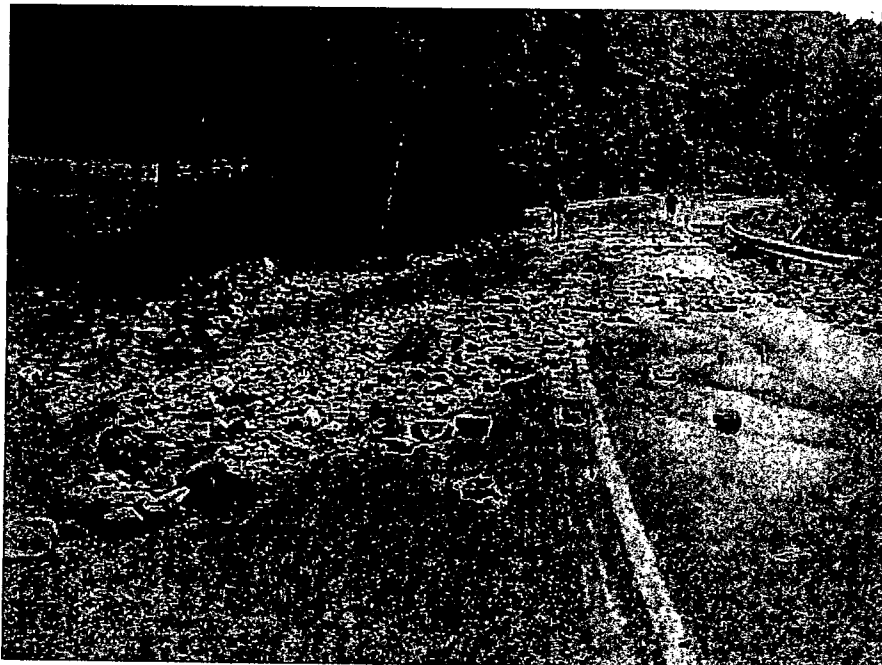

ANNUAL TOWN REPORT

The Londonderry Volunteer Rescue Squad responded to 474 calls in 2003. This is up from 416 calls last year. The locations of these calls are as follows: 1 in Andover, 11 in Jamaica, 7 in Landgrove, 117 in Londonderry, 90 in South Londonderry, 29 in Peru, 15 in Stratton, 48 in Weston, 26 in Windham, 68 in Winhall, and 2 in Manchester. There were 60 calls at the following ski areas: 30 at Bromley, 22 at Stratton Mountain, 7 at Magic Mountain, and 1 at Viking.

Of these calls: 214 were illnesses, 130 injuries, 71 motor vehicle accidents, 11 stand-by calls, 9 canceled or dry runs, 7 transports, and 32 public assists. We responded to 14 mutual aid calls, while 19 calls resulted in other services coming to our aid. Our members started 114 pre-hospital IV's, and we used the Paramedic Intercept service 9 times.

We are excited with the many changes and upgrades that took place in 2003 that will continue into 2004. The State of Vermont has finally passed the advanced life support protocols that we first proposed over four years ago. A 34-hour course this spring will enable our EMT-Intermediates to do many of the procedures that we now call for a Paramedic to do. We are fortunate to have 34 members on our squad with 15 of them being EMT-Intermediates.

We have a new "Road Rescue" ambulance on order that should arrive sometime in February. This ambulance is slightly larger than our current ambulances, mounted on a Ford E450 chassis. With the trade in of our 1994 ambulance, the new ambulance will cost \$106,520. We have been awarded a total of \$66,555 in Homeland Security Grants. This has enabled us to purchase radios, a portable power unit for our extrication unit, air bags, Thermal Imaging Camera, AED's, and medical supplies. We will also be purchasing a bi-phasic heart monitor, generator, portable lights, electric saw, air chisel, impact wrench, and other tools and medical supplies. We received \$2,300 from the Thrifty Attic to purchase a new stair chair. The State of Vt. EMS gave us an Automatic External Defibrillator, which is now located at Mountain Valley Medical Center and will cover Flood Brook School as well.

The Londonderry Volunteer Rescue Squad thanks you for your continued generosity and support. New members are desperately needed. If you have the time, desire, and the dedication it takes, please contact one of our members or go to the town of Londonderry's Website for information about joining.

VERMONT LEAGUE OF CITIES AND TOWNS

The Vermont League of Cities and Towns' mission is to serve and strengthen Vermont local government. Most government services used by Vermonters on a daily basis are those provided by its cities and towns. These include highways, police, fire, recreation, sewer and water. Vermont municipal officials are responsible for raising and expending nearly one-half of the non-federal taxes raised in the state.

In large part, volunteer elected and appointed municipal officials lead these governments. VLCT provides the following services to its member cities and towns to serve and strengthen the ability of these officials to provide quality services at affordable levels of taxation:

- **Advocacy representation before the State legislature, administration and judiciary, ensuring that municipalities have the resources and authority to serve their citizens.** VLCT is a leader in the education finance debate and in securing revenues for town highway and bridge maintenance programs.
- **Training, technical assistance and publications to strengthen the ability of municipal officials to serve their communities.** In the past year, we have responded to almost 50,000 telephone calls, 21,200 of them from local officials on the toll-free telephone line available to them. Our Municipal Assistance Center and Group Services staffs provided over 750 workshops and small group training sessions attended by over 4,000 municipal officials and answered over 2,300 legal questions posed by municipal officials. VLCT distributed over 575 copies of local government publications and distributed over 3,200 hard copies or electronic mail versions of VLCT's *Weekly Legislative Report* to municipal officials each week during the legislative session.
- **Purchasing opportunities to provide needed services at the lowest cost.** These include an array of municipal insurance programs, among many others. Examples of how this saves local taxpayers dollars are the securing of municipal employee health insurance and liability coverage for town operations. The VLCT Health Trust represents the most affordable option available to provide health insurance to your employees. The value of VLCT PACIF to all our members was made painfully clear last year when the major re-insurer for the largest private sector option available for municipal property and casualty insurance was declared insolvent by the State of Pennsylvania, threatening the payment of claims made under those policies.

All 246 Vermont cities and towns are members of VLCT, along with 140 other municipal entities including villages and fire districts. Membership dues are \$.72 per capita plus a \$250 service fee per year. VLCT maintains its offices in Montpelier and employs 42 staff members. It has an annual operating budget of approximately \$3.0 million.


We hope that you will consider adding the following warnings in the 2003 Annual Report for the Town of Windham:

2003 ANNUAL REPORT

The Council on Aging for Southeastern Vermont, Inc. (COASEV, Inc.) fosters and supports successful aging of seniors in the Windham community and throughout Windham and Windsor Counties. COASEV staff, along with seniors and other community members, develop, advocate, coordinate and assure access to services which enhance the quality of their lives in Windham. To accomplish this mission in Windham we provide direct services as those listed below, as well as work collaboratively with other organizations in Windham.

- ◆ **Information and Assistance** – through the Senior Helpline at 1-800-642-5119 – Providing resources, tips, applications for benefits, and assistance with health insurance information.
- ◆ **Senior Nutrition** – Home delivered meals are provided through a contract with Grace Cottage Hospital and congregate meals are available in Londonderry, Townshend and Grafton.
- ◆ **Transportation** – Special arrangements are made for non-Medicaid seniors requiring medical transportation.
- ◆ **Case Management** – Providing one on one case management to those wishing to stay in their community and by managing the Medicaid Waiver program which provides nursinghome like care. With self-neglect referrals we assist the individual to become aware of and access services thus regaining control of their lives. 7 Clients are currently receiving these services at an annual cost of \$5,467.
- ◆ **Advocacy** – Assisting with accessing a wide array of benefits such as VHAP pharmacy, fuel assistance, food stamps, telephone lifeline, tax rebates, and Supplemental Security Income. These services are provided through home visits out of our West River Valley Regional office.
- ◆ **Care Giver Respite** – Through grants we are able to provide respite assistance for caregivers of those diagnosed with dementia and other chronic diseases.
- ◆ **Senior Companion Program** – Providing friendly visiting as well as a stipend employment opportunity for older, limited income workers.
- ◆ **Planning** – for seniors is accomplished by working with legislators, other agencies, and the communities we serve.
- ◆ **Successful Aging Initiatives** – Providing a series of small community grants for groups and organizations to create and expand their programs. This year a grant of \$755 was made to help support Windham News & Notes.

Your town contribution of \$200 will generate \$1,133 in Federal matching funds to support all of these activities. Services are provided at no cost but participants are encouraged to make anonymous, voluntary contributions. The support of Windham citizens as well as that of the hundreds of volunteers and dedicated staff make these services possible.

RSVP recruits people 55 and older and matches them with volunteer jobs at non-profit organizations throughout Windham County. By doing so, we help solve local problems and improve the quality of life in all of our communities. Volunteers receive training, assessment, supplemental insurance coverage, and recognition for their contributions. RSVP's affiliated "Volunteer Connection" (VC) refers people under 55 who wish to volunteer.


RSVP is a part of the National Senior Service Corps, is a United Way member agency, and is sponsored by Health Care & Rehabilitation Services of Southeastern Vermont, Inc.

Last year 496 RSVP volunteers contributed 76,928 hours of service in Windham County through 129 not-for-profit community agencies. Windham residents received an estimated 538 hours of service through the work of those volunteers, which in dollars equates to approximately \$8,034. We are asking Windham voters to consider providing \$150 in funding, the same amount as last year, to RSVP for FY 2005.

Examples of how RSVP volunteers make a difference for Windham residents:

- Help improve children's reading skills, as an RSVP America Reads partner at Windham Elementary School; help introduce children and their families to kindergarten through support work for Early Education Services' "Teddy Bear Teas."
- Support local health care by volunteering at Grace Cottage Hospital.
- Ensure that people who lack transportation are able to get to medical appointments, by serving as drivers for Town & Village Bus (now Valley Transportation) and Vermont Association for the Blind and Visually Impaired.
- Support independent living and help to alleviate loneliness and isolation by helping elderly citizens with their tax forms through AARP's Tax Aide Program, and visiting or entertaining local nursing home residents.
- Help people get through tough times by serving in local thrift shops and soup kitchens, and by knitting or crocheting sweaters, mittens and baby sets for local children through the Reformer Christmas Stocking.

The following is the letter we sent to you on December 11th, as per your auditor's request.

The Women's Crisis Center formally asks that you place its request for \$450 from fiscal year 2005 funds on the warning for the March, 2004 town meeting. This represents what we hope the taxpayers of Windham will agree is a modest increase after 3 years of level-funding.

During the past fiscal year (7/1/02-6/30/03), the Women's Crisis Center provided emergency shelter to 1 woman from Windham for a total of 2 shelter-days. We also answered crisis calls from or on behalf of 14 known residents of Windham. Since many of our callers prefer to remain anonymous, there could well have been more Windham citizens directly utilizing our services. And we continue to believe that our ongoing community education, outreach, and emergency response efforts benefit all of Windham County.

The Visiting Nurse Alliance is like the local police and fire departments - a strategic part of the community's safety net – with services that must be continuously available to anyone in need. The need varies dramatically from month to month and year to year. The VNA provides a comprehensive range of care, requisitioned by hospital staff and physicians, for everyone, regardless of ability to pay.

We value the continued partnership with the Town of Windham to help us meet your residents' home care, hospice and family health needs. Town funding accomplishes the following:

- Enables your family, friends and neighbors to remain independent and at home as they receive skilled clinical care during times of injury, recovery from surgery or accidents, disability, whether for short-term and chronic illness. For many such patients, many are addressing multiple medical, emotional and social issues at the same time.
- Provides emotional support plus pain and symptom management during terminal illness. Hospice care extends to family members as well. More and more patients want to be at home during their end of life, and through hospice they have that control.
- Provides community-wellness programs and assistance to young families at risk. Clients range from fathers and/or mothers who want to be more effective parents through learning parenting skills or providing a balanced diet; infants who require hi-tech health care; and children who grow and learn through play groups that offer interaction with other children.

The WRC assessment is calculated using the 2000 Census population estimates, and the Federal Reserve Board's annual inflation estimate. The current population estimate for Windham is 328. The WRC assessment for this year is \$1.39 per capita based on the 2000 U.S. Census population estimates (with a \$250.00 minimum). The per capita assessment was adjusted to account for the Federal Reserve Board estimated Consumer Price Index when the WRC budget was drafted this summer. The assessment for the Town of Windham is \$456.00.

Annual Report – Town of Windham, 2003

- **Bioterrorism and Emergency Preparedness:** The Vermont Department of Health is actively working with local, state and federal agencies to assure a rapid and effective response to bioterrorism and other public health threats or emergencies. Local health department response may include finding and identifying disease, investigating the source of the disease, providing accurate and timely information to the public and health professionals, and collaborating with other agencies during biological, environmental or weather events. Recent local efforts have included participation in hospital committees, smallpox vaccination clinics, and membership on the District 3 Local Emergency Planning Committee (LEPC #3).
- **Special Supplemental Food & Nutrition Program for Women, Infants, and Children (WIC):** WIC improves the health of eligible pregnant and postpartum women, infants and young children through access to health care, nutrition education and individually designed nutritious food packages. In 2002, numerous women, infants and young children living in Windham received health and nutrition screening, education and nutritious foods through this program. Participation in this program has been steadily increasing in this area. The average value of foods provided is \$35.00 per person each month.
- **Reportable Disease Investigations:** Infectious diseases continue to be a major source of illness, disability and death in the U.S., accounting for 25% of all doctor visits each year. The Department of Health investigates all reportable diseases, such as hepatitis, meningitis, measles or foodborne illness. When these illnesses occur, we strive to determine their source and recommend measures to control and prevent further spread of disease. In 2002, Windham County had 183 cases of disease investigated.
- **Vaccine-Preventable Diseases:** Proper vaccination protects children and adults against many diseases, saves health care costs, and minimizes sick leave from school or work. Immunization has reduced reportable cases of preventable diseases in Vermont to record low levels. Still, total annual hospital costs from vaccine-preventable disease in Vermont are \$2.6 million, and each year up to 200 Vermonters die of pneumonia or influenza. In 2002, the Department of Health distributed 11,711 doses of vaccine to health care providers in Windham County, at a value of \$154,654 to these communities.
- **Food Establishment Inspections:** Public health sanitarians inspect eating establishments (restaurants, schools and fairs) to decrease the risk of foodborne disease outbreak. The five greatest risks for foodborne outbreaks are storing food at improper temperatures, inadequate cooking, contaminated equipment, unsafe food sources, and poor personal hygiene among food handlers. Inspections include a 44-item review to evaluate food storage, preparation and handling, as well as to identify potential risks. Of the two establishments in your area, there were three inspections in 2002. For the most recent inspection scores and results in your area, please go to www.healthyvermonters.info and select "Program List" then scroll down to "Division of Health Protection" and select "Restaurant Inspection Scores."

- **Town Health Officer (THO) Program:** Every town in Vermont has a THO who is nominated by the Select Board and appointed by the Commissioner of Health. THOs work on a variety of environmental and health issues, and respond to calls on public health concerns as varied as animal bites, West Nile Virus, rental code complaints and septic systems. The Department of Health supports THOs with training, information and technical assistance. Your THO's report describes the calls received for Windham.
- **West Nile Virus (WNV) Surveillance:** WNV first appeared in the U.S. in 1999. Birds and mammals (including people) can get WNV from the bite of an infected mosquito. The Vermont Departments of Health and Agriculture conduct surveillance for WNV each year from June until cold weather limits mosquito activity. In 2003, five THOs throughout the state also participated in this program by assisting with mosquito trapping. As of September 19, 2003, there have been 450 mosquito samples tested, with nine positive for WNV. In Windham County from June – September 19, 2003, 132 dead birds were reported, 52 were tested, and 16 were found to be infected with WNV.

The Vermont Department of Health works to protect and promote the public's health. Current challenges include emergency preparedness and response to disease threats such as SARS or potential acts of bioterrorism; expansion of substance abuse prevention and treatment; and improving health care for people with chronic conditions like diabetes, asthma and cardiovascular disease. Health Care and Rehabilitation Services of Southeastern Vermont requests an appropriation of \$248.00 from the Town of Windham at the 2004 Town Meeting to help defray the cost of services to its residents for the Mental Health Walk-In-Clinic. In the year ending June 30, 2003, our agency provided a comprehensive range of community based services to 4,424 residents of Windsor and Windham counties. The services that are available to the residents of your community are as follows:

Outpatient Mental Health Services: The mission is to provide caring, high quality, cost-effective mental health care for our community at every level of need. Our highly trained staff of professional therapists, social workers, and psychiatrists help individuals and families cope with stress and anxiety, develop their full potential and maximize control of their lives. We make it our paramount goal to ensure that children, adolescents, and adults who come to us receive appropriate, timely care. We are now offering walk-in clinics to any resident who has an urgent need to see a mental health counselor for support and more effective coordination of services.

Alcohol & Drug Treatment Services: For adults and family members who are adversely affected by the use of alcohol or drugs, we offer a comprehensive program of assessment, inpatient referral, outreach, outpatient treatment and aftercare dedicated to aiding the recovery from chemical dependency and its effects.

Community Rehabilitation & Treatment Program: The CRT program provides comprehensive services to adults over the age of 18 who are suffering from a mental illness so serious that it interferes with that person's capacity to function in the community. We provide help and information to concerned family members and help clients regain stability and learn how to manage their mental illness, either in a hospital setting or as outpatients.

Community Services Division: The CSD provides services to people with developmental disabilities and their families. Services are available to people of all ages who have been found eligible, and each person being served receives an individually written program to meet his or her needs.

The Alternatives Program: A short-term alternative to hospitalization, the Alternatives Program provides crisis stabilization, respite and support to clients with psychiatric disabilities or to any adult experiencing an acute mental health crisis. We also provide a transitional residence for those stepping down from an inpatient setting. Our program provides a very desirable alternative to hospitalization in being less costly and less structured, while at the same time providing individualized attention in a more homelike, community based setting.

Emergency Services: The Emergency Services Team has a very specific mission to act quickly in critical situations. Specially trained mental health professionals are available 24 hours a day for emergencies. Anyone may use this service when an emergency arises including individuals of any age, family or friends of an individual in crisis; hospitals and nursing homes; police; schools; clergy; businesses and other community agencies.

We thank the board and the citizens of Windham for your past support and for your continued interest in Health Care & Rehabilitation Services of Southeastern Vermont.

Dear Vermont Coalition of Municipalities Member Town:

The organized effort to substantially reform Act 60 and reduce the reliance on the property tax to fund education is not over. Despite the recent enactment of Act 60 reform, we believe the promise of lower education property taxes will be short term.

Therefore, the Coalition intends to remain an organized force to keep the pressure on the Legislature and the Administration to lower significantly the statewide property tax and reform the property valuation system.

Because there will not be as much activity on this issue until the new Act 68 goes into effect in July, 2004, the Coalition has substantially lowered its dues. Dues have been reduced to \$250 for large dues-paying towns and to \$100 for small dues-paying towns. The dues for your town for the next fiscal year will be:

\$250

Please set aside this amount in your budget for the next fiscal year. An invoice will be sent in June. Thank you.

During the coming year the Coalition will continue to work on the following issues:

- Over-dependence on the property tax to fund education;
- Reliance on a flawed property valuation and equalization system;
- Rapidly rising property values, which under the Common Level of Appraisal (CLA) system, increase tax rates;
- A system based on tax rate instead of tax burden;
- Lack of cost controls over rising education costs; and
- Tax policy inhibiting economic development and job creation.

We will continue to communicate with you on developments in the education finance system. If you have any questions or comments, please contact us.



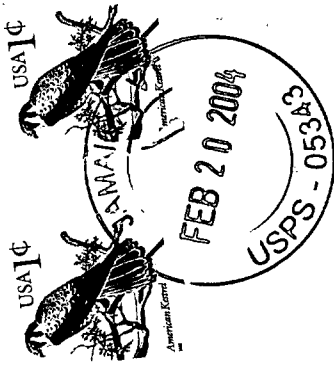
