For the sake of full disclosure, I will just have “finished” working with my colleagues on voting out the water bill that morning, so I can tell you in advance that I am going to walk in with a limited understanding of the bill. Even so, I think it will be a useful conversation to have as we begin to take up RESET, and I thank everyone for agreeing to meet. And as the committee and I learn more about the bill, we will have follow on conversations to get into more detail in the coming week. Our goal is review, edit, and vote out the bill by the following Friday (4/24).
