- a. Tammy Pitt wrote the Board regarding responsibility of after hours service providers. Specifically, it was recently brought to her attention that a number of psychologists, physicians and other physical and mental health care professionals are utilizing answering service personnel, who are untrained and otherwise potentially unqualified to handle urgent and/or emergency calls, as an extension of their office during off-hours. The Board responded that it is notable to offer a “blanket” policy statement on specific conduct as it could influence any Board action on any potential specific complaintan investigation in the future. If she has a concern about a particular instance, she should go to the Board’s website for information pertaining to filing a complaint. In addition, she can review the APA Ethical Standards and the ASPPB Code of Conduct for more information about this aspect of professional practice.
- b. Polly Young-Eisendrath, Ph.D. wrote the Board regarding licensure requirements for a colleague. The Board responded that the qualifications for licensure as a psychologist in Vermont are given in the Rules Relating to Psychologists, Section 2.4 through Section 2.9. Her colleague would need a licensure to do consulting work as a psychologist with organizations, corporations and/or individuals.
