> I guess I am not sure why public information was deleted.

>

> The names, ages, DOB, street number and address, hometown and more are all included in the courthouse paperwork that anybody can see.

>

> Other court paperwork included in the bail statement provide other public information, including job, employer, phone number(s), dates and places and the list of crimes that were charged and resulted in criminal convictions, reductions of charges or dismissals.

> (I snapped a pic of just a charging information that signed by prosecutors in every case.)

> How can we determine if the names submitted match up to a lawyer, or others? (even maybe a newspaper reporter!)

>

> Also the list that was made has some names multiple times. Does that mean the person has 3 or 4 convictions for possession of marijuana?

>

> Some of the names are listed together on the spread sheet. I spotted at least two that were separated by names.

> A few other pending things:

>

> I never heard back from my initial request asking the basis for the Governor stating the pardons could be revoked for false information or other issues.

>

> (I may have outlined what happened when an agreement with a convicted rapist fell through, Gov. Snelling was unable to pull the pardon. So how will these be handled? Especially when Gov. Shumlin is likely to be out of office when the fraud or false info comes to light? How does one Governor undo a pardon issued wrongly by a second Governor?)

> We also had asked in the initial request about the breakdown for the cost of approving these pardons.

> Also what can I get the latest update on the number of applications?

> Thank you very much for the partial response to my Vermont Public Records request concerning the application
being filed with Gov. Shumlin seeking pardons for possession of small amounts of marijuana.
>
> Before I consider the appeal you suggested, I am seeking the rest of the information requested first.
>
> Unfortunately the state's response failed to meet my request for the pardon forms submitted by those seeking to
have their records wiped clear. Obviously we are doing an assessment about how many of those seeking pardons
are old cases or new cases. The Governor said some people picked up in 1968 have been unfairly penalized. We
hope to determine through the public records how many are from 40-50 years ago and how many are 4-5 years ago.

> We are seeking the specific forms and information – as provided under the Vermont law – to review the action of
how each state government officer is responding to this pardon program proposed by Gov. Shumlin. That is one of
the standards under the law. Clearly based on the interviews and the records released there are some questions.
>
> Also with the limited information you provided there is no way to determine who these people are without the full
information on the pardon applications. It even appears that a Burlington lawyer is among those who applied, or is
it somebody with the same name? Who knows? We don't have ages, addresses and more that were all part of the
public record when these people were convicted.
