COMMITTEE INTEL:

- **Senate Judiciary, School Discipline bill, [S.67](#):** would create a school discipline advisory committee, AOE does not recommend supporting this bill, it would require a lot of work on their part and is essentially duplication of efforts. The bill mostly relates to data collection and the idea that discipline impedes education and disproportionately affects IEP and minority students. Despite testimony against this bill from AOE and others, will likely pass. Sears and Campion pushing.
- **[H.98](#), relating to reportable disease registries and data,** is moving along. It would allow VT to share cancer info with early detection programs, require data on HIV to be stored on networked computers in the same manner as data on other reportable diseases (HIV community wants this), and would expand access to a student's immunization records. Anti-vaxxers are opposed so there is some controversy here. VDH proposed the changes, likely the HIV piece will be the only piece left standing.
- **[S.9](#), Child Protection:** Passed Senate Judiciary 5-0 and Senate Health and Welfare approved changes. It will likely come out of S. Appropriations tomorrow, and Sears may try to suspend the rules and have it on second reading for Friday.
- No ombudsman in new version (though will likely appear in House). A fiscal note states this would cost around \$240k.
- There is a legislative oversight committee still in the draft but it would not have the ability to review confidential information. S. Appropriations thinks they can absorb costs for this.
- And there were good developments in the criminal issue, toward what DCF favors.

- **S.44, relating to early college**, will pass Senate Education tomorrow. Currently cap is at 18 for each college, this bill would allow colleges to exceed cap as long as aggregate does not exceed 54 total. Passed Senate Education.
- **Harry testified on Act 49 of 2013 – End of Life Choices** in Senate Health and Welfare. He reported it is working as intended and would be comfortable lifting sunsets

Health Care:

- **House Ways and Means Payroll Tax:** testimony went relatively well, no new news here. However, Rep. Komline brought up the issue of the scenario 5-10 years down the road. Committee was concerned with Teachout's [numbers](#).

- **Al Gobeille in House Health Care:** The testimony was well received and covered a lot of ground with regard to All Payer Waiver and Cost Shift. Gobeille reiterated that while addressing the cost shift is not required in order to get the all payer waiver, it would be in the best interest of the state to make sure it is addressed. When asked about his thoughts when people say that the cost shift does not exist, Gobeille likened it to a price differential. The committee found this analogy helpful.
