

Dear Governor Shumlin:

Pursuant to Vermont's Public Records Law (1 V.S.A. §§ 315-320), I request that the Agency of Administration release the following public records in its possession, custody or control:

1. All public records from the period of January 1, 2011 to September 16, 2012 related to the number of times Lt. Governor Phil Scott has been acting Governor and for the duration of time that Lt. Governor Scott has been Governor.
2. All public records from the period of January 1, 2011 to September 16, 2012 of the Governor's schedule.
3. All public records from the period of January 1, 2011 to September 16, 2012 related to the Governor's out-of-state travel expenses for official Vermont business, political activities and for personal vacation time.
4. All public records from the period of January 1, 2011 to September 16, 2012 related to any staff or security expenses for out-of-state travel for official Vermont business and political activities.

5. All public records from the period of January 2002 to December 31, 2010 related to the number of time Lt. Governor Dubie was acting Governor.
6. All public records from the period of December 7, 2011 to September 16, 2012 related to any correspondence or emails between the Governor's office, staff and the Secretary of State's office, Attorney General's office, the Auditor's office and State Agencies that mention Senator Randy Brock.
7. All public records from the period of December 7, 2011 to September 16, 2012 related to any correspondence or emails between the Governor's office, staff and the Secretary of State's office, Attorney General's office, the Auditor's office and State Agencies that mention Annette Smith and/or Martha Abbott.


I am addressing this request to you in the belief that you are the custodian of such documents. If you are not, I request that you forward my request to the proper custodian of such documents and inform me of whom that person is.

If the law does not allow me to have access to some of these records, please inform me within two business days, as provided by law, and inform me of the specific exemption that applies to each record or portion of a record being withheld. If an otherwise public record has a portion that is exempt from disclosure, I request that you block out the exempt portion and release a copy of the rest of the document together with a notation of the specific exemption that applies to the portion withheld.

If some or all of my entire request is denied, please tell me the title and name of the person responsible for the denial and, as the law requires, please inform me of the appeal procedures available to me and the name of the person to whom appeal may be made.
