1. The meeting was called to order at 9:10 a.m. by the Board Chair, James Eckhardt.
2. The Board reviewed the Minutes of the September 19<sup>th</sup> meeting. Mr. Davis made a motion, seconded by Mr. Wernecke, to accept the minutes of the September 19, 2014 meeting as submitted. Motion passed unanimously.

Mr. Davis, made a motion, seconded by Mr. Murphy, to accept the Investigative Team's recommendation and concluded the case without formal prosecution. Motion passed 3-0. Mr. Eckhardt, Investigative Team member abstained from the vote.

Mr. Wernecke, made a motion, seconded by Mr. Davis, to accept the Investigative Team's recommendation and concluded the case without formal prosecution. Motion passed 3-0. Based on the information submitted, Mr. Wernecke made a motion, seconded by Mr. Murphy, to approve Talentwise Inc. and Mr. Powers Qualifying Agent's application. Motion passed unanimously.

The Board reviewed the request for Nancy J. Murray to be added to Green Mountain Concert Services 40 hour training instructors. Based on the information submitted, Mr. Murphy made a motion, seconded by Mr. Wernecke, to add Ms. Murray to GMCS list of 40 hour training instructors. Motion passed unanimously.

The Board reviewed the request for a waiver of the 40 hours of training and request to be added as a trainer of the 40 hour training program with Securitas from Robert Frankson. Based on the information submitted, Mr. Davis made a motion, seconded by Mr. Murphy, to grant the waiver of training excluding the 4 hours specific to the Vermont Statutes and Rules and add him to the list of the instructors for Securitas. Motion passed unanimously.
