## **Part 1: School MLTS (ECS) Status**

**Background:** In the spring of 2016, the Enhanced 9-1-1 Board resumed its work of assessing the capabilities of telecommunications systems in Vermont’s schools. The assessment focused on whether existing multi-line telephone systems (MLTS), now referred to as Enterprise Communications Systems (ECS), were capable of sending accurate and specific location information to Vermont 9-1-1.

The phrase “accurate and specific location information” means that when a 9-1-1 call is placed from the school’s phone system, the 9-1-1 call-taker can see not only the physical address of the school building, but also the unique phone number in use and the specific location (room number, floor number, etc.) of the caller within the school. The ability of a call-taker to see this information, and pass it on to emergency responders, is critical in events where a caller is unable to speak or does not know their specific location or phone number.

During the fall of 2016, over eight hundred 9-1-1 test calls were placed from 267 of Vermont’s 304 public schools. The test call results showed that while nearly all test calls provided an accurate street address for the school building, only 60 schools (approximately 20%) were capable of also sending the unique phone number and specific location information. Thirty-seven schools did not respond to requests to conduct test calls. Each school and supervisory union was provided with a report on their test call results. Follow up with schools included information about the availability of 9-1-1 Compliance Grant Funds.

**Current Status:** **Updated 1/30/2019:** **One hundred** additional schools have become compliant with the 9-1-1 requirements since the Fall of 2016. This means that **160** schools, or approximately **53%** of Vermont public schools, have demonstrated the ability to send **all** required information to the 9-1-1 system. Based on the compliance grants awarded to date, the Board can report that another 24 schools are expected to complete upgrade projects by the end of 2019. Successful completion of these projects will move the number of compliant schools to 184, or 60%. The number of compliant schools is expected to move to 199, or 65% by the end of 2020.


*It is important to note that all tested schools have shown the ability to send the correct physical address of the facility.*

### Part 2: Enhanced 9-1-1 Compliance Grant Program

**Background:** The Enhanced 9-1-1 Compliance Grant Program was created by Act 160 of the 2016 legislative session. This Building Communities grant is intended to provide financial assistance and incentive to Vermont schools to support the identification and implementation of needed changes to the school's telecommunications technology so accurate address and location information (i.e., specific call back number, building name/number, floor number, room number, etc.) is provided to Vermont 9-1-1 in the event of an emergency. Grants are awarded competitively and the program is authorized to award matching grants of up to \$25,000.00 per project.

**Funding and Award History:** Since the Fall of 2016, \$512,496.69 of compliance grant funds have been awarded for projects benefitting 95 Vermont schools. The grant awards range in value from \$250.00 to \$25,000.00. The average award was \$5,394.70. A table showing all awards begins on page 3.

➤ **Fall 2016:**

- 15 applications received on behalf of 15 schools
- \$78,787.50 was awarded to projects impacting 15 schools from the 9-1-1 Compliance Grant Fund of \$200,000.00

➤ **Spring 2017:**

- 53 applications received on behalf of 68 schools
