MINUTES

March 13, 2023 Remote Meeting

1. Call to Order: The meeting was called to order at 9:00 am by the Chair, Jennifer Laurent.

William “Jamie” Floyd moved to accept the state’s request for summary suspension; Jennifer Lyon seconded. The motion passed unanimously.
