Wednesday, September 11th, 2024
at 9:00 a.m.

1. Call to Order

The meeting was called to order at 9:00 A.M. by Dr. Ruhl.

3. Approval of Previous Minutes:

Dr. Coakley moved to approve the minutes of May 8th, 2024. Ms. Kelly seconded the motion. The motion passed unanimously.

5. Other Business

- **Dental Assistant Application of SDF**
 - Dr. Ruhl provided a correspondence to the Board, asking for more information on dental assistants applying SDF to patients.
 - Dr. Koch moved to have attorney Tredeau add language to the pending administrative rules, stating that traditional dental assistants may apply SDF if appropriately trained. Ms. Kelly seconded the motion. Dr. Grimes opposed the motion. Motion carried.
- **Possible Expansion of Dental Assistants role in Dental Hygiene Service**
 - Dr. Koch and Dr. Coakley stated that this could affect the quality of care. Dental hygienists are appropriately trained, whereas dental assistants do not require training for licensure.
- **Dental Laboratory/Dentist interaction with direct patient care**
 - Dr. Koch presented a scenario to the Board: A patient brings a loose crown to a

dental laboratory. The assistant then puts their hands in the patients mouth to remove or place temporary crown.

- Attorney Tredeau informed the Board of Vermont State Dental Statute 26 V.S.A. § 561 (3)(C)
 - “Practicing dentistry” means ...except on the written prescription of a duly licensed dentist and by the use of impressions or casts made by a duly licensed and practicing dentist”
- Dr. Koch suggested that the referring Dentist be specific in the work order what you’re asking the lab to do.

- **Officer Elections**

- Chair: Dr. Koch moved to nominate Dr. Ruhl as Board Chair, Dr. Grimes seconded the motion. Motion carried.
- Vice Chair: Dr. Ruhl moved to nominate Dr. Koch as Board Vice Chair, Dr. Coakley seconded the motion. Motion carried.
- Secretary: Dr. Koch moved to nominate Ms. Kelly as Board Secretary, Ms. Greaves seconded the motion. Motion carried.
