Unapproved Minutes
Meeting of February 17, 2011

1. The meeting was called to order at 9:11 A.M.

Members present: Mark A. Basol, DVM, Chairman; Ronald S. Svec, DVM, Secretary; J. Drexel Wheeler, DVM and Terry York.

2. The Chair called for approval of the Minutes of the December 9th meeting. Dr. Svec made a motion, seconded by Dr. Wheeler to approve the Minutes of the December 9, 2010 meeting as presented. The question was called and the motion passed unanimously.

3. Hearings/Stipulations and Consent Orders:

- a. A Summary Suspension hearing was held in the matter of Dr. Steven P. Sanford, Docket Number 2010-687. Larry S. Novins presided for the Board. Prosecuting Attorney, Edward Adrian presided for the State. The Respondent, Dr. Steven P. Sanford, and his Attorney were present. The Board went into deliberative session from 9:50 A.M. to 9:57 A.M. and again from 1:04 P.M. to 1:26 P.M. The Board denied the State's request to summarily suspend Dr. Sanford's license. The Chair, Investigating Member, did not participate in the vote.
- b. The Board considered a Motion to Modify Stipulation and Consent Order in the matter of Dr. Gene J. Courtright, Docket Number 2009-155. Larry S. Novins presided for the Board. Prosecuting Attorney Edward Adrian presided for the State. The Respondent was not present, however his Attorney was. Dr. Svec made a motion, Seconded by Dr. Basol, to accept the modified Stipulation and Consent Order. Motion passed unanimously. Dr. Kristin Haas was the Investigating Member.
