1A	Joint Fiscal Office	\$125,000	Funds to pay for IT project review consultant. This work funded from capital bill FY15 to FY21. Currently funded with legislative carry-forward
2A	Joint Fiscal Office	\$65,000	Funding to pay for limited-service position in FY22. Position authorized by JFC on September 17, 2021 for ARPA funding-related work
3A	Legislature	\$105,000	Funding to pay for HR Generalist in FY22. Position authorized in Act 74
4A	Reversion	(\$295,000)	Additional FY22 reversion from Legislature to cover all new FY22 funding requests

FY23 Budget Pressures + Reversion

1B	Pay Act	\$388,000	4.15% pay act for all legislative staff and legislators
2B	Benefits increases	\$249,971	defined benefit rate from 21.4% to 25.5%; health premiums at 10.7% above 2021 rates
3B	ISF increases	\$45,862	Internal service fund charges up 3%
4B	Staff changes	\$112,096	Staff transitions - replacement staff opting into higher cost retirement/health plans
5B	New staff	\$85,764	Annualizing remaining new costs for positions authorized in FY22 and JFO temp staff to permanent
6B	All other changes	\$100,990	Increases to contracted IT costs (primarily Microsoft platform) and other misc. minor cost increases
7B	Reversion	(\$250,000)	FY23 reversion from legislative departments
