




Personal Note from the Treasurer

"2022" was a year of progress and return to normalcy from the upheaval that was Covid. In the treasurer's office, there are three primary areas of progress to note. First, the treasurer's and clerk's offices are now able to take credit card payments for all items of town business. Second, an external audit was conducted by Sullivan Powers and the results were not only a clean audit, but a great commendation to the town for our current fiscal practices. Third, we received our first half of ARPA funds (along with virtually every other town in the state of Vermont). The second half was received in our current fiscal year (FY23). Those funds, under the discretion of the Select Board, have been allocated to the purchase of a fire truck for the Clarendon Fire Association and a new town grader. Please note on the ballot, the measure to create a municipal buildings fund. The purpose of the fund is to be able to better care for our municipally owned facilities and offset the maintenance costs associated with them. The Select Board's intent is to transfer the remaining ARPA monies into this fund, a decision I wholeheartedly support. It has been a privilege to serve you. My door is always open for anyone who wishes to ask questions or review the town's financial documents. I hope to see you all in March for Town Meeting day. Best Wishes for 2023.

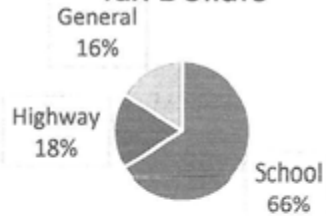

Select Board Report FY22

The Select Board is honored to serve on behalf of the Town of Clarendon and respectfully submits the following report on Fiscal Year 2022 (July 1, 2021- June 30, 2022):

Fiscal Year 2022 was a year filled with change and activity. The Board welcomed Art Menard to the Select Board in March of 2022. Art has served on the Community Center Board for many years and recently joined the Rec Committee. He has been a great addition to the town's leadership. The Select Board extends their gratitude to outgoing Board member, Rick Wilbur, for his years of dedication to the town.

Clarendon saw two of their longtime Transfer Station attendants decide to officially retire. The Board thanks Tom Weeks and Joe Turner for their many years of service to the community and wish them all the best in their fulltime retirement. The Board also welcomed the newest members of the Transfer Station team, Horst Gebauer and David Hance.

Summer of 2021, the Highway Department added a temporary employee, Zack Ames. Zack was integral in helping the road crew safely ditch Walker Mountain Road, in preparation for paving. Having Zack on projects that required flagging/tree removal, created a less hazardous work environment for the whole crew. Road Commissioner Ruane thanks Zack for his help during that season.

Clarendon was awarded a substantial grant from the Town Highway Class 2 Roadway Program, that allowed for the town to be able to pave an extensive section of Walker Mountain Road that was in desperate need. The town was also awarded a Town Structures grant, to aid in the replacement of a box culvert on Creek Road. This project will be getting under way this construction season (2023).

Clarendon purchased a new Linkbelt Excavator. It can be seen around town working on various projects. The road crew continues to advance our ditching, road surfaces, and culverts to get them up to MRGP (Municipal Roads General Permit) compliance.

In addition to the State funding Clarendon received, the town also received ARPA (American Rescue Plan Act) money; a federal assistance award that was put in place to bring towns through the COVID-19 crisis and replace lost revenue. Clarendon elected the "standard allowance" which gave the town more flexibility in how the funds could be spent. In fiscal year 2022, the town received \$360,654.26.

The Select Board held many meetings over the course of fiscal year. During several meetings, there was discussion about the town creating an Inclusion Statement. A committee was formed, and eventually an Inclusion Statement came together. A copy of the statement can be found on the town's website (clarendonvt.org).

Firework permitting continues to be handled by the Select Board. Permit requests should be made 15 days prior to the event. The Select Board reviews permits at their meetings, so please plan accordingly.

The Select Board worked hard on the town budget and announces a minimal increase to the municipal portion of it. The Board encourages citizens to participate in the budget process as well as all other town business. Meetings are posted at the Town Hall, Post Office, and on the town's website.

All requests for agenda placement must be received no later than 1:00 p.m. on the Thursday preceding the scheduled Monday meeting to allow time for preparation of the agenda and time for Select Board members to prepare for the meeting. *Individuals not on the agenda must wait until completion of all agenda items unless invited by the Selectboard Chairman to speak.*

Clarendon Listers Report

The primary role of the Listers is to maintain a fair and equitable Grand List for the Town for purposes of taxation. Annually property owners have the right to grieve their valuations for the upcoming tax year by submitting a request to the Listers by the designated due date each spring.

Property Tax bills reflect ownership and status as of April 1st. Updates to the Grand List include changes based on additions or new construction, demolitions or removals that the Town has been notified of, property transfers, additions or reductions to acreage, disabled veterans status, and changes within the State's Current Use Program. Addresses of record are updated throughout the year. It is inherent upon property owners to notify the Listers when mailing addresses change. Tax due dates are the same whether we have your current address or not.

Town residents should make their Homestead declarations each year by the April 15th due date in order to avoid late filing penalties.

Throughout the year the Listers provide copies of tax bills and property descriptions (Lister Cards) on request. To the extent we can we assist people with various requests concerning ownership of specific parcels or what the parcel consists of. The Listers do not do deed research or provide legal advice.

The Town Tax Maps are maintained by the Listers with a new set being updated as of January 1, 2023.

The Town Clerk is required by statute to be the receiver and recorder of the Town's Land records. Other statutory responsibilities include maintaining the voter checklist in conjunction with the Board of Civil Authority, as well as being the presiding officer for elections. The Town Clerk is the clerk for the Board of Civil Authority and the Board of Abatement.

All records in the town office are open for public view during business hours.

The Town Clerk's Office is responsible for:

- Administering all local and state elections
- Recording of land records – deeds, mortgages, etc.
- Recording town proceedings
- Issuing Marriage licenses
- Filing and indexing of all vital records - births, deaths & marriages
- Filing and indexing liens, surveys and an assortment of other documents
- Issuing dog licenses
- Issuing motor vehicle renewals
- Voter registration
- Notarizing documents
- Preservation and restoration of land records and vital records
- Transfer Station ticket sales
- Issuing Green Mountain Passports

Voters may register to vote and request an absentee ballot through the Town Clerk's Office or through the Election Management System online (see below).

By using the My Voter Page (MVP), a registered voter can check registration status, get directions to a polling place, see polling place hours, view a sample ballot, request and track an absentee ballot and much more by logging in at: <http://mvp.vermont.gov>

The absentee ballot must be returned, either to the Town Clerk's Office or at the post office by Election Day.

Please Note: All dogs six months of age and older must be licensed annually on or before April 1st. This year it will be due by **Saturday, April 1, 2023**. A current rabies certificate **must** be provided at the time of licensing, 20 V.S.A. 3581.

If a dog is acquired after April 1st, it must be licensed within thirty days. If it is a puppy, it must be licensed within thirty days of turning 6 months of age.

If you cannot come to the office, you may send the rabies certificate, a check payable to 'Town of Clarendon' and a self-addressed, stamped envelope to the **Clarendon Town Clerk, PO Box 30, Clarendon, VT 05759** and the 2023 license will be mailed to you.

The Town Clerk's office is open Monday – Thursday 10-4.

Bailey Memorial Library Annual Report 2022

Bailey Memorial Library continues to provide current reading materials and services to the residents of Clarendon and beyond. Materials and services include fiction and nonfiction books and DVDs for adults and children, audiobooks for adults, snowshoes for adults and children and passes for Vermont state parks and several Vermont museums that offer reduced or free entry fees. \$213 was added to our budget this year from the raffles and the town wide sales. We thank everyone for their support.

Clarendon resident Barbara Smith, our Library Director, oversees the day-to-day workings of the library and supervises Mary Doyle, who works Tuesday evenings and Saturdays. The Board is very grateful for the work all staff do to keep the library open and running smoothly.

All residents of Clarendon are entitled to a library card. Out of town borrowers can purchase a card for a nominal fee. To view and search the library's collection, visit the library's website at **baileylibraryvt.wordpress.com** and click the link for library catalog. The user name is Bailey and no password is needed. From there, you can search for titles, authors or subjects of interest to you.

This year the library has been able to purchase new equipment and books through grants from ARPA, American Rescue Plan Act of 2021. Applications were made through the Vermont Department of Libraries. The first grant for \$3471.45 was used to purchase 3 updated computers, a printer, a study chair, Microsoft Office, and books. The second grant of \$1179 allowed us to purchase 2 air purifiers, an iPad and a bench for the porch.

The library has two online computers for public use and free wireless access for patrons and others. Comcast provides free Internet service to the library. Many users come to the library to take advantage of our free Wi-Fi service, which can be accessed outside of the building as well as inside. Users can print resources and email and make copies of documents for a small fee.

The Board of Trustees and the library staff thank all of the people who make donations of books to the library. If these books meet our needs, they are added to the library collection. Others may be sold in the on-going book sale at the library.

The Library is looking for volunteers to serve on the Board of Trustees. This requires a small time commitment, mostly attending the Board meeting the second Tuesday of each month and bringing new ideas. Please call the library or a board member if you are interested in becoming a member of the board.

The Historic Society of Clarendon has had another successful year documenting our history and making it readily available via our website <http://clarendonvthistory.org/>, our Facebook page <https://www.facebook.com/groups/clarendonhistorical>, and our YouTube channel <https://www.youtube.com/channel/UCdsb59xBBtYulvwnat97k6A>. Regular monthly meetings resumed last March as we entered into a new post-pandemic normal. Meetings are held every 3rd Monday at 6PM at the Community Center, except for Nov./Dec. due to busy holiday schedules.

Our website has surpassed 2,200 entries spread across 26 collections: Artifacts, Bridges, Buildings & Enterprises, Cellar Holes, Cemeteries, Churches, Documents, Events, Farms & Barns, Homes, Letters, Mysteries, Music, Poetry & Art, Newsletters & Presentations, Oral Histories, People, Places, Quarries & Mines, Railroads, Reference Materials, Schools, Soldiers & Wars, Town Reports, Vermont Life Magazine, Writings of Mabel T. Herrick, and YouTubes.

Given the huge amount of information contained on the website, the Keyword Search feature under Collections can quickly help you find what you are looking for.

Our Facebook group continues to be successful as a mechanism for ongoing interaction with historic society members and interested parties. A new entry is posted every day featuring material from our website or presenting new material that itself is subsequently added to our website.

We do not have a physical home yet but we continue to accumulate maps, books, photos, postcards, and various documents and objects of historical interest to Clarendon. Donations of materials are greatly appreciated as are short term loans for purposes of scanning or making copies.

Last summer Lois Wilder Kerwin and Anne Frost donated approx. 300 letters from the 1830's – 1870's associated with Clarendon's Willson family and an equal amount of documents, including original property deeds as old as 1779. Many of these letters and documents have been transcribed, added to the website, and featured on the Facebook page. The rest are in process. They are incredibly informative of life and events in that era. We are immensely grateful to Lois and Anne for this donation.

CLARENDON CEMETERY COMMITTEE REPORT

Two thousand and twenty two was a busy year for the members of the cemetery committee. The first of three large projects was accomplished in May. The Southard and Benson memorials in the Flats Cemetery were repaired, the bases were reset and spires that had been on the ground lifted back in place with the help of Chris Fish from Pittsford who volunteered his time and small excavator for this job. In July, with the help of Brad Gilman and his bucket tractor, the memorial for Sarah Smith in the Old Marsh Cemetery was repaired. This also included resetting the base, rebuilding the lower parts of the memorial, and lifting the spire in place. In October, the Hill's plot project in the West Clarendon Cemetery (Chippenhook) was tackled. A section of a 140+ year wrought iron fence was removed so we could get a tractor in to lift the three stones back in place once those bases were reset. Along the way, well over a 100 different headstones were repaired, reset or straightened. These projects can be seen on the Clarendon Historical Society website.

Members of the Vermont Old Cemetery Association (VOCA) worked in July at the Flats Cemetery and in September at the Spafford Cemetery.

On November 1st, a set of rules that had been accepted by the Selectboard were put in place. These were posted to the Clarendon web site and on the new Clarendon Facebook page. The majority of comments have been positive including comments from a funeral director.

In August, John Romano reached out regarding repairing and restoring the Walker-Crary Cemetery, also known as the Haven Hill Cemetery on Old Orchard Place. This cemetery is the resting place for approximately 38 people including John's great (5x) grandmother. Upon visiting the site with John and discussing what he wanted the cemetery to look like, we settled on a long unused cemetery that was still maintained. After John had the brush cleared away we set out to repair and reset stones, assisted by Tom Giffin, the president of VOCA and Carla Peck.

The year concluded with the Old Marsh Cemetery being declared restored. With a couple of day projects left to do in the Spafford and Clarendon Flats Cemeteries, the majority of our time in 2023 will be the start of repairing the West Clarendon Cemetery. A VOCA work day has been scheduled there on June 24th. There will be jobs from light scrubbing to handling a shovel and pry bar.

Discussion has also started on replacing the fences running across the front of the Old Marsh and Clarendon Flats Cemeteries and having signs made for those cemeteries along with the Spafford and West Clarendon Cemeteries. A large tree has been scheduled for removal in the Spafford Cemetery this coming Spring.

If anyone is willing to assist in restoring the town's cemeteries on either the VOCA work day or any day throughout the season, or you have a small piece of equipment and would like to make yourself available for a specific project, contact us through the town office. Many hands make light work, but hydraulics is even better.

From 1983 to the end of the fiscal year, Regional has responded to 250,700 ambulance calls. This past year, ending June 30, 2022, the service responded to a total of 10,609 ambulance calls in our 12 communities and an additional 101 "Medic One" paramedic intercept calls. We are proud of our accomplishments and look forward to continuing to serve the public.

This past year, COVID-19 continued to play a role in the activities at R.A.S. The safety of our patients and staff remains our number one priority. We diligently follow CDC and State Guidelines. Our motto, "Serving People First with Pride, Proficiency and Professionalism" is demonstrated by our employees' commitment to continuing EMS training. Each year our employees have specialized training in Critical Care Paramedicine, Best Practices in Decontamination/Disinfectant, ALS, BLS, Prehospital Advanced Trauma and Medical Life Support, Pediatric Advanced Life Support, Emergency Vehicle Operations, Bloodborne Pathogens and a variety of continuing education programs. Our professional staff is extremely capable and dedicated.

Monthly C.P.R. classes are taught at Regional Ambulance. Last year, through the R.A.S. American Heart Association Training Center, 1,795 people were trained in C.P.R. Tours, lectures, demonstrations and C.P.R. classes are available for the general public. Child Car Seat inspections are Wednesdays at the Regional Ambulance building by appointment. We completed 84 child car seat inspections this past year.

The public is encouraged to visit and talk to our employees at our Stratton Road facility. Please feel free to contact Jim Finger, Chief Executive Administrator, or your Representative, if you have any questions concerning the service.



Brief Description of RSVP & The Volunteer Center

RSVP and The Volunteer Center is a volunteer program for people of all ages who want to meet community needs through volunteer service. RSVP/VC considers volunteering to be a key solution in responding to Rutland County's most pressing challenges. Needs are met in critical areas such as human services, elder care, health care, education, literacy, and the arts. RSVP/VC involves individuals in service that matches their personal interests and makes use of their varied life and professional experiences. RSVP/VC enables people to contribute to their communities while enjoying the personally satisfying and rewarding experience that community engagement offers.

RSVP also offers several free "Signature Programs" that benefit residents. These include RSVP Bone Builders, an osteoporosis prevention program which provides strength and balance exercise classes offered twice per week at many locations in Rutland County; RSVP Rutland Reads a children's literacy and mentoring program; RSVP Veterans Connections Program, a program designed to reduce social isolation in veterans; and RSVP Operation Dolls & More, which distributes over 15,000 new and restored items to children. Last year approximately 30,552 items were distributed by RSVP Operation Dolls & More to 38 partner agencies and an estimated 1,800 children. We also partner with AARP to provide free income tax return services to low-income residents of Rutland County. Locally, RSVP/VC is the largest program of coordinated volunteer services serving the people of Rutland County with 607 volunteers. From July 1, 2021, to June 30, 2022, RSVP/VC volunteers provided 101,761 hours of community service. The cost benefit to the communities of Rutland County in terms of cost of services provided equals \$3,047,741.

Services Provided to Clarendon Residents

In FY'22, Clarendon residents took advantage of RSVP programs such as free income tax return preparation, and our free Bone Builders classes. Clarendon RSVP volunteers donated their services to the following non-profit organizations: Community Cupboard, Gilbert Hart Library, and the AARP Tax Program. Some of the services Clarendon volunteers provided include food shelf assistance, free income tax preparation services, and leading RSVP Bone Builders classes.

The monies we are requesting this year will be used to help continue to defray the financial impact of COVID-19 on our organization along with the cost of providing volunteer placement, support, transportation, and recognition. Report of Services for Town of Clarendon

The Vermont Association for the Blind and Visually Impaired's 2022 Fiscal Year saw the organization's continued success in adapting to the ever-evolving COVID-19 pandemic.

This is an excellent time for VABVI not only to reflect on changes from the past several years, but also set goals based on an increased number of clients and schools and other public environments being re-opened. As projected in recent years, the aging population of our state promises a continued increase of clientele. We believe that the innovations developed as a result of the pandemic are a demonstration of VABVI's ability to accommodate increased demand in even the least ideal circumstances. Moving forward, it is exciting to imagine the strides we will make in enabling blind and visually impaired Vermonters to be more independent, develop adaptive skills, and improve their quality of life.

SMART Device Training Program: The SMART Device Training Program has served a higher number of Vermont seniors each year we've offered it, especially because of the COVID-19 pandemic. Due to social distancing protocols, technology has become essential for our clients to be able to live independently while remaining social and connected to their communities. Clients who received technology training prior to COVID-19 have reported that the skills learned in this program have been invaluable throughout the pandemic, and clients who sought out our help during the pandemic will continue to use SMART Technology in the future.

PALS (Peer-Assisted Learning and Support) Group: PALS Groups, held throughout Vermont, are monthly meetings where members share coping strategies and discuss the practical, social and emotional challenges of vision loss. While PALS groups have been operating remotely via Zoom and telephone over the past two years, arrangements are being made to resume in-person meetings by the end of 2022.

HAPI (Helping Adolescents Prepare for Independence): The HAPI program enables Teachers of the Visually Impaired and Certified Vision Rehabilitation Therapists to work one-on-one with students to practice daily living skills.

IRLE Summer Camp (Intensive Residential Life Experience): IRLE camp helps VABVI students develop social skills, meet fellow visually impaired peers, learn independent living skills, and improve self-advocacy skills. This year's camp took place in Upstate New York at Six Flags Great Adventure Lodge and nearby attractions such as rail biking and bowling.

In FY22 VABVI served 1,145 clients in the state of Vermont, including 1 student in Clarendon and 87 adults and 28 students in Rutland County.

Dear Board of Selectpersons, Town Clerks and Auditors:

On behalf of the Vermont Rural Fire Protection Task Force, I am writing to request your support for the Vermont Rural Fire Protection (RFP) Program, formerly called the Dry Hydrant Grant Program. The RFP program helps Vermont communities protect lives, property, and natural resources by enhancing fire suppression resources. Program Manager and Engineering Technician Troy Dare helps local fire departments identify appropriate sites for dry hydrants and other rural water supply systems, designs installations, and finds financial resources to support the costs of construction. During the **25+ years** of the program, almost **1200 grants** totaling over **\$2.6 million** have been provided to Vermont towns for the installation of new rural fire protection systems, as well as for replacements and repairs.

The Rural Fire Protection Program is managed by the Vermont Association of Conservation Districts (VACD). VACD is the membership association of Vermont's fourteen Natural Resources Conservation Districts, whose mission is to work with landowners and communities to protect natural resources and support the working landscape throughout the state.

The annual expense of the Rural Fire Protection Program in FY 2022 was **\$285,901**, of which **\$165,422** was paid in grants to support the construction and repair of **27 rural fire protection projects** throughout Vermont. The remaining budget covered site assessments, project design and program oversight. Most of our funding comes from the Division of Fire Safety of the Vermont Department of Public Safety, through annual appropriations by the Vermont Legislature. In addition, the program receives support from the US Forest Service through the Vermont Department of Forests, Parks and Recreation. Unfortunately, these grants do not completely cover the costs of the program. Therefore, we are respectfully requesting that you include a \$100 appropriation in your town budget to support the Rural Fire Protection Program. In FY 2022, we received over **\$9,000** in town appropriations from **over 90 towns**. We are deeply grateful for your ongoing support.

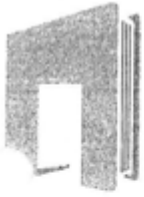

Report to the Citizens of Clarendon

This report describes the services that the Southwestern Vermont Council on Aging (SVCOA) provided to elders in Clarendon during SVCOA's most recent annual reporting period of 10/1/2021 through 9/30/2022.

Nutrition Support

The Council helped provide 4,715 meals that were delivered to the homes of 26 elders in your community. This service is often called "Meals on Wheels". In addition, 5 Clarendon elders came together at a luncheon site in your area to enjoy a nutritious meal and the company of others; 75 meals were provided.

Additionally, SVCOA provided 10.25 hours of one-on-one nutrition support, including nutrition assessments and resource connections and referrals, to 11 residents of Clarendon.

Case Management Assistance:

SVCOA case management and outreach staff helped 17 elders in your community for a total of 99.75 hours. Case managers meet with an elder privately in the elder's home or at another agreed upon location and assess the elder's situation. They will work with the elder to identify needs and talk about possible services available to address those needs. If the elder desires, the case manager will link the client to appropriate services, coordinate and monitor services as necessary, and provide information and assistance to caregivers. Case managers also help elders connect with in-home assistance programs, including a program called Choices for Care. This program is especially helpful to frail elders facing long term care placement who still wish to remain at home.

Other Services and Support:

1) "Senior Helpline" assistance at 1-800-642-5119. Our Senior HelpLine staff provide telephone support to elders and others who need information on available programs and community resources; 2) Medicare and health benefit counseling information and assistance through our State Health Insurance Program; 3) Legal service assistance through the Vermont Senior Citizens Law Project; 4) Information about elder issues and opportunities via various agency articles and publications 5) Nutrition education and counseling services provided by SVCOA's Registered Dietician; 6) Senior Companion support for frail, homebound elders; 7) Outreach services to elders dealing with mental health issues through our Elder Care Clinician. This service is provided in cooperation with Rutland Mental Health; 8) Transportation assistance; 9) Caregiver support, information and respite to family members and others who are providing much needed help to elders in need of assistance; 10) Money Management programs that offer either a volunteer bill payer or representative payee services to elders and younger disabled individuals.



Dear Citizens of Clarendon,

The Child First Advocacy Center (CFAC) serves as a central agency through which reports of suspected child abuse can be channeled for investigation and victim recovery. CFAC was established in 1995 and became a fully Accredited Member of the *National Children's Alliance (NCA)* in 2004. We share with NCA the passion to minimize the traumatic effect of child abuse upon the children and families of our community. CFAC is a non-profit organization serving Rutland County to assist families in the discovery, intervention, treatment and prevention of child sexual abuse, severe physical abuse and children affected by violence. We provide a safe comfortable environment for the forensic quality and child appropriate interviews, training for professionals and collateral referral services for victims and their non-offending family members. Our agency serves families of all socio-economic levels and is committed to providing quality services regardless of the ability to pay.

On behalf of the Board of Directors and the Child First Advocacy Center Multidisciplinary Team, we want to thank you for your continued support and dedication.

In calendar year 2022, The Child First Advocacy Center served 160 clients and 155 of their family members. **We were able to provide direct wrap around services and support to four (4) Clarendon families as they began their recovery from the effects of trauma.** In addition, we continue to provide community awareness and education at no cost, in an effort to provide adults with the ability to recognize, react and respond appropriately to child sexual abuse and increase each school district's ability to complete the legislatively mandated ACT 1 initiative also known as Child Sexual Abuse Awareness training for Educators, Community Members and Student's grades K-12.

The Child First Advocacy Center is requesting funds in the amount of \$800 to continue our efforts in supporting families in your community. Please feel free to contact me if you have any questions or need further information.

Greetings to the Town of Clarendon:

The Rutland County Court Diversion and Restorative Justice Center (doing business as Rutland County Restorative Justice Center) is a 501(c)(3) non-profit agency (EIN 03-0279824) that is requesting to be included on the Clarendon town appropriation for \$500. We greatly appreciate the town's consideration and hope to work together in fiscal year 2024.

Our agency strives to make Rutland County a healthier and safer community for all residents. Our mission is to engage community members in responding to the needs of crime victims, the community, and those who violate the law, holding the latter accountable in a manner that promotes responsible and restorative behavior. Our programming is designed for a range of individuals, such as at-risk and truant youth and those with mental health and substance use treatment needs. We focus on fostering accountability, repairing the harm caused by crime, skills development, and connection to treatment and education.

In fiscal year 2022 the RCRJC's seven programs served 331 participants who chose community support and accountability over the traditional criminal justice system. In FY 22 RCRJC helped: 119 people connect with volunteers to address the harm they caused in the community through restorative panels; 29 youth complete the Youth Assessment and Screening Instrument (YASI) to determine risks and needs of the youth; 99 adjudicated, at-risk, or truant youth work to improve school/appointment attendance, therapeutic treatment engagement, one-to-one support and community-based visits, case plan and court hearing support, coping skills, time management, and community and family connections; 140 youth gain skills through our five-week social and emotional intelligence (SEI) course; 54 youth aged 16-21 participate and complete the Youth Substance Awareness Safety Program that identifies and educates youth about dangers of substances for which they received varying violations; 33 people seek substance misuse treatment and 55 people work towards reduced fines, violation issues, and reinstatement of their driver's licenses.

Our proposed language for the ballot would be:

Article: Shall the Town of Clarendon vote to raise, appropriate, and expend the sum of \$500.00 for the support of Rutland County Restorative Justice Center to provide services to residents of the Town.

Our agency has served Rutland County for decades, and we look forward to continuing to meet the needs of our community members for many more years to come. We sincerely appreciate your support.

As in previous years, the Rutland Natural Resources Conservation District (RNRCD) is seeking a contribution from District Towns to support our many conservation programs/projects. We are a non-profit organization servicing the Upper Otter Creek watershed, dedicated to providing on-the ground conservation assistance as well as promoting public awareness and appreciation for the value, responsible use, development, and conservation of our natural resources. We respectfully request a \$250.00 contribution to support our 2023 program.

With funding through the State's Clean Water Initiative Program and Lake Champlain Basin Program, last year, among other services, the District:

- Coordinated the removal of a berm in the Cold River Watershed in the Town of Clarendon, to restore floodplain function. The berm was created after the floods of the 1970's. Removal of this berm addresses sediment and nutrient loading in the Cold River by allowing it to access the floodplain, thus reducing flood heights and slowing velocities which reduces erosion and provides ample storage of sediment within the river corridor.
- Received a final design for a Stormwater Best Management Practice (BMP) located within the parcel boundaries of the Wallingford Elementary School. The design was completed by Watershed Consulting Associates, LLC.
- Received a final design for removal and site restoration of Youngs Brook dam located in West Rutland. The design was completed by SLR International Corporation.
- Is working with the Town of Proctor to develop a Stormwater Master Plan (SWMP). The overall objective is to provide the Town of Proctor with a strategic approach for meeting stormwater management needs in the Otter Creek watershed, to address pressing water resource concerns in a cost-efficient and targeted manner.
- Provided the City with a Phosphorus Control Plan (PCP). The plan was completed by Fitzgerald Environmental Associates and will help the City to achieve the percent phosphorus (P) reduction target for the Otter Creek segment of Lake Champlain.
- Worked to develop and prepare projects for future design and implementation throughout the District. These projects have been identified in Stormwater Master Plans or other assessments/reports.

We would greatly appreciate your support. We are not able to personally petition each town within the District, so we ask that this contribution be included in the Select Board's 2023 budget. Please let us know if you need an invoice.

TIME TO SPAY AND NEUTER YOUR CATS AND DOGS!

The VT Spay Neuter Incentive Program (VSNIIP), under the VT Department of Children & Families, is administered by VT Volunteer Services for Animals Humane Society. **Funded by a \$4.00 fee added to the licensing of dogs, this monetary resource is limited by the number of dogs licensed, which is required by law at six months of age.** By statute, unlicensed dogs can be confiscated. Puppies and kittens can have the first rabies vaccination after 12 weeks of age. If unable to schedule an appointment with a veterinary office for this vaccination, Tractor Supply Stores hold monthly clinics. Call for their schedules. After the vaccination, contact your town clerk and provide proof of the rabies vaccination to license your dog.

Rabies IS in Vermont and it IS deadly.

Licensing a dog:

- 1) Helps identify your dog if lost.
- 2) Provides proof your dog is protected from rabies in the event your dog is bitten by a rabid animal {but still needs immediate medical attention}.
- 3) Protects your animal if they bite another animal {or person – which could result in the quarantine of your dog or possibly euthanized in order to test for rabies if not currently vaccinated}.
- 4) Pays for this necessary program addressing the population situation in VT.

For a VSNIIP Application and a List of Participating Offices, send a 10" SASE: Self-Addressed, Stamped Envelope to: VSNIIP, PO Box 104, Bridgewater, VT 05034. Note if your request is for a cat, dog or both. Once fully completed, please mail it back. If approved, you will receive a Voucher and instructions.

The cost for the surgery to you is only \$27.00, providing there are no complications. Fellow Vermonters pays the balance of your account from funds collected at the time of dog licensing. Please be SURE your cat or dog is completely flea and tick free **before** the visit, or you will be charged for treatment. Pain medication is highly recommended **after** the surgery, but would be your responsibility. It is also wise to buy an "E" collar to avoid having sutures pulled out. These are the right choices!

Animals left UN-neutered are more prone to forms of cancer.

Thank veterinarians for their participation in this important program. **These altruistic veterinarians are the backbone of the program!** If your veterinarian is not a participant, please encourage them to join. Several veterinarians have retired, leaving a reduced number of participating offices. VSNIIP offices are accepting less reimbursement than what they would usually charge for their services. We NEED them :) Let them know you appreciate the difference they have made in our state over the years when euthanasia was the routine means of animal over-population control. Those days are behind us ~ let's keep it that way!
