BOARD OF STEOPATHIC PHYSICIANS & SURGEONS
UNAPPROVED MINUTES
June 12, 2008

1. The meeting was called to order at 10:30 a.m.

Board members present: Howard S. Jonas, D.O., Chair; William Cove, D.O., Vice-Chair; John Welch, Esq.; and Mary C. Mazzariello. Absent: John Peterson, D.O.

2. The Chair called for approval of the Minutes of the June 28, 07 meeting. Ms. Mazzariello made a motion, seconded by Dr. Cove, to approve the Minutes of the June 28, 2007 meeting as presented. Motion passed unanimously.

Dr. Jonas discussed the need to amend the statute to include physician's leaving Vermont or retiring. For public protection, the physicians should include an notice in local newspapers, send a letter to all of his/her patients, and enclose a release form to the patients so that the physician may release the patient's record to a new physician. He said the provisions should include a seven year retention of records and a 30 day minimum notice.

OS01-0807-Report of Concluded Investigation-The Board reviewed the Report of Concluded Investigation. Based on the information provided, Mr. Welch made a motion, seconded by Dr. Cove, to accept the Investigative Team's recommendation to conclude this matter without charges. Motion passed 3-0. Dr. Jonas, Investigating member, did not participate in the vote.
