The Board reviewed the e-mail from Aaron Fuller regarding the Agency of Natural Resources' ***Proposed Amended Wastewater System and Potable Water Supply Rules, Water Supply Rule, and Indirect Discharge Rules***. Members shared concerns articulated by Mr. Fuller that the proposed rule appeared to vest wastewater system designers with authority to locate boundaries in excess of the exemption at 26 V.S.A. § 2503(b). Mr. Short made a motion, seconded by Mr. Diebold, to submit a comment on the proposed Rule expressing this concern. Motion passed unanimously.
