2004 SELECTMEN'S LETTER

The year has passed very quickly, but there are always challenges that loom before us.

First of all, we wish to acknowledge the loss of our long-time employee, Larry Sargent. The road workers are out there when no one else wants to be there or SHOULD be there. Larry was no exception to that. His family waited for him many times through Holidays when he was "out on the roads". We remember him fondly and with gratitude. We miss you, Larry!

We have been thankful to have found Larry Bovey, who was hired this summer. He comes to us with much experience. We welcome him!

The Town has contracted with Steven Wright Appraisals for our reassessment. In all likelihood, an informational meeting will be held for the public beforehand. Citizens will be notified before any visit to reassess. Hopefully, this will progress smoothly and work for everyone.

We continue to look for solutions to problems with space at the Town Offices. We have a Town woodlot (approx. 31 acres). Should we sell the land? Should we look at timber? We have a Town gravel pit (33.4 acres). Should we sell this? Should we buy something else, if possible, to give us the much needed space?

The dump, unfortunately, is consistently misused. We have sent letters to everyone and for a while, it got better, but eventually things got out of control again. If we lock the gate, people throw garbage on the ground and over the fence. Some of this is household garbage and some of it is definitely not. This has to be cleaned up and sorted. Contaminated loads could cost the Town their right to dispose of all garbage. This has become a costly, complicated problem.

We continue to deal with the speed ordinance. It is in effect, as of December 27, 2004.

We also continue to explore the issue of health insurance for our Town employees. The full-time employees feel that keeping their present policy is more important to them and their families than receiving any increase in salary. We believe that this is a fair compromise. Therefore, our budget provided for maintaining the present health insurance policy, but does not provide for the usual cost of living increase.

In September, 2004, James Reddy of OMYA Industries Inc. sent the Town a letter informing that "they had made alternative plans to supply their customers from other locations, and as a result, had closed this project".

The dramatic rise in fuel rates has raised havoc with budget figures. This is out of our control, as it is with everyone else.

This past Fall we purchased a 2005 International Model 7600 Truck. We sold a grader and sanders, which allowed us to pay off the loader.

We would note that the 2004 voter turnout was extremely high for the Presidential vote. We added nearly 100 new voters to the checklist last year. It was encouraging to see lots of young first-time voters.

Once again, we wish to thank the citizens for their assistance, and hope any problems that arise can be worked out. We can be only as effective as the people make us. We are grateful for their input.

The legal voters of the Town of Danby are hereby warned and notified to meet at the Town Hall, Danby Four Corners, Vermont, on Monday, February 28, 2005 at 7:30 p.m. to transact the following business:

- Article 1. Will the voters accept the Town Report?
- Article 2. Will the Town vote to have taxes paid to the Town Treasurer on October 12, 2005?
- Article 3. Will the Town authorize the Selectmen to borrow money in anticipation of taxes not to exceed the previous year's budget?
- Article 4. To transact any other business proper to come before this Town Meeting.

To be voted on by Australian Ballot on March 1, 2005:

- Article 5. To elect all Town Officers for the ensuing year
- Article 6. To see if the Town will vote a budget of \$918,776.00 to meet the expenses and liabilities of the Town, and authorize the Selectmen to set a tax rate sufficient to provide the same.
- Article 7. Shall the Town of Danby authorize the Selectboard to appoint the Office of Constable as opposed to electing Constables? (Pursuant to 17 VSA 2561a.; Constables; appointment; removal)
- Article 8. Shall the voters of the Town of Danby vote to allocate the sum of Twenty-five Thousand Dollars (\$25,000.00) per year for the next eight years (Two Hundred Thousand Dollars (\$200,000.00) in total) to be spent for the lease/purchase of a new fire truck for the Danby-Mt. Tabor Vol. Fire Department?

Article 9. To see if the Town will vote to fund from tax revenues the following organizations:

DANBY-MT. TABOR VOL. FIRE COMPANY

During 2004, the Danby-Mt. Tabor Vol. Fire Company responded to 44 calls, including structure fires, motor vehicles accidents and fires, rescue squad assistance, brush and grass fires, carbon monoxide detection, mutual aid calls from surrounding towns, and alarms.

The new rescue team which was created along with East Dorset went into effect on January 1, 2004 has been successful with both departments. In conjunction with this, we have made a commitment to purchase East Dorset's rescue truck with a 2-year financial agreement as they had updated theirs. With Homeland Security Grants we have been able to equip major items on the truck to serve Danby and Mt. Tabor more efficiently. With any call for accidents or rescue calls, in either Danby and Mt. Tabor, and also East Dorset, both departments respond.

Homeland Security Fund Grants we received for 2004 in the amount of \$60,408.91 designated that we purchase specific items eligible under the grant. We were enabled to purchase a thermal imaging camera, three SCBA air packs, five hand-held radios, two mobile radios and exterior antennas, hydraulic pump, jaws of life equipment for extrication at accidents, a portable 25hp water pump, chain saw with carbon tip blade, a communications repeater which is under construction for our radio frequency. This repeater is at Burr and Mary Sprague's residence on Colvin Hill, along with the paging antenna previously installed. Many thanks to their generosity for letting us use their property.

On the ballots for both towns, you will find a request for a sum of money to help us purchase a new pumper truck. This would be under an eight-year program in our truck replacement fund. The basic truck we are investigating has a 1250 gal. pump, 1,000 gal. water storage tank, with foam capability. It is also a four-wheel drive vehicle. At this time, we have an estimate of \$206,000.

We are asking Danby for \$25,000 a year for eight years, and Mt. Tabor for \$6,000 for eight years. If this does pass, this would become a lease purchase. The longer we wait to order a truck, the cost always increases for a vehicle. Our present pumper is 30 years old, and we feel we have to start some kind of program to keep giving the towns good service.

Thank you all for supporting us in the past. Our Department is dedicated to the people we serve, and the safety of the firemen.

There has been a much-needed addition to the Lister's Office. The old copier has been replaced with a basic printer/copier connected to the computer for printing out the tax bills more efficiently. The printer/copier has also come in handy for all the copying of the parcels we've had to do for the proposed upcoming reappraisal.

As proposed, Act 68 went into effect, but not without its drawbacks, of which there are many. It certainly created more work and confusion for all towns. It most definitely was not the answer to correct our Common Level of Appraisal (CLA). Ours dropped from 79% to 72%.

Hopefully, the proposed townwide reappraisal will help us to get our CLA above the 80% reappraisal by the State.

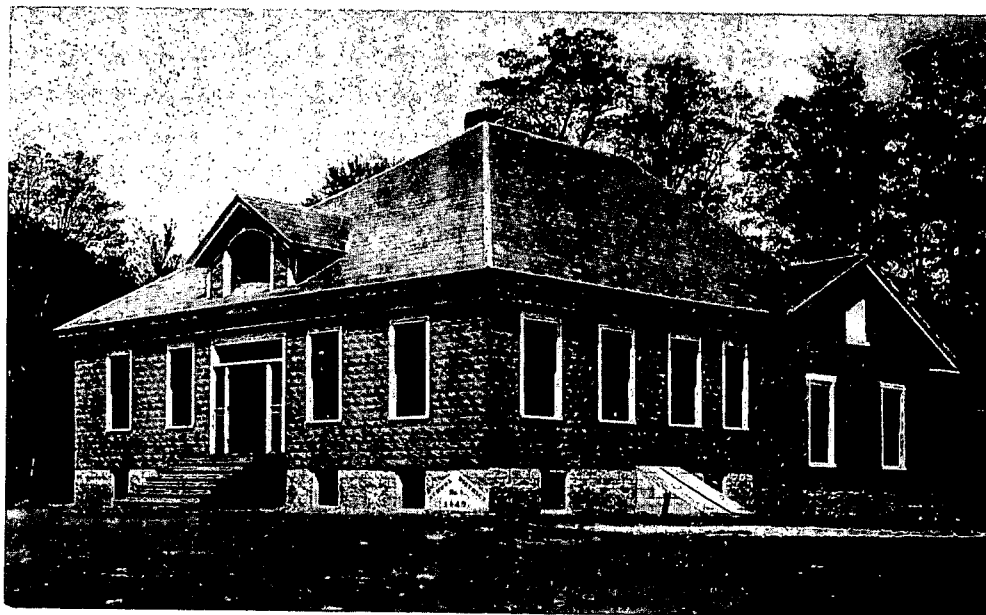

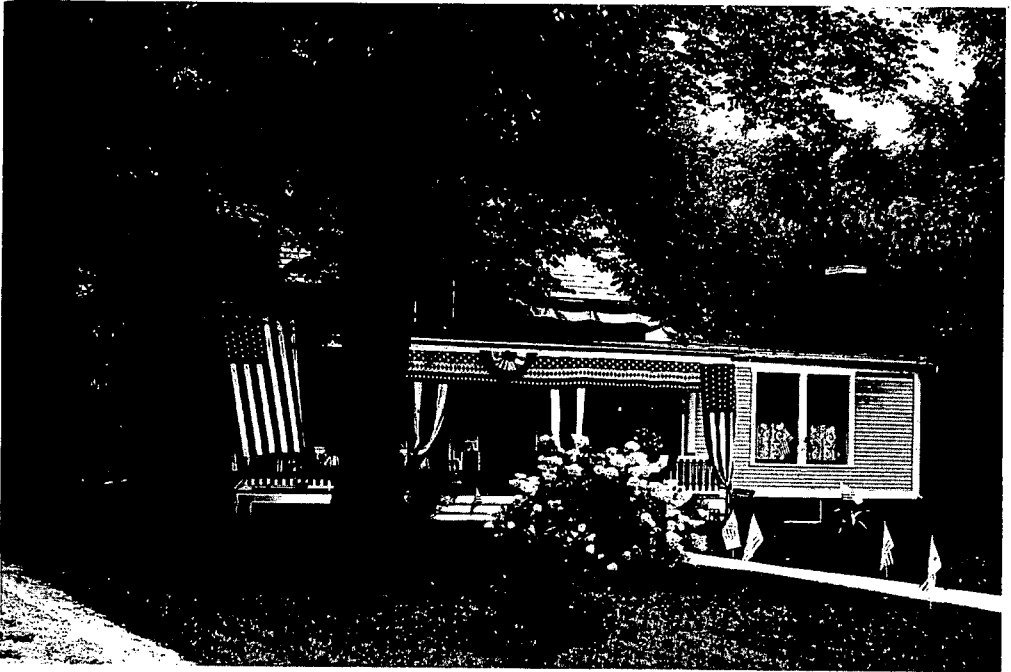

Be sure all vaccinations are up to date, since all dogs **MUST** be vaccinated against rabies before registration. For the safety of your pets and yourself, please vaccinate all of your dogs. Cats are also at risk, so please vaccinate them as well.

The dog's first vaccination only lasts for one year. All following vaccinations last for two years, regardless of the dog's age.

To register a dog as a neutered male or spayed female, a certificate signed by a licensed veterinarian stating that the dog has been sterilized must be shown to the Town Clerk.

There were 297 dogs registered in the Town of Danby in 2004. \$1.00 of each registration goes to the State of Vermont for rabies control.

INFORMATION REGARDING SNOWPLOWING

It is unlawful to plow snow across a Town Highway in a manner that leaves snow in the road. Violation of this law may result in a \$100 fine, plus the actual repair of any damage resulting from such obstructions of the highway.

It is unlawful to cause water or ice to run onto a Town Highway in such a way that it causes damage to the highway, obstructs traffic or creates unsafe conditions.

**Danby Board of School Directors
Report to Danby Voters
January 2005**

The Danby Board of School Directors submits a budget for FY 2006 of \$1,467,498 for your approval. These expenditures represent a decrease of 7.5% over the previous year's budget. The decrease is due to a combination of factors, some of which are due to planning and some are due to good fortune. The principle factors are listed below:

1. Danby is anticipated to have 13 fewer students at the high school level than the current population. There is now a relatively large class of 12 graders who will be replaced by a small group of entering 7th grade students. Since Danby pays tuition for all students grades 7 – 12, our budget is highly sensitive to student enrollments.
2. We have made reductions in the cost of transportation by reducing the number of buses we contract for from 5 to 4. While doing so, we have maintained the separation of younger students from the older student group and continued to offer transportation to the Manchester and Arlington schools to serve students with special needs and/or different school preferences. We are entering into a new contract and will replace existing buses with new equipment for the school year 2005-06. This expense item is continuously monitored because it is one area totally under our control.
3. There has also been examination and restructuring of the way special education and administrative services are provided. The bottom line is that the district has been able to increase the level of services for special education, early education and technical support for the school faculty and staff while keeping costs at or close to previous levels. These changes will benefit our students in the coming years as they receive greater emphasis on math and technology as part of the required curriculum.
4. The estimated tax rate is \$1.83, an increase of \$.01 over last year. The increase, while slight, is the result of the Common Level of Appraisal which fell this year to 72%. If our town reappraisal was completed for the 2006 budget year, and the Common Level of Appraisal was near 100%, our school tax rate would be \$1.32 rather than the \$1.83 estimate. This reinforces the need to complete the town reappraisal as expeditiously as possible.

The Board urges your support of this budget by voting to approve it on March 1, 2005.

The Board also urges the approval of funds to complete the reappraisal.

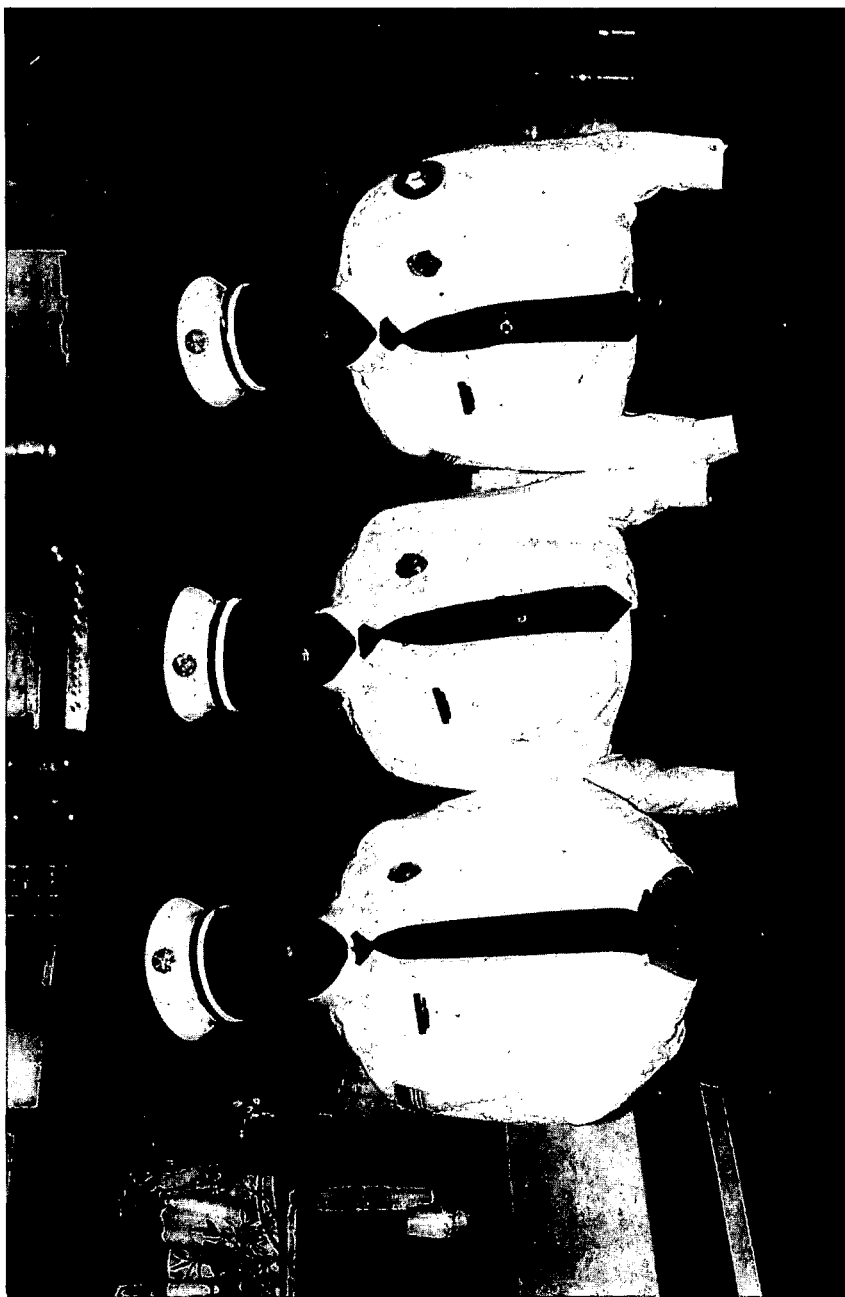
