1. The meeting was called to order at 9:07 a.m.
2. Dr. Grimes moved, seconded by Dr. Root, to approve the minutes of the June 10, 2022, as written. The motion passed unanimously.
3. 2022-175 – *In re: Hal Schmitter* – A hearing convened on the State's petition for summary suspension. The respondent was present with his attorney. The Board went into deliberative session at 9:43 a.m. and came out of deliberative session at 11:02 a.m. Dr. Grimes moved, seconded by Dr. Basiliere, to summarily suspend the respondent's license pending a full hearing on the merits. The motion passed unanimously.
4. Other
 - a. The Board discussed the possibility of awarding continuing education credits to members and attendees at board meetings. The Board reviewed a draft policy, provided comment, and will discuss further at its next meeting. Mr. Gilman noted that 3 V.S.A. § 136 establishes a uniform process for periodic evaluation of continuing education requirements and recommended using the § 136 process to vet the idea.
 - b. Enforcement Summary – Dr. Huitt noted that he has been assigned to two investigative cases and Dr. Root noted that he has been assigned to one.
 - c. ASPPB requested feedback on ASPPB Guidelines on Practicum Experience for Licensure. Dr. Huitt will review this and report back to the Board at its August meeting.
 - d. Recruitment by Behavioral Health Applications was noted. Dr. Huitt expressed concern about aggressive recruitment by online counseling platforms.
