If she is more interested in ongoing consultation in Vermont, however, the Board encourages her to apply for a full, regular Vermont license. It was noted to her that any consultation (or any forms of psychological services) require either temporary or full Vermont licensure.

- b. Summary of Supervised Practices spreadsheet—Other options for collaboration to complete this process are being considered.
- c. Audit—The Board continued the review of individuals audited. Dr. Wallis created a "Continuing Education Credit Audit Result" form which the Board accepts as a tool for helping with the audit process.

- a. Roger Peterson, Director of Antioch Psychology Department will be making a presentation to the Board on Competency Based Education at its May 14th meeting at 1:00 p.m.
- b. Dr. Lewis contacted the Vermont Psychological Association to invite them to speak with the Board regarding their request for the Board to co-sponsor and co-participate in the VPA Annual Meeting in November, 2010 to directly coordinate, plan and set an agenda for the Annual Meeting presentation.
