Analysis of Bill

- 1. Summary of bill and issue it addresses.** *Describe what the bill is intended to accomplish and why.* The bill is in part a follow on from the legislative study on DLC modernization done in 2015, which is setting the stage for a more through update to Title 7 in 2017. There are a number of definitional changes to different licenses issued by the Department including the creation of a new Destination Resort Master License. There is also a new provision to allow a licensee to deliver beer or wine during limited hours. The Department is tasked with making a rule related to this new delivery provision by 2017. The DLC and Department of Taxes are tasked with completing a study on how to allow the transfer of malt beverages between facilities owned by the same manufacture without having to pay taxes for the transfer. The bill also deals with appointment of liquor control board and the DLC commissioner.
- 2. Is there a need for this bill?** *Please explain why or why not.* Yes to cleanup some provisions, clarify others and add some other provisions.
- 3. What are likely to be the fiscal and programmatic implications of this bill for this Department?** Some additional work to create several new classes of licenses and drafting of new rules and a report.
- 4. What might be the fiscal and programmatic implications of this bill for other departments in state government, and what is likely to be their perspective on it?** No additional impact for other departments is anticipated.
