2 Senator Sirotkin moves that the bill be amended as follows:

3 First: In Sec. 1, in 20 V.S.A. chapter 176, in subsection 2678(b), by  
4 inserting a new subdivision (7) to read:

5 (7) Units rented for fewer than 90 days. The registration and fee  
6 requirements imposed in subsection (a) of this section do not apply to a unit  
7 that is rented for fewer than 90 days per calendar year.

8 and by renumbering the remaining subdivision to be numerically correct

9 Second: In Sec. 3, repeal, by striking out “2678(b)(7)” and inserting in lieu  
10 thereof 2678(b)(8)

11 Third: By adding new Secs. 14a and 14b to read:

12 Sec. 14A. VERMONT RENTAL HOUSING INVESTMENT PROGRAM;

14 In fiscal year 2022, of the amounts available to the State from federal  
15 coronavirus relief funds, the amount of \$2,000,000.00 is appropriated to the  
16 Department of Housing and Community Development to implement the

19 FY 2023 APPROPRIATION

20 In fiscal year 2023, of the amounts available to the State from federal  
21 coronavirus relief funds, the amount of \$10,000,000.00 is appropriated to the

1 Department of Housing and Community Development to implement the  
2 Vermont Rental Housing Investment Program created in Sec. 9 of this act.

3 Fourth: By striking out Sec. 15 in its entirety and inserting in lieu thereof a  
4 new Sec. 15 to read:

5 Sec. 15. EFFECTIVE DATES

6 (a) This section, Secs. 8-10 (Vermont Rental Housing Investment  
7 Program), and Sec. 14a (FY 2022 VRHIP appropriation) shall take effect on  
8 passage.

9 (b) The following sections shall take effect on July 1, 2022:

10 (1) Sec. 1 (DPS authority for rental housing health and safety; rental  
11 housing registration);

12 (2) Sec. 4 (DPS positions);

13 (3) Sec. 5 (DHCD positions);

14 (4) Sec. 6 (conforming changes to Department of Health statutes);

15 (5) Sec. 7 (DPS rulemaking authority and transition provisions); and

16 (6) Secs. 11–14 (revolving loan program; reports).

17 (7) Sec. 14b (FY 2023 VRHIP appropriation).

18 (b) Sec. 2 (administrative penalty for failure to register) shall take effect on  
19 July 1, 2023.

20 (c) Sec. 3 (repeal of registration exemption for housing provided as a  
21 benefit of farm employment) shall take effect on July 1, 2025.
