2. Is there a need for this bill? Yes, this bill is needed to update DMV fees.

3. What are likely to be the fiscal and programmatic implications of this bill for this Department?

TOTAL COST TO DMV: \$158,644.00
(see cost breakdown below)

DMV Procedures: Major work to DMV procedures. The DMV has identified at least 25 procedures that need changes.

- Procedure work required will be 20 Hours @ \$36.00 = **\$720.00**

- Training & Learning Aid materials: 10 Hours @ \$36.00 = **\$360.00**

Bulletins: employee, dealer, enforcement, inspection station, school bus, driver’s education, town clerks, and numerous others

- Cost will be 20 hours of work at \$36.00 per hour = **\$720.00**

Forms: Numerous changes to DMV forms. The DMV has identified at least 50 paper forms that will need changes, 10 template forms, and 10 electronic forms that will need changes. **Total cost of forms = \$55,688**

- Paper forms
 - 150 Hours of work @ \$36.00 = \$5,400.00
 - Printing of forms: \$40,000
 - Recycling old forms (cost of removal & cost of form): \$10,000
- Template forms: 3 hours of work @ \$36.00 = \$108.00
- Electronic Forms: 5 hours of work @ \$36.00 =- \$180.00

4. What might be the fiscal and programmatic implications of this bill for other departments in state government, and what is likely to be their perspective on it?

- Agriculture, Public Safety, Conservations, Fish & Wildlife, Children and Families will see an increase in the amount of money they get from DMV fees such as the Conservation plates, Building Bright Futures plates, and Snowmobile, motorboat, and ATV registrations.

5. What might be the fiscal and programmatic implications of this bill for others, and what is likely to be their perspective on it? (for example, public, municipalities, organizations, business, regulated entities, etc)

Motor Fuel Distributors: Will either lose the ability to claim 0.5% or the entire 1% of the gas and diesel shrinkage allowance. This could cause some fiscal implications to these companies.

6. Other Stakeholders:

6.1 Who else is likely to support the proposal and why?

Other state agencies and departments that receive money from DMV fees.

6.2 Who else is likely to oppose the proposal and why?

Vermont Residents – an increase in DMV fees may make people unhappy with the Department and government.

7. Rationale for recommendation: *Justify recommendation stated above.*

The DMV has numerous fees that have not changed in over 10 years. By making the fees consistent with today's market this will bring our fees on par with the current consumer price index.

8. Specific modifications that would be needed to recommend support of this bill: *Not meant to rewrite bill, but rather, an opportunity to identify simple modifications that would change recommended position.*
