c) The board may adopt rules, under chapter 25 of Title 3, to regulate the use by the public of lands acquired under this subsection, including the taking of wild animals on such lands or of 6 fish in such waters and close or open such waters or lands or any part thereof 7 to the taking of fish or wild animals. Such regulations shall be posted in the 8 affected areas.

(d) A primary goal of the Agency of Natural Resources, the Department of Fish and Wildlife, and the Fish and Wildlife Board shall be to the greatest extent possible to maintain, enhance and optimize hunting and fishing opportunities on any lands owned or acquired by the Agency and Department or lands regulated by the Department or Board.
