Hi again Darren,

Thanks for working out the Governor's UVM visit with Jason. A student government sponsored forum with the Governor is the perfect venue. The room isn't huge, but it will look great packed with students.

Regarding the April 28th youth rally at the Statehouse, I spoke with Matt Hennen today. He likes the idea, but needs to run it by the all-student organizing committee at this Sunday's meeting. The students had originally decided on a "no politicians" criteria for speakers, but Matt thinks a divestment message coming from the Governor is too good to pass up. They've been

fielding other requests to speak from politicians, so don't want to open the flood gates and take away from the youth focus. But we agreed that the Governor of our state should be the exception. Also, this group had originally proposed a divestment plan to the state legislature a few years ago that apparently didn't make it out of committee, so this feels like a particularly good tribute to the legacy of this youth lobby.

Matt will be in touch with me Sunday night with a concrete proposal. If positive, I'll put you two in touch. The timing would likely be at the start of the 2-hr rally around 11 am, following the initial march to the statehouse.
