However, in this case Governor Shumlin instructed me to disclose the records notwithstanding, subject to limited redaction pursuant to the advice of his security officer. In particular, I have redacted information relating to the specifics of his travel plans-- the hotels where he stayed and the airport through which he flew.

I have contacted the US Department of State – Boston Field Office and have spoken with S.A. Reggie Murdock who was the Agent on Duty. There is no Embassy or Consulate on the Island of Dominica. The U.S. Embassy which “covers” Dominica is on the Island of Barbados. SA Murdock recommended that the Governor be registered as a visitor to Dominica. I have spoken with Shana and she will see to it this is done.
