Analysis of Bill

1. Summary of bill and issue it addresses. The purpose of this bill is to ensure the Victims Compensation Board has access to law enforcement records necessary to process victim's claims for financial assistance.
2. Is there a need for this bill? This bill appears to serve no purpose other than to provide documents that provide narrative of a crime to the Victims Compensation Board members, it is my understanding that these documents are already available from the States Attorneys in each of the counties, and the records listed are all public record and easily accessible.
3. What are likely to be the fiscal and programmatic implications of this bill for this Department? The problems that likely would exist are that the arresting agency or local agency being requested for these records could be burden with the copying and delivery of hundreds/thousands of forms that are already in existence at the prosecuting States Attorney Office.
4. What might be the fiscal and programmatic implications of this bill for other departments in state government, and what is likely to be their perspective on it? Fiscally this bill could cause very minimal monetary cost to an agency but potentially countless hours for an administration staff to make and provide copies to each member of the Compensation Board.
5. What might be the fiscal and programmatic implications of this bill for others, and what is likely to be their perspective on it? The likely perspective is that this is going to be "another" burden to their resources, specifically admin staff that will be required to provide the documents.
