NOVEMBER 21, 2019 MEETING

1. General Business

- a. The Board called the meeting to order at 8:10 a.m.
- b. Mr. Irwin moved, seconded by Ms. Smith, to approve the minutes of the October 17, 2019 meeting as written. Approved.

2. Hearings

- a. 2019-84 – Rose Sheehan – A Stipulation and Consent Order was heard. Mr. Sahba moved, seconded by Elizabeth Merrill, to accept the Stipulation and Consent Order as presented. Approved. Mr. Irwin was opposed.

 - Barrier to access
 - Pre determination regarding criminal background
 - Endorsement from other states – Uniform policies/a substantially equivalent definition
 - Bridge licensure
 - Continuing education hours across professions
 - Nurse compact
 - Home Contractors

The Board stated that it would like to be consulted and to be able to add its input to some of the issues being addressed before being submitted to Legislature.

Attorney Layman will show the Board how to monitor a bill at its next meeting.
