**Analysis of Bill**

---

**1. Summary of bill and issue it addresses.** *Describe what the bill is intended to accomplish and why.*

The bill accomplishes five different things as a result of combining multiple bills into one omnibus bill. Section 1 is the purpose: it allows first and second class license holders that have received approval from their local jurisdiction, but not from the department of liquor control to conduct tastings and print menus, to make their startup easier once final approval is accomplished. Section 2 is the language for the tastings for management and staff. Section 3 is the definition for sampler flights. Section 4 allows a first and third class licensee to serve vinous, malt, and spirits for comparison purposes in a sampler flight format. Section 5 allows a second class license holder to pick up vinous beverages from a Vermont Manufacturer in the manufacturer's vehicle if those products cannot be obtained from a wholesale dealer. Section 6 is a study conducted by the Department of Liquor Control regarding the risks associated with powdered alcohol products. Section 7 is the penalties associated with possessing or selling of powdered alcohol. Section 8 is the effective date on passage.

**2. Is there a need for this bill?** Yes. It helps the licensees get ready to open their business as they await final approval. There is no loss of time once that is accomplished. Sampler flights allow the customer to try similar products and make a choice. It's a common practice in this country and throughout the world. Picking up wine from a manufacturer could reduce shipping costs and get the product to the store for sale in a more efficient manner. The study is important as we are seeing very non-traditional products entering the marketplace that are a regulatory problem for the department. Also there are risks associated with powdered alcohol that youth could try and have negative consequences. *Please explain why or why not.*

**3. What are likely to be the fiscal and programmatic implications of this bill for this Department?** None that we are aware of.

**4. What might be the fiscal and programmatic implications of this bill for other departments in state government, and what is likely to be their perspective on it?** DOH is assisting in the study and I believe they support our position in finding out more information on powdered alcohol and its negative effects on our society.
