UNAPPROVED MINUTES OF THE  
VERMONT BOARD OF CHIROPRACTIC  
March 19, 2019 MEETING

Present: Vernon Temple, D.C., James McDaniel, D.C. and Michael Sommers, D.C.; Absent: Daniel Coane  
Staff Present: Gabriel Gilman, Lauren Layman, Carla Preston, Tara Grenier, Lora Marchand, and Diane Lafaille. Others Present: Heather Rice, D.C.

1. The meeting was called to order at 1:40 p.m.
2. Dr. McDaniel moved, seconded by Dr. Sommers, to approve the minutes of the November 6, 2018 meeting as written. Approved.
3. Administrative Updates  

Tara Grenier, Licensing Administrator discussed changes in staffing. She notified the Board that Ashley Piro will now be the Boards Licensing Administrator in place of Diane Lafaille.
4. Education Course Review:
  - a. An Evidence Based Diagnostic Classification System for LBP – approved.
  - b. The Nordic Maintenance Care Program – approved.
  - c. The Inflammatory Response in the Regression of LHD – approved.
  - d. System Review & Meta-Analysis – approved.
  - e. Magnesium Deficiency and Inflammation – approved.
  - f. Clinical Practice Guidelines for Chiropractic LBP – approved.
  - g. The Secrets of Scapula Dynamics in Shoulder Conditions, Injuries & Syndromes – VDA withdrew this request for approval of this course.
  - h. Mastering the Disc – approved for 8 continuing education credits.
  - i. Mastering the Rotator Cuff – approved for 8 continuing education credits.
5. Other Business:
  - a. Rule Revisions – Members of the Board will submit to the Office of Professional Regulation, any comments they may have regarding the rules. The Office will work on a draft of the revised rules for the Board to review at its next meeting. Specifically, the continuing education rules will be addressed.
  - b. FCLB dues of \$1124.00 were approved to be paid.
  - c. The Board asked where the Board of Radiologic Technology was in its rules in defining a course for chiropractors with radiology privileges to complete to renew this privilege. It does not appear that a course has been defined. The Board asked if it could recommend courses to the Board of Radiologic Technology if some were found and Attorney Gilman stated that this may be helpful. Dr. Temple, through the Office of Professional Regulation, will reach out to Bruce Fox, who is a radiology diplomate of the American Chiropractic Board of Radiology and teaches radiology at Life University in Marietta, Georgia, and inquire if he knows of any courses that may be available for chiropractors to take.

- d. Dr. Heather Rice supplied the Chiropractic Board with information regarding videofluoroscopy in chiropractic. Videofluoroscopy is not within the scope of a chiropractor with radiology privileges. This is not considered conventional radiology under the chiropractic scope of practice. This would require a change in the statute.
  - e. The Board and the Office of Professional Regulation presented Dr. Rice with a plaque thanking her for her dedication and service to the Board of Chiropractic.
  - f. The Board's next meeting is scheduled for May 7, 2019 to begin at 1:30 p.m.
