I reminded him that those in such a situation would be eligible for expungement and the intent of what we are doing is to quicken that process. I also told him that if we had concerns about any application we would reach out to the appropriate authorities – police, prosecutors, judges – but we don't have a blanket policy to seek those views on every application.

In 2013, I signed a law that makes possession of up to one ounce of marijuana a civil offense, similar to getting a speeding ticket. But there are over ten thousand Vermonters who received such a conviction before the law was changed. For many of those Vermonters, this minor offense continues to tarnish their lives and prevents them from getting a good job. With my remaining time in office, I will consider pardoning non-violent offenders convicted of possessing up to one ounce of marijuana. We got approximately 156 marijuana pardon applications as of 10:30am this morning. I want to get through as many as is reasonable, understanding that VCIC has limited staff and other important work. Can the three of us touch base quickly on Monday morning to work through the best way to handle/prioritize them. I think we need to balance the priority based on the following criteria:

1. First-come, first-serve
2. Likelihood that applicant will qualify (so we are not wasting time with background checks that turn up violent crimes/felonies)
3. Compelling reason for pardon (the majority of applicants have included a brief description of why they want a pardon and in some cases a pardon will have an immediate positive impact)

"the people he's offering pardons to are eligible to have their convictions expunged since the expungement statute covers convictions for conduct that is no longer criminal. The process does involve an application to a judge but the statute says their conviction "shall" be expunged as long as it is in the interest of justice."

I understand outgoing Governors' desires to use pardon powers. If the statute needs to be changed though, please let me know. I will be working on expanding it.

Also let me know if you have any thoughts on legalization/regulation. I can get certain prosecutors and most likely TJ on board with the DC model, and should be safe from Trump. Commissioner Menard,

Good to hear from you, I hope this changing of the seasons finds you well!

Unfortunately VCIC is not able to provide that level of analysis. This is primarily due to the lack of current residency information available through various criminal history channels. For example, an individual may have a criminal history in Vermont but reside in New York just as someone may have a criminal history in New Hampshire but reside in Vermont.

The courts may be able to provide some data relating to this but my guess is that a fully engaged research project involving multiple agencies would be required. At least to generate some numbers which could stand close analytical scrutiny.
