Hi Sarah,

We are pleased that Governor Shumlin will participate in the High-Level Event on Zero-Emission Vehicles on Tuesday, Dec. 8th at 13:30 in the Netherlands Pavilion at the COP. The latest agenda is attached, and we do not expect any major changes. The Governor is on a panel with Québec Premier Couillard and California Gov. Brown, moderated by the head of UN Habitat, Dr. Joan Clos.

The key messages we expect from the High-Level Event on ZEVs are that ZEVs are ready for deployment as a climate solution now, and that there are governments and private-sector actors committed to that deployment.



