- **Promulgated Emergency Rule effective November 13, 2013** - V.R.Cr.P. 11.1. Adds provisions to plea colloquy required by changes to 18 V.S.A. Sec. 4230
- **Proposed Rules (proposed October 14, 2013; comments due December 13, 2013)**
  - a. V.R.P.P. 67. Theft of assets by fiduciaries in probate proceedings;
  - b. V.R.P.P. 80.21. Notice of appointment of guardian;
  - c. V.R.P.P. 17(a)(3). Defining "interested persons" in involuntary adult guardianship proceedings (Proposed December 4, 2013; comments due February 3, 2014)

  - c. V.R.C.P. 5(h)(1). Requiring the appellant to produce a transcript in all on-the-record appeals.

  - a. V.R.C.P. 4(b). Eliminating requirement that summons contain e-mail address of Court;
  - b. V.R.C.P. 79(b)and (c). Reflecting elimination of record-keeping requirements in Act 67 of 2013.
