- a. Mr. Stockton brought up questions regarding fingerprints and if you have a security guard application on file with fingerprints, if you would have to resubmit another set of prints for a company license. The rules of the Board state the following:

2.3 How to get an agency license

- 1. Agency applicants shall submit a completed application with the correct fee to the Office. In addition to the agency application, each partner of a partnership or the president and secretary of a corporation shall submit an application and two sets of fingerprint cards.
- b. Mr. Stockton brought up questions regarding firearms qualification. It was agreed that if you qualified for an automatic weapon, a revolver or a shotgun that it would entitle the person to carry any caliber of the said weapon.
