Later today, Agency of Natural Resources' Secretary Deb Markowitz will be announcing, on behalf of the Governor, a new state policy that will be phased in over the spring and summer to eliminate bottled water in state buildings. This change in policy takes into account both budgetary and environmental concerns.

The new policy will be phased in over the next several months. Please assure your staff that there will be opportunity for input as the new policy is crafted and that we will take into account the need for all employees to access clean, safe drinking water in the workplace.
