**Working Lands Enterprise Board <- title of Board**

“This act creates the Vermont working lands enterprise board, which is charged with administering the working lands enterprise fund to make investments in, and provide services to, working lands enterprises, as well as to make investments in working lands infrastructure.” <- *description of Board (there is a spreadsheet with this information for you, I copy and paste it!*
