- a. Ronald H. Noel – Unarmed registrant with US Security Associates. Based on the information provided, Mr. Coane made a motion, seconded by Mr. Eckhardt, to approve Mr. Noel for registration. Motion passed unanimously.
- b. Paul Martin Sr. – Unarmed registrant with Censor Security. Mr. Eckhardt recused from voting on this registrant. Due to a lack of quorum Mr. Martin was issued a temporary and his registration will be tabled until the March meeting.
- c. Inter-Con Security Systems - As a security agency with Edward Brown as the qualifying agent. Based on the information provided, Mr. Coane made a motion, seconded by Mr. Eckhardt, to approve Inter-Con Security Systems with Edward Brown as a qualifying agent. Motion passed unanimously.
- d. Iliya J. Light – Unarmed registrant for Stockton Security Services, Inc. Mark Stockton from Stockton Security Services, Inc. called to withdraw this application. No action was taken.
- e. VTPI (Vermont Private Investigations) As a private investigative agency with Shawn Waldron as the qualifying agent. Based on the information provided, Mr. Coane made a motion, seconded by Mr. Eckhardt, to approve VTPI as a private investigative agency with Shawn Waldron as the qualifying agent, however they

only approved the application as unarmed until such time as Mr. Waldron takes an approved firearms course. Motion passed unanimously.
