- I. Attorney Layman and Attorney Tredeau informed the Board of H.305 passing and the relevant items associated with it affecting Veterinary medicine.

6. Discussion:

- **Renewal Process in relation to 6.1**

- I. Dr. Wheeler and Dr. Howard informed OPR that the board was concerned that licensed veterinarians had to upload CE certificates to renew their licenses. Requiring the upload is inconsistent with the requirements of the new Rules adopted in 2022, particularly Rule 6.1 which requires only an attestation regarding completion of continuing education.

- II. Attorney Layman agreed that the request for CE certificates was inconsistent with the requirements of the new Rules and apologized for the administrative error. She stated that OPR would work on revising the renewal process to

reflect the current veterinary administrative rules CE requirements and would consult with the Board regarding any changes.
