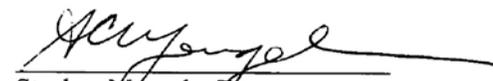
**VILLAGE OF DERBY CENTER  
ANNUAL MEETING**

The legal voters of the Village of Derby Center, Vermont, are hereby notified and warned to meet at the Derby Town Clerk's Office meeting room at 124 Main Street, in said Village on Tuesday, April 4, 2023 at 6:00 p.m. to transact the following business:

- Article 1.** To elect a Moderator.
- Article 2.** To hear and dispose of the reports of the several officers for the past year.
- Article 3.** To elect One (1) Trustee for a three (3) year term.
- Article 4.** To see if the Village will vote an annual salary to the Chairman of the Board of Trustees in the amount of \$3,450.00 (\$1,380.00 from Water, \$1,380.00 from Sewer and \$690.00 from Village) and an annual salary of \$2,875.00 each for the other two Trustees (\$1,150.00 from Water, \$1,150.00 from Sewer and \$575.00 from Village).
- Article 5.** To see if the Village will vote to authorize the Board of Trustees to place the Sewer fund surplus balance of \$40,030.16 into a fund to renovate one sewer pump station.
- Article 6.** To see if the Village will vote to authorize the Board of Trustees to place the Water fund surplus balance of \$72,134.10 into a fund to purchase radio read water meters.
- Article 7.** To see if the Village will vote to pay its taxes to the Village Treasurer as provided in Title 32, V.S.A., Sections 4791, 4792 and 4793.
- Article 8.** To see if the Village will vote to collect Water and Sewer payments through the Treasurer as provided in Title 32, V.S.A. Sections 5136, 1674 and V.S.A. 24 Section 5151.
- Article 9.** To see if the Village will vote a percentage to the Collector of Delinquent Taxes, Water, and Sewer Rents in addition to the eight percent (8%) allowed by law.
- Article 10.** Shall the Village of Derby vote to raise, appropriate and expend the sum of \$3,300.00 for the support of the Dailey Memorial Library to provide services to residents of the Village.
- Article 11.** To have presented an estimate of expenses for the outstanding indebtedness and current expenses of the Village for the ensuing year and to appropriate such sums as what it deems necessary for said expenses, expressing said sum in dollars in its vote.
- Article 12.** To transact any other non-binding business that may legally come before said meeting.
- Article 13.** To adjourn.

**ANNUAL VILLAGE MEETING**

**2022 Minutes**

Agreeable to the foregoing Warning the legal voters of the Village of Derby Center, Vermont met at the Derby Town Clerks Office meeting room at 124 Main Street, in said Village on Tuesday, April 5, 2022 at 7:00 p.m. to transact the following business:

The meeting was called to order at 7:00 p.m. by Moderator William (Bill) Gardyne. Bill asked everyone to stand to recite the Pledge of Allegiance.

**Article 1:** Elizabeth Bumps nominated Bill Gardyne for Moderator. Seconded by Stephen Mengel. So voted.

**Article 2:** The Village Report was presented as a whole by Bill Gardyne. No comments. Stephen Mengel moved to accept the minutes of the 2021 Annual Meeting. Seconded by Marcel Caron. So voted.

**Article 3:** Trustee – 3 year term – Elizabeth Bumps nominated Marcel Caron. Seconded by Stephen Mengel. So voted.

**Article 4:** Salary for Trustees – Elizabeth Bumps moved to pay an annual salary to the Chairman of the Board in the amount of \$3,450.00 (\$1,380 from Water, \$1,380 from Sewer and \$690 from Village) and an annual salary of \$2,875.00 each for the other two Trustees (\$1,150 from Water, \$1,150 from Sewer and \$575 from Village). Seconded by Diana Mengel. So voted.

**Article 5:** Stephen Mengel moved to authorize the Board of Trustees to place the Sewer fund surplus balance of \$114,895.08 into two reserved funds: \$60,000 for the upgrade of two sewer pump stations and \$54,895.08 to be used for capital expenses. Seconded by Doug Bumps. So voted.

**Article 6:** Doug Bumps moved to authorize the Board of Trustees to place the Water fund surplus balance of \$60,856.71 into a reserved fund for upgrades at the water treatment facility. Seconded by Diana Mengel. So voted.

**Article 7:** Elizabeth Bumps moved to pay the taxes to the Village Treasurer as provided by law. Seconded by Stephen Mengel. So voted.

**Article 8:** Stephen Mengel moved to collect Water and Sewer payments through the Treasurer as provided by law. Seconded by Marcel Caron. So voted.

**Article 9:** Doug Bumps moved to pay the Collector of Delinquent Taxes, Water, and Sewer Rents 6% in addition to the eight percent (8%) allowed by law. Seconded by Marcel Caron. So voted.

**Article 10:** Elizabeth Bumps moved to appropriate and expend the sum of \$3,300.00 for the support of the Dailey Memorial Library to provide services to residents of the Village. Seconded by Diana Mengel. So voted.

**Article 11:** Elizabeth Bumps moved a figure of \$33,896.99 to be raised by tax. Seconded by Marcel Caron. So voted.

**Article 12:** Other Business: Elizabeth Bumps informed everyone that there had been a few inquiries concerning the Village Forest. One neighbor would like to purchase 20 acres that borders his property and one of the Derby Listers suggested it could be divided into three building lots. The 70 acre forest was a gift from Rob & Dorris Kilborn on July 10, 1953. The Village has logged off the forest a couple times and used the money for special projects that we didn't have to raise taxes to do. Elizabeth stated that she believes this to be an asset to the Village. We are exempt from paying taxes on it from the Town of Derby. They exempt the Village for ten years at a time, our next request for exemption will be 2024. There is no reason to sell this land. We just wanted to get an idea of how folks felt about this. Elizabeth suggested that if it were ever thought to be sold by the Trustees that it come to a vote of the Village residents not just the Board of Trustees deciding it. This was a gift to the Village. We need to walk the land with the county forester to see if there are trees that could be harvested and to remove taps that have been put in the trees by a neighbor. Forest management should be looked into. Bill Gardyne suggested forming a small committee to look into this.

**Article 13:** Marcel Caron moved to adjourn. Seconded by Elizabeth Bumps. So voted.

Adjourned at 7:14 p.m.

## Trustee Notes

We have received a total of \$164,110.38 from the American Rescue Plan Act (ARPA) fund. The money can be used for water/sewer system upgrades/improvements. We have purchased and installed 100 radio read water meters. This will be an ongoing project to replace all of the water meters. Most all of the meters were installed in 1995. We also plan to replace four pumps in two of our sewer pump stations which will take most of the remainder of the funds.

Lighthouse Marine LLC, Casey Morey was hired again this year to remove milfoil from Lake Derby. We have money from the Town of Derby and receive a yearly grant from the State of Vermont to pay for this.

The Board meets the first and third Tuesdays of each month. The first meeting is at 8:15 a.m. and the second is at 6:00 p.m. in the Village Office at 428 Main Street.

Note the change of time for the Annual Meeting.

We thank Dave West for the work he does for the Village/Water/Sewer Depts. as our Public Works Director; James Barry our weekend backup for Dave; Carlton Kingsley for keeping the sidewalks clear; Jordan Benjamin as back up for Carlton and keeps the hydrants clear of snow and the office staff of Assistant Clerk/Treasurer Karen Jenne and Clerk/Treasurer Elizabeth Bumps.
