I would like to respond to the letter that you forwarded to me from Edward Nuttall regarding the inquiry he made. We have in fact responded to this request in the most complete manner that we were able back in July of 2011. I am forwarding the email and attachment that was sent to Senator Brock with the information that was requested.

Just to give you some history regarding this request here is what we have done:

Back when the request came in, Rob Hofmann was Secretary. We had a meeting to discuss this request because it seemed excessive. Because of this we called Senator Brock and the decision was made with him to send him an AHS Budget book which would provide all of the information that was being asked for.

The following day I sent out the prior year's budget book. I am not sure what happened, but that book never reached the Senator once it got to the State House. When I found out he did not receive that book, I sent him a new book (which had just come out). After some time passed I heard from the Senator that this was not an acceptable response to the request that was made.

At this point, Doug had become Secretary and we had another meeting to decide what to do because once again this was a huge request that seemed almost impossible to meet. Once we went through the list of Programs that the Senator's constituent was referring to (which took us a day itself) we realized that a large part of the list was not actually programs but just links to federal program, websites, etc. So we consolidated the list into actual programs that we could get a budget and staffing numbers for. Once we determined the department that was responsible for each of the programs I sent a request to each of the Business Managers and asked them to provide the number of staff and budget for each of these programs. However, we also told them not to spend excessive amounts of time on this request.

We were eventually able to get all these numbers pulled together and in July of 2011 sent the attached list to Senator Brock.

Senator Brock has insisted all along that he does not want us to create documents or expend a great deal of effort to comply with his request. We have sent him the information that did not have to be created (except that the consolidated list being created by me). We are unclear what more the Senator is looking for us to provide to him. There is no further information that we can provide that exists today. We can of course send him the most recent AHS Budget Book (FY2013), but we do not believe that this will be an acceptable response for him again and will cost approximately \$100 to put together.

Secretary Racine also want to point out to Senator Brock and his constituent that this Administration inherited this "management problem" from Governor Douglas.

If there is more information that you would like from me regarding this matter please let me know.

Attached is a program by program response to your question. The information was compiled by the Central Office staff plus the business offices of each of the six AHS departments. While no new information was developed, this was a time-consuming project that obviously was not going to get done to anyone's satisfaction during the legislative session with its many demands for budget work.

I hope that this information meets your expectations and the needs of your constituent.

Many of these entries are policy or program initiatives that do not have discrete budgets or state staff FTE's associated with them. In other words 1 state FTE, as part of their daily responsibilities, may be responsible for overseeing many of the services listed below. Similarly, some of these items are prior authorization or other eligibility processes which do not have discrete budgets but rather describe a process for approval for certain Medicaid categories of service.

Where discrete FTE's are noted below they are state staff and not reflective of the many FTE's working in the private nonprofit provider system funded by grants and contracts to deliver the services listed.

The most accurate and detailed source of AHS expenditures is in the budget book prepared annually for the legislative session. Dollar figures noted below are FY12 estimates.

### AHS

Housing and Homeless Assistance: This is a policy initiative that brings together staff from across the agencies to work in a coordinated fashion to address housing issues. There is no discrete FTE associated with the efforts, nor is there a budget.

### DAIL

Adult Day: No discrete FTE's – These are grants to community providers who employ staff locally and have many public and private revenue streams to support their work. DAIL funds \$1,968,752 to 14 providers annually.

Adult Protective Services: 12 FTEs and \$854,000 annual appropriation

Assistive Community Care Services: These are supplemental payments made to individuals in residential care. The total estimated in this category of service in DVHA is \$13,561,779.

Assistive Technology Program – 5 FTEs; Total appropriation \$80,000

Attendant Services Program – No discrete FTE, GF = \$2,311,190; GC = \$1,486,456

Autism Specialists – 1 FTE

Blind and Visually Impaired Services –10 FTEs; Total appropriation \$2,433,284 (Admin. and Grants)

Children's Personal Care Services – 2 FTEs; Total appropriation approx \$23M in DVHA's budget

Choices for Care (1115 Long-Term Care Medicaid Waiver) - 16 FTEs; Total appropriation \$208,380,598 SFY '12 in DVHA's budget

Dementia Respite Program – No discrete FTE; Total appropriation \$250,000

Developmental Disability Services - 7 FTEs; Total appropriation \$139,884,478

Flexible Family Funding – No discrete FTE; Total appropriation \$1,103,749

Food and Nutrition Program – No discrete FTE; Nutrition Services Incentive Prog \$753,915 and 3 Squares Vermont \$208,648 GF.

Green Mountain Self-Advocates (GMSA) - No discrete FTE; Total grant \$30,000

Guardianship - 28 FTEs Total appropriation \$2,298,142

High Technology Home Care – No discrete FTE; Prior authorization process for an array of services in the DVH budget for example, skilled, nursing, high tech equipment and durable medical equipment.

Housing and Residential Supports - No discrete FTE; HASS and SASH Total appropriation \$773,192

Mental Health Elder Care Clinician Program (ECCP) - No discrete FTE; Total appropriation \$235,423

Offender Services - Public Safety caseload \$1,923,596

Older Vermonters and Family Caregiver Services (Older Americans Act) - No discrete FTE; Total appropriation \$9,710,281

Senior Community Service Employment Program (SCSEP) - No discrete FTE; Total appropriation \$495,555

Supported Employment-Division of Disability and Aging Services – 1 FTE; Total appropriation \$11,300,000

Supported Employment-Division of Vocational Rehabilitation - 1 FTE; Total appropriation \$2,528,407

Traumatic Brain Injury (TBI)-Division of Disability and Aging Services - 3 FTEs; Total appropriation \$4,744,899

Traumatic Brain Injury Program-Division of Vocational Rehabilitation – ¼ FTE; Total appropriation \$143,719

## DCF

Aid to the Aged, Blind, Or Disabled for an Essential Person: No discrete FTEs, eligibility is part of the overall ESD caseload and supplemental payments are made to beneficiary as deemed eligible. Total appropriations \$12,871,654.

Adopting a Waiting Child – No Specific FTEs; no specific appropriation. This is part of Project Family. See below.

Adoption Registry - There are no FTEs; This is part of Project Family. See below.

Baby Safe Haven – this is a state law, there are no FTEs or funds

Business Start Up – Micro Business is \$367,009; Revolving loan fund is \$57,965.

Child Care Subsidy – FTEs associated with this are split between CDD and CCCSA's; \$41,598,819

Child Support – OCS budget and FTEs: \$12,902,118 – 115 FTEs

Community Services – Block Grant was \$3,730,000

Disability Determination Services – \$5,656,106; 38 FTEs – all federal.

Domestic Violence Unit - \$147,488 for 2.5 FTE.

Early Childhood Intervention Services – Now known as Children's Integrated Services within the CDD; Total appropriation \$3,738,991.

Emergency/General Assistance – No discrete FTE, eligibility is determined by ESD as part of overall caseload; Total appropriation \$6,500,000.

Farm To Family - \$68,730

Three Squares Vermont (Cash Out) – No discrete FTE, eligibility is determined by ESD as part of overall caseload; Total appropriation \$23,756,778.

Fuel Assistance (Crisis) - No discrete FTE, eligibility is determined by ESD as part of overall caseload; Total appropriation \$2,950,000.

Fuel Assistance (Seasonal) - No discrete FTE, eligibility is determined by ESD as part of overall caseload; Total appropriation \$11,612,664

Housing Assistance - Emergency/General Assistance – Included in GA/EA numbers above.

Housing Assistance – Shelter and Services – OEO No Discrete FTE; Total appropriation \$1,114,331.

Lifeline – no dollars associated with program and is done as small function of one FTE

Link Up Vermont State Agency of Human Services – no information available.

Partners In Service (PINS) – Contract cancelled – no FTE and no dollars.

Project Family – contract is \$275,791

Reach Up – Staff (66) on ESD payroll as well as case managers in DAIL and VABIR; costs for the latter two are included in total appropriation. Total appropriation \$49,155,572

Reporting Child Abuse – 7 FTEs: \$635,704 for the Centralized Intake Unit.

Savings Assistance – IDA budget is \$135,300.

Vermont Child Abuse and Neglect Registry: Guide for Persons Substantiated for Child Abuse or Neglect and also the Vermont Child Abuse and Neglect Registry: A Guide for Employers; There are no specific FTEs who staff the Child Abuse and Neglect Registry. Initial registry checks are done as part of the job duties of 6-8 FTEs – there is no appropriation. Registry Reviews due to an appeal of a Registry listing are staffed by 2 FTEs and some contractors to do the reviews at a cost of \$374,712.

Vermont Foster Parents: Cannot answer as the intent of the question is unable to be interpreted. However, \$3,324,652 was budgeted in Standard Foster Care for SFY '12.

Weatherization Program 2 FTEs; Total appropriation \$11,945,291 includes the FTEs.

Smoking Quit Line - As part of the Vermont Quit Network, the Smoking Quitline provides telephone counseling and Nicotine Replacement Therapy (NRT) to Vermonters who are attempting to quit smoking, and helps them build a "quit plan" in order to be successful. – 0.065 FTE; Total appropriation \$254,245

Substance Abuse Intervention and Treatment - The promotion of a community-based resiliency and recovery oriented system of care and support for screening, brief intervention and treatment services. 15 FTEs; Total appropriation \$25,390,750

Substance Abuse Prevention – The proactive promotion of healthy lifestyles and norms that reduce the risks associated with the use of alcohol, tobacco and other drugs. 10 SAPs in the schools; Total appropriation \$2,731,670

Substance Abuse Trainings – The development and maintenance of a substance abuse and related expertise among the prevention and treatment workforce in the State of Vermont. 0.25 FTE; Total appropriation \$21,760

WIC in Vermont (Nutrition Program) - The Special Supplemental Nutrition Program for Women, Infants and Children provides individualized nutrition counseling, breastfeeding promotion and support, health screening & referral and specific nutrient dense foods to income eligible pregnant, postpartum and breastfeeding women and infants and children who are younger than 5 years old. Dear Governor:

Since December 2010 I've been working with the two Senators of Franklin County (Brock, Kittell) and one Representative from Fairfax (Gilbert) to obtain the number of personnel the Agency of Human Services supports with funds provided courtesy of the taxpayers of Vermont. It is now almost July 2011 and I still haven't received an answer. I'm having some serious doubts about the management of AHS and why it is so difficult to provide basic information. In the budgeting process one should be able to ask the question of how many people are supported by category of support as listed on the AHS Webpage. Since that information is difficult to obtain one has to wonder what kind of management is in place that allows that information to go unnoticed.

Here's the current AHS answer in reply to an email from Senator Randy Brock:

*I wanted to let you know where I stand on the request for information from your constituent. Unfortunately I was out of the office all last week very sick. I am back now and working on this project. I am sorry that the budget book did not answer the questions that your constituent had. This request involves a great deal of work for the agency but we are moving forward on trying to provide it. I have taken the list of programs that the constituent provided from our website and broken it down by department. Many of the things listed are not actually programs, but just links to reports or websites, etc., so I have removed those. The actual programs I have split up into the appropriate department responsible for it. I have now sent the list, by department, to each of the Commissioners. I have asked each of the Commissioners to provide the cost and staffing for each of the programs listed under their departments.*

*As soon as I receive that information back I will send it to you.*

Given the latest mismanagment of funds at the local level that is ongoing resulting in loss of monies to taxpayers, I can't help but continue to wonder who's really in charge at AHS and who's looking over their shoulder.

Here's an assessment by Senator Randy Brock:

*"Secretary Racine:*

*As I emphasized in our discussion (and in my original discussion with former Secretary Hofmann), it was not my intent to ask the agency to create any information that is not already compiled. That serves a two-fold purpose: First, to avoid asking an overstretched agency to do additional unbudgeted work and, second, and most important, to assess whether the agency actually knows how much, both in dollars and staff time, is being spent on each program it administers.*

*To that end, if the agency were to review the programs and services cited in Colonel Nuttall's original request, would it be possible to see what detail already exists in summary form (below the high-level budget) that is responsive to this request? For those separately-identifiable programs that are largely funded by Federal funds, I would assume there is an accounting of how much is spent in Federal and matching state funds, as well as an accounting of costs, including staff, chargeable to each such program. I appreciate the fragmented nature of program service delivery, including the activities of the designated agencies, but again, I would assume, as a minimum, that the requested information should be available for*

each discrete program that received Federal pass-through funds, due to the required preparation for the annual A-133 Federal compliance audits.

For example, with Early Childhood Intervention programs, although there may be several individual programs, I would assume that there should be cost and performance data readily available for each such program. Otherwise, how does the agency answer such fundamental questions as what is the cost per child for each program and how do you measure the return on investment? Without such data, how does the agency determine how to allocate its precious resources?

Colonel Nuttall's request simply is to determine how much is spent by the agency on each of the programs it administers, how many people are served by each program and how many state employees are dedicated to each program. If this information is currently unknown, please let me know.

I hope that this sufficiently clarifies and narrows the request so as not to generate excessive work in responding to it. If you have questions or would like to discuss this, feel free to give me a call. My cell is (802) 309-8220.

This frustration has been building over the months since my original request. As can be seen below, Senator Brock has taken the lead on this request and clearly identified the perception of a concern that many taxpayers have:

Doug:

Almost a month has passed since my request for information, a copy of which appears below. Almost four months have passed since my original request to the department through your predecessor and his senior staff. My attempt to get this information has included a written request, in person conversations with two AHS secretaries and telephone conversations with agency staff. To date, my constituent, who rightly has grown increasingly angry, has received no response to his inquiries.

It seems incredible that the Agency does not seem to be able to produce a listing of how much it spends on each of its entitlement programs and how many people are involved in delivering them. I would think, as a minimum, that this information would be readily available at least for programs that receive Federal funds.

Can you advise when or if the Agency will respond to this request?

Randy,

Attached is a list of human services to which many deserving people are helped, but I question how the State puts quality control into the services. I wonder about fraud and abuse. So much money is diverted into these services that it's having an impact upon our budget.

It would seem to me someone should be accountable to us and answer that question. Here are the questions I wish for you to answer:

How many dollars does Human Services spend in providing these services?

How many people are we talking about and can that list be summarized by category? If not, why not?

*All of us want to help the disadvantaged. That's simply a fact! But we have a distaste for those who abuse the system by not working to draw in income if able. If "willing", depends on your values in life. Here's an incident a friend of mine experienced: He became aware an individual was out of work. He secured a job for him but he failed to show, on two occasions. He called Human Services who stated this individual was making more money through welfare than he could working at this job. I don't know the outcome, but my point is to many it is more secure to draw welfare checks than to work. On the other hand many cannot work or their jobs need to be supplemented through welfare. It all goes back to horror stories of abuse and rampard in MEDICARE/MEDICAID. It seems we're more concerned about giving than policing.*

*This is my opinion. What's yours?*

The bottom line is that the AHS has been contacted over a period of six months to provide basic information, i.e. number of people given support by category of support. We, as taxpayers, expect our government to be responsive and respectful. We expect our government to be accountable for the funds we provide, i.e. taxes.

I have the right to an answer to my question in an expeditious manner. Can you make that happen?


As you may be aware, there are serious issues relating to Ascutney Mountain Resort that are not only affecting the Town of West Windsor but the State of Vermont. With the ski area closed and the resort-owned sewer system and related delivery line to Windsor embroiled in issues with the 270 property owners and the Town of Windsor, this situation is seriously affecting the marketability of the resort. As a result the select board is faced with plummeting property values as well as a lackluster business climate with associated unemployment due to inactivity at the resort. Waste water pollution issues discovered during a recent state-funded engineering study in the village of Brownsville, adjacent to the Resort along Mill Brook, add to the seriousness of the situation.

The select board is being very proactive in dealing with these issues; however we need your help. We have applied for financial assistance through the Clean Water State Revolving Fund. Being categorized as a very high priority in this program is urgently needed to facilitate the purchase of the resort sewer collection and distribution system by the town. This will stabilize the issues relating to the property owners and Windsor, improving the likelihood of a resort sale, and provide a means for solving our waste water pollution issues. The select board respectfully requests that you urge those who administer this fund to view this situation not only as a local issue, but as a state issue. Funding for this project is desperately needed. Additionally, any assistance that might be available through other state/federal funding sources would be greatly appreciated.

While the Board certainly recognizes other critical funding needs elsewhere in the state, this situation has persisted for nearly two years with little or no involvement from anyone at the state level. With the resort shuttered, thus directly and indirectly providing greatly reduced revenues to the state coffers, the loss of nearly 150 full and part-time jobs and direct points of pollution into state waterways, we need to address these issues soon. West Windsor is not looking for a hand-out, just assistance in dealing with a complex situation ultimately resulting in a more prosperous, environmentally responsible Vermont.

As select board chairman, I would be happy to meet with you at your convenience to discuss the complexities of our situation. Thank you for your consideration.

Thanks for the response. I'm not sure why your first attempt didn't come through, but this time it worked.

I'm not sure why everyone keeps on saying my question was answered, when in fact it was not. (If you can produce the response which answered my inquiry, I will eat crow.) I clearly asked for number of people, not dollars, by category. The AHS response oriented its answer towards the latter.

Senator Brock and I have had a very difficult time getting the AHS to produce numbers of people supported. I don't understand why that is so, and it seems to me one would be more interested in showing number of people served, although budgeting is a necessary item of interest.

If you follow the email correspondence Randy and I have presented, you will see the AHS has avoided answering my question all along.

This is very disturbing and smacks of mismanagement at the highest level. Something is seriously wrong here and should be looked into before findings are made, disturbing to all.

Let me make some simple points.

- The Agency of Human Services has an Internet page and a mission.
- On this Internet page are listed all of the services it provides.
- Each of these service departments or section heads provide services to a number of people throughout the State of Vermont.
- To provide these services, dollars are asked for (budgeted) and spent based upon need that is real or projected.
- If one follows proper accounting, one would ask for dollars required for the year based upon a summary of services provided to individuals the previous year with projections for the upcoming year.

And here's where the water gets murky. It appears the AHS is managing by exception, i.e. the AHS budget is not supported by need expressed by number of people supported or to be supported; rather by dollars needed without having the need to justify this dollar amount.

I'm not attempting to belittle any one organization or individual; rather I am looking for fiscal responsibility from my government. And I don't see it in this one area. I suggest it is time to audit the AHS and find out what is wrong. Then implement the necessary procedures to assure the people of Vermont fiscal responsibility is in effect.

Accessibility to state and program budgets is critical to maintaining transparency and accountability. The administration of programs and services is complicated and necessitates the pulling together of myriad data, requiring the time and full attention of staff. The most accurate, timely, and comprehensive set of expenditures and financial data is compiled into the budget book annually for each legislative session. This document was initially mailed to you and Senator Brock in response to your budget inquiries.

When you expressed dissatisfaction with this response, employees at the Agency of Human Resources and point people at each Department worked to pull together an alternative document. There is no further information that is currently compiled, or that would be reasonable to begin compiling, that could more sufficiently answer your original request for the budget of programs within AHS than the budget book. The most recent AHS Budget Book (Fiscal Year 2013), is available currently. It would take approximately \$100 to pull together for your receipt. I believe Deputy Commissioner Hollar has flagged this event for you on the Governor's calendar.

This year's date has tentatively been set for September 19, but we do have some flexibility on that, depending on the Governor's availability. We do not have a location reserved yet, but typically we meet at a church hall in Randolph.

This being an election year, we will also be inviting Senator Brock to meet with us at a separate time on the same date, so I will need to coordinate with his schedule as well. Our format the last time was for each candidate to get approximately 45 minutes on the agenda, which seemed enough to present remarks and answer questions from the audience. We would submit some sample questions in advance that we ask each candidate to address, either in his prepared remarks or during Q & A. This format seemed to work well for Governor Shumlin two years ago. I'm hoping it meets with his approval again, as well as Senator Brock's.

As you know, our non-profit status prevents us from making endorsements, but last time public access TV filmed each candidate interview and we prepared transcripts. These were made available to our members via our website and those of the various public access stations around the state. The two organizations have combined email lists of over 400 housing, homelessness and anti-poverty professionals around the state. We expect to do the same again this year.

Please let me know as soon as possible whether the Governor will be able to attend so I can contact Senator Brock.
