Maxine says she will do *\_parts of\_* H.221 as committee bill. Suzi still very much needs to work out specifics with DOC, so I'm not sure how much a vehicle H.221 is, but Chris thinks it is. His priority seems to be some version of private employer BTB bill getting through the House this session. (He will explain there is one long crazy BTB bill, and a short one that got no attention, and his priority is the short one. Both apply to public and private employers.) It sounds like he will be still happy and supportive of press conference either way, but wants to make above pitch to you and try to get Governor support for that as well.
