
We have audited the Town's financial records for 2021. This report is being delivered to the registered voters of the Town for their review in a timely manner and in compliance with State Statutes.

Authority

This Audit was conducted in accordance with Vermont Statutes 24 V.S.A. §1683 and §1684, which, among other things, require that the elected Auditors examine and, as needed, adjust the accounts of all Town Officers and all other persons authorized by law to draw orders on the Town Treasury.

Objectives

The objective of the Audit Committee was to examine and adjust, as needed, the Town's accounts and to establish the Town's financial condition and the resulting balances in specific funds at the end of fiscal year 2021.

Background

Work began on the 2021 Audit on January 17, 2021; it was completed on January 30, 2021.

Statutorily Required Materials

Financial Condition of the Town

The Town of Maidstone Balance Sheet, dated 12/31/21, shows that the Town has assets totaling \$1,245,322.17: \$ 378,233.60 in General Fund 002; \$50 in petty cash; \$435,940.59 in Earmarked Funds; and \$431,097.97 in Accounts Receivable. The Town paid a total of \$933,686.90 in Educational Taxes in 2021. Educational tax obligations, due to be paid in April and June 2022, total \$482,020.39. The Town has no other debts at this time.

Summary of Receipts and Expenditures

Taxes Billed, Received, Outstanding, and Expended

The Town of Maidstone is authorized by the State of Vermont to collect taxes. Historically, the Town sent tax bills out once a year. These taxes were due by October 15th and became delinquent and subject to interest payments and penalties after that date. Starting in 2019, the annual Town tax bill divided the total amount due into two approximately equal payments, the first payment due on October 15, and the second payment due on April 15 of the following year. Any taxes due on October 15th that were not paid became delinquent; however, due to State Statutes, only interest can be charged on these past due amounts. No penalties can be charged on any amounts past due until after the final payment date, which is currently April 15th. Additional information may be found in the Town's Policy for the Collection of Delinquent Taxes, dated January 16, 2020.

Tax bills sent out in 2021, after authorized adjustments were made to the Grand List, totaled \$1,185,514.53. Of that amount, \$592,758.13 was due on October 15, 2021, and an additional \$592,756.40 is due on April 15, 2022. In addition, \$569,434.76 of the 2020 taxes were due on April 15, 2021.

By 12/31/2021, the Town had collected \$13,293.99 in past due 2020 taxes plus \$386,878.02 in 2020 taxes due on 4/15/2021. Of the 2021 taxes, the Town had collected \$583,796.62 of the \$592,758.13 due on

October 15, 2021. Of the \$592,756.40 due on April 15, 2022, the Town received prepayments totaling \$183,338.24. The total amount of non-delinquent taxes collected in 2021 was \$1,169,418.87.

The tax balance as of 12/31/2021 includes \$409,418.16 due on April 15, 2022, plus \$8,961.51 of the 10/15/21 tax bill that is past due. Therefore, the balance of 2021 taxes due is \$418,379.67.

During 2021, the Town collected \$45,700.28 in delinquent taxes (DT), interest, and penalties. As of 12/31/2021, the Town has a balance of \$8,502.78 in delinquent taxes, plus \$681.91 in penalties and \$3,533.61 in interest. This sum, when added to the balance of 2021 taxes due yields an Accounts Receivable of \$431,097.97. The Table below provides this summary information in greater detail.

Non-delinquent taxes collected in 2021 totaled \$1,169,418.87. Of this, the Town paid the State of Vermont \$933,686.90 in Educational Taxes in 2021, yielding a balance of \$235,731.97 in Municipal Tax Revenue.

Highway Fund

The Highway Fund 2021 opening balance was \$312,803.42. The Highway Fund raised a total of \$57,503.81 in grants and fees during 2021. The Highway Fund expenses totaled \$179,973.93. The net, i.e., revenue minus expenses, for the Highway Fund was therefore a negative amount, - \$121,508.37. An appropriation of \$20,000 to the Highway Fund was approved during the 2021 Town Meeting. An additional \$70,000 appropriation was included in the Town Budget, and was approved when the Town Budget was approved. With these appropriations included, a net change in the Highway Fund was \$ -31,508.37, leaving a remaining balance in the fund of \$281,295.05 as of 12/31/21.

The Highway Fund is further broken down into three sub-funds: The Highway Fund, which accounts for the maintenance of Town roads in summer and winter, has a balance of \$48,864.40; the Town Road Rebuild Fund, which accounts for road rebuild projects, has a balance of \$219,810.65; and the Clean Water Act, which addresses problems associated with Storm Water runoff entering our rivers, lakes, and ponds, has a balance of \$12,620.00.

Other Receipts

The Town's total revenue for 2021 was \$454,999.93. Of that amount, \$235,731.97 was raised in Municipal Taxes; \$45,700.28 came from the collection of delinquent taxes including interest and penalties; \$154,606.60 was received in grants from the State of Vermont and other sources; \$12,509.11 was received in fees and fines; and an additional \$6,451.98 was received in interest payments.

Other Expenditures

The Town's expenses for 2021, without including Educational Taxes, totaled \$360,197.90. The Auditors did not find it necessary to make any adjustments to any of the expense accounts.

Statement of Revenue and Expenses

The Statement of Revenue and Expenses, provided in Appendix A, is required to be prepared under Vermont Statute 24 VSA §1683. This statement summarizes the Town's revenue and expense accounts into categories that are consistent with those presented in the Annual Report. It also shows the balances and expenditures in the Town's Earmarked Funds that are cited in the Annual Report. The Statement shows both the opening and closing balances for each of these funds. This Statement shows that the Town had a net gain of \$94,802.03, with Revenue exceeding Expenditures. The Statement of Revenue and Expenses does not include the revenue collected or expenses paid to cover the Educational Taxes that the Town levies for the State.

The Statement of Revenue and Expenses also shows a total inter-fund transfer of \$104,500.00 from the General Fund into the Earmarked funds, that was authorized during the 2021 Town Meeting either by approving the budget or by approving individual articles: \$90,000 into the Highway Fund; \$2,000 into the Grand List fund; \$10,000 into the Reserve Fund; and \$2,500 into the Direct Fire Support Fund.

The Treasurer's Report includes a Report on Grant Activity. The Auditors have included these income and expenses in the General Fund so that they are included in the Statement of Revenue and Expenses.

Outstanding Payables

Some of the 2021 Educational Taxes that the Town must pay to the State were due in 2021; the remainder due in 2022 is \$ 482,020.39.

Report of Deficit

The Town has no debts at this time.

Other Information

Selectmen's Compensation

Although the Selectboard may set compensation levels for each town officer, under Vermont Statute 24 VSA § 933, the Selectboard does not set compensation for its own members; this responsibility falls to the Auditors.

On January 10, 2022, the Auditors met in a Special Meeting and voted to adjust the Selectboard's Compensation to \$1,340 for the Chairman, and \$1,140 for each of the other two Selectboard members. The Selectboard's compensation has had no cost of living or other form of adjustment since 2009, perhaps longer. The 13.16% increase is the compounded consumer price index cost of living adjustments from 2016 to 2021.

Financial Policies and Internal Controls

During 2021, the Treasurer appointed Kathleen Intoppa as Assistant Treasurer. Following best accounting practices, the Assistant Treasurer independently reconciles the bank statements of the many Town of Maidstone bank accounts. This increases the transparency of all transactions that happen in the Town's financial system. The Assistant Treasurer is also an additional signer on the Town bank accounts..

Milfoil Grant Each year, the Maidstone Lake Association administers a greeter program to monitor the boat launch area specifically to stop the introduction of invasive species into Maidstone Lake. The grant program is funded by the State and must be financed through the Town of Maidstone, but does not cost the Town in that any short-fall of expenses over income is paid by the Maidstone Lake Association to the Town.

SOS Grant The Vermont Secretary of State's office provided reimbursement for election related expenses due to the COVID-19 pandemic that were above and beyond the Town of Maidstone's budget for the Annual Meeting election.



Fire Warden's Report

2021

During the 2021 State of Vermont wildland (grass/brush) fire season the state received reports of 94 fires from 47 towns that burned about 157 acres which was slightly more than the 133 acres burned in 2020.

The town of Maidstone experienced 1 wildland fire during the year. There were (3) three calls answered by the North Stratford fire department. The Groveton fire department did not respond to my request for the number of calls made to town this past year. Additionally, there were (18) eighteen requests for EMS services (Groveton ambulance) throughout the year.

This past year the Stratford fire department again came to the lake for a training session on the dry fire hydrant located at the boat launch area. In doing so the hydrant was back-flushed and pumped and found to be in working order. The dry hydrant at the McKenzie pond is still out-of-service until it can be repaired.

There were a total of 5 burning permits issued by Chelsey and Bill during the year.

Burning Permits Required: In general a permit **is required** for any outside burning except when there is snow covering the entire site. ***Only natural wood, grass and leaves may be burned. Any other material requires an Air Pollution Permit in addition.***

Burning Permits Not Required: A permit **is not required** for a small campfire (any fire for cooking or warming) on a person's own land and contained in an appropriate pit or fire ring.


Also, please remember that any fire kindled must be attended at all times and shall be totally extinguished before leaving it, even if it is raining or there is snow covering the site.

If there are any questions as to when a burning permit is, or is not required, or for any other questions that may arise, please call either the Fire Warden or Key Person. There is **no charge** for burning permits.



Report of the Superintendent



Dear Families and Community Members,

As I reflect on this past year, it is easy to begin listing all the challenges we have faced over the past two years in education. It would be just as easy to highlight all the sacrifices and efforts it has taken to keep our schools open and our children safe in what is now our third school year impacted by COVID-19. Despite these challenges and sacrifices, administrators, teachers, staff members, students, and caregivers have all come together to meet this unprecedented time in our lives. Vacations have been postponed, plans have been canceled, and protocols - whether we agree with them or not - have been followed. In short, you've done whatever has been needed on a day-to-day basis to protect not only your own families, but every family in our district. I could not be more proud and more grateful to serve the children and families of the NEK Choice School District.

Our overall enrollment has increased from the prior school year, even with several transitions to home study and families moving out of our district. We are currently working with 36 schools to ensure residencies are verified, tuition payments are made timely and support services are being provided based on needs for the 312 children in our NEK Choice communities. Our Director of Student Services, Jennifer Lawcewicz and Associate Director of Student Services, Beth Lemnah have continued to streamline contractual agreements for student services working collaboratively with 21 of the 36 schools our students currently attend.

As it relates to the budget, there are still many moving targets in the current legislative session related to our estimated equalized per pupil costs including the final Tax Commissioners yield, the use of prior year surplus from the education fund, potential changes to the funding formula related to the UVM Weighting Study Report and the ACT173 Special Education block grant. Based on our projections for the FY2023 budget, we anticipate a 16.8% rise in our projected equalized per pupil cost to \$20,285. Our total expenditures less offsetting revenues account for the educational spending request of \$5,814,523 which calculates our NEK Choice Homestead Union Tax Rate for the school district at \$1.5680, which is an increase of \$.0360 cents from the prior year.

Under our Act46 Articles of Agreement, we no longer receive any incentives and/or throttles limiting community taxes from increasing or decreasing by 5%. Although, some communities will be impacted significantly by their town's Common Level of Appraisal (CLA) and grand list outcomes on re-appraisals, comparatively the projected tax rates shared in the 2018 community merger vote presentation are lower than previously anticipated.

We have audited the financial statements of the governmental activities and the major fund of NEK Choice School District for the year ended June 30, 2021. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards and *Government Auditing Standards* as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated May 21, 2021. Professional standards also require that we communicate to you the following information related to our audit.

Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by NEK Choice School District are described in Note 1 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during the year. We noted no transactions entered into by the School District during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The School District had no accounting estimates.

The financial statement disclosures are neutral, consistent and clear.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. There were no corrected or uncorrected misstatements as a result of our audit procedures.

Disagreements with Management

For purposes of this letter, a disagreement with management is a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated October 25, 2021.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the School District's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the School District's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

We applied certain limited procedures to management's discussion and analysis, which is required supplementary information (RSI) that supplements the basic financial statements. Our procedures consisted of inquiries of management regarding the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statements. We did not audit the RSI and do not express an opinion or provide any assurance on the RSI.

Restriction on Use

This information is intended solely for the information and use of the Board of School Directors and management of NEK Choice School District and is not intended to be, and should not be, used by anyone other than these specified parties.

Report of the Director of Student Support *Jennifer Lawcewicz*

We are so very fortunate to have such dedicated, flexible, and positive educators and support staff in our district. This year has presented us with increasing challenges as we stretch to ensure that all learners are getting the support they need to be successful during this pandemic. Educators and administrators have been extraordinary flexible and creative, compassionate, and supportive of both students and staff throughout this year.

At Canaan Schools, we currently have three special education teachers and 11 paraprofessionals who support 36 students with individualized education plans (IEPs). I provide case management for the other 29 students at Canaan who are on 504 or educational support plans as well as our 5 students who are in out of district placements. Our administrative assistant, Lori Kolatschek, manages the accounting, payroll, and Medicaid for our department in collaboration with the main office.

I am proud of the improvements we have made as a department. We continue to contract with in-person related service providers including Speech & Language, Occupational Therapy, Physical Therapy, Sign Language, Teacher of the Blind and Visually Impaired, Teacher of the Deaf, a behavior consultant, a school psychologist, and the UVM I-Team. The addition of Irene Simons from Northeast Kingdom Human Services and Tina Tarryk from Mobile Counseling have brought in-person therapy and behavioral supports to many students in need. Although we conduct many of our own evaluations in-house, we also contract with a school psychologist to conduct some of the more complex evaluations.

In the Northeast Kingdom Choice District, my Associate Director, Beth Lemnah, has worked hard to ensure that the needs of all students are being met. She currently oversees 40 students on IEPs and 22 students on 504s or educational support plans as well as ensuring the evaluations of any new referrals or 3-year re-evaluations are completed. Beth works closely with 21 schools throughout the Northeast Kingdom to ensure that each student is receiving the services and supports that they need. This has become extraordinarily complex as schools move in and out of remote learning and students move in and out of our district.

We have adjusted our plans for developing a life skills program and shifted to individualized life skills programming focused on the unique needs and interests of the individual student. This has included engaging lessons in gardening, cooking, robotics and STEM, work-based learning, shopping, and menu planning, etc. Through this approach, students are engaged in learning with their peers throughout the day, while additionally participating in authentic learning experiences specific to their individual needs. I would like to thank the staff, administration, school boards, and community members for their continued support as we work to creatively meet student needs in these unprecedented times. I feel very fortunate to work with such amazing people.
