- a. The audit material that had been received to date was distributed to Board members for review.
- b. The newsletter was reviewed and approved with minor changes.
- c. Mr. Spivey reported on his attendance at the New England Regional Communications Forum. The topics covered were:
  - \* Update on Massachusetts and New York status
  - \* CPA exam extension to Japan, Israel and Dubai
  - \* 120 semester hours to sit and 150 for licensure
  - \* Peer Review Reports
  - \* Presentation by The Center for Public Trust (branch of NASBA) to promote ethics for all types of professions.
- d. Ms. Douglass was present to report on the changes to the CPA Exam. The topics covered were:
  - \* CBT – 2 long simulations at present will be shortened to 6 or 7 short ones, which will make it easier to grade.
  - \* Essays – less time
  - \* First quarter of 2011 will require validity scoring
  - \* Board of Examiners will be responsible for makeup & content of the exam
  - \* Review Board (Prometrics) will secure how things are run
  - \* 99% of executive directors said no to test out of the country, but they have moved forward with it
